A RESOLUTION commending the Kentucky Steam Heritage Corporation.

2	WHEREAS, railroads are deeply embedded in Kentucky history; and
3	WHEREAS, the Kentucky Steam Heritage Corporation seeks to bring about
4	economic development through rail-related tourism and operating steam locomotives; and
5	WHEREAS, the Kentucky Steam Heritage Corporation, in partnership with CSX
6	Transportation, Estill County Schools, the Estill Development Alliance, R. J. Corman
7	Railroad Group, and Hardy Oil, is working to contribute to tourism and economic
8	development in Kentucky by creating a multi-use, rail-based tourist attraction and
9	economic development project in Irvine, Kentucky, that will integrate the region's history,
10	natural beauty, and culture into a 45-acre campus known as The Yard; and
11	WHEREAS, The Yard will contribute to tourism and the local economy in the
12	eastern Kentucky area by incorporating a food truck venue, the Hardy Pavilion, a great
13	lawn, and more, where visitors can participate in activities including but not limited to
14	visiting farmers markets and food trucks, train rides, steam locomotive demonstrations,
15	concerts, visiting a gift shop and Rail Heritage Center Museum, and visiting a restaurant
16	and brewery; and
17	WHEREAS, the Kentucky Steam Heritage Corporation will partner with Estill
18	County and other regional schools to establish a vocational program for learners
19	interested in learning a trade, with programs to develop skills in welding, pipefitting,
20	machining, and tool and die; and
21	WHEREAS, the Kentucky Steam Heritage Corporation is contributing to tourism
22	and the economy not only in Kentucky but throughout our nation as, for example, it has
23	partnered with the Railroad Museum of New England which plans to host C&0 2716, a
24	steam locomotive owned by the Kentucky Railway Museum that is leased and being
25	restored by the Kentucky Steam Heritage Corporation;
