

1 AN ACT relating to agricultural land.

2 ***Be it enacted by the General Assembly of the Commonwealth of Kentucky:***

3 ➔Section 1. KRS 211.015 is amended to read as follows:

4 (1) As used in KRS 211.005 to 211.380, unless the context requires otherwise:

5 (a) "Cabinet" means the Cabinet for Health and Family Services;

6 (b) "Farmstead" means a farm dwelling, together with other farm buildings and
7 structures incident to the operation and maintenance of the farm, situated on
8 five (5)~~ten (10)~~ contiguous acres or more of land outside the corporate limits
9 of a municipality:

10 1. Used for the production of livestock, livestock products, poultry, poultry
11 products, dairy, dairy products, or horticulture products or for the
12 growing of crops such as, but not limited to, tobacco, corn, soybeans,
13 and wheat. For purposes of this paragraph, "livestock" means cattle,
14 sheep, swine, goats, horses, alpacas, llamas, buffaloes, or any other
15 animals of the bovine, ovine, porcine, caprine, equine, or camelid
16 species; or

17 2. Where devoted to and meeting the requirements and qualifications for
18 payments pursuant to agriculture programs under an agreement with the
19 state or federal government;

20 (c) "Secretary" means the secretary of the Cabinet for Health and Family
21 Services; and

22 (d) "Private water supply" means a residential water supply located on private
23 property under the control of a person holding a possessory interest in the
24 property, the use of which is limited to family members.

25 (2) As used in KRS 200.560 and 200.550, unless the context otherwise requires:

26 (a) "Department" means Department for Public Health;

27 (b) "Commissioner" means the commissioner of the Department for Public

1 Health;

2 (c) "Committee" means the Hemophilia Advisory Committee; and

3 (d) "Hemophilia" means a bleeding disorder resulting from a genetically
4 determined deficiency factor in the blood, or hereditarily resulting in an
5 abnormal or deficient plasma procoagulant.

6 ➔Section 2. KRS 318.010 is amended to read as follows:

7 As used in this chapter, unless the context requires otherwise:

8 (1) "Department" means Department of Housing, Buildings and Construction;

9 (2) "Journeyman plumber" means a person who engages or offers to engage, either as
10 an occupation or otherwise, in the construction, installation, alteration,
11 maintenance, repair, remodeling or removal, and replacement of plumbing under the
12 supervision, direction, and responsibility of a master plumber;

13 (3) "Master plumber" means a person who assumes responsible charge, supervision, or
14 direction of journeyman plumbers, plumbers' apprentices, and other persons in the
15 construction, installation, or alteration of plumbing or who engages in, offers to
16 engage in, or advertises or otherwise represents that he is permitted or qualified to
17 engage in the design, planning, superintending, contracting for, or responsible
18 charge of plumbing;

19 (4) "Plumbing" means the art of installing in buildings the pipes for distributing the
20 water supply, the fixtures for using water and drainage pipes for removing waste
21 water and sewage, together with fittings, appurtenances, and appliances of various
22 kinds, all within or adjacent to the building. It shall not include the installation of
23 on-site sewage disposal systems, except for the piping, fixtures, or other
24 appurtenances needed within the building. It shall include:

25 (a) The water service pipe which forms the connection between the property line
26 and the building, other than piping serving firefighting equipment;

27 (b) Private water supply systems;

- 1 (c) House sewers which convey the waste water and sewage from the building to
2 the property line or other points of disposal, but not including sewers located
3 between manholes and sewers extending five (5) feet from a main or manhole
4 on private property;
- 5 (d) Storm sewers and rain water piping located within a building to a point two
6 (2) feet outside of the building; and
- 7 (e) Medical gas piping;
- 8 (5) "Public building" means any building intended for public use or built with public
9 funds and includes but is not limited to the following: schools, industrial
10 establishments, housing projects, restaurants, food-handling establishments, private
11 clubs, theaters including drive-ins, trailer coach parks, camping areas, hospitals,
12 nursing homes, hotels, motels, tourist courts, rooming houses, boarding houses, and
13 other establishments furnishing public sleeping accommodations;
- 14 (6) "Maintenance man" means a person employed to maintain and keep plumbing in
15 good repair;
- 16 (7) "Apprentice" means a person in the process of learning the plumbing trade who
17 assists and is under the personal supervision of a licensed master or licensed
18 journeyman plumber;
- 19 (8) "Farmstead" means a farm dwelling together with other farm buildings and
20 structures incident to the operation and maintenance of the farm situated on five
21 ~~(5) [ten (10)]~~ acres or more of land which is located outside the corporate limits of a
22 municipality;
- 23 (9) "Person" means any individual, public or private corporation, political subdivision,
24 government agency, municipality, copartnership, association, firm, trust, estate, or
25 other entity whatsoever;
- 26 (10) "Commissioner" means the commissioner of the Department of Housing, Buildings
27 and Construction; and

- 1 (11) "Code" means the Kentucky State Plumbing Code.
