6	(2) Notwithstanding any other law, an insurer may deliver all communications
7	relating to an employer-sponsored group health insurance policy, certificate
8	plan, or contract to a covered person by electronic means if:
9	(a) The employer consents to electronic delivery of communications on behalf
10	of the covered person; and
11	(b) The insurer complies with subsection (4) of this section.
12	(3) An employer may consent to the electronic delivery of communications under
13	subsection (2) of this section if the employer confirms the following for the
14	covered person:
15	(a) The covered person is:
16	1. An employer-sponsored group member that routinely uses electronic
17	communications during the normal course of employment or

19	2. A dependent of an employer-sponsored group member referenced in
