

1 AN ACT relating to juvenile justice.

2 *Be it enacted by the General Assembly of the Commonwealth of Kentucky:*

3 ➔SECTION 1. A NEW SECTION OF KRS CHAPTER 15A IS CREATED TO
4 READ AS FOLLOWS:

5 *The Department of Juvenile Justice shall, thirty (30) days after the end of each quarter*
6 *of the calendar year, report to the Criminal Justice Statistical Analysis Center created*
7 *pursuant to Section 44 of this Act data on children under supervision, which shall*
8 *include monthly population totals and a monthly breakdown by age, race, gender,*
9 *presence of a disability, whether the child's father is part of the household, and type of*
10 *supervision or placement. A child shall be identified as having a disability if the child*
11 *has been referred for evaluation or admitted to Special Education in accordance with*
12 *707 KAR 1:300 or is eligible for accommodations under Section 504 of the*
13 *Rehabilitation Act of 1973 or the Americans with Disabilities Act. Race shall be*
14 *reported using current categories which satisfy the standards established by the United*
15 *States Office of Management and Budget.*

16 ➔SECTION 2. A NEW SECTION OF KRS CHAPTER 15A IS CREATED TO
17 READ AS FOLLOWS:

18 *By February 1, 2018, the Department of Juvenile Justice shall submit to the Juvenile*
19 *Justice Advisory Board created pursuant to KRS 15A.065 and to the oversight council*
20 *created in KRS 15A.063 the current three (3) year plan created in accordance with the*
21 *federal Juvenile Justice and Delinquency Prevention Act to address disproportionate*
22 *minority contact with, and involvement in, the juvenile justice system. By February 1*
23 *of each year thereafter, the Department of Juvenile Justice shall submit the updated*
24 *plan and a report describing its progress in implementing the plan.*

25 ➔SECTION 3. A NEW SECTION OF KRS CHAPTER 27A IS CREATED TO
26 READ AS FOLLOWS:

27 *The Administrative Office of the Courts shall:*

- 1 (1) By the end of each quarter of the calendar year, report to the Criminal Justice
2 Statistical Analysis Center created pursuant to Section 44 of this Act data on
3 children involved in the juvenile justice system, including the number of
4 complaints filed, diverted, and referred to court, and the number of referrals to
5 family accountability, intervention, and response teams established pursuant to
6 Section 20 of this Act. The report shall include monthly totals and a monthly
7 breakdown by age, race, gender, presence of a disability, whether the child's
8 father is part of the household, and whether the case involved a public or status
9 offense. A child shall be identified as having a disability if the child has been
10 referred for evaluation or admitted to Special Education in accordance with 707
11 KAR 1:300 or is eligible for accommodations under Section 504 of the
12 Rehabilitation Act of 1973 or the Americans with Disabilities Act. Race shall be
13 reported using current categories which satisfy the standards established by the
14 United States Office of Management and Budget;
- 15 (2) By January 1, 2019, develop and submit to the Juvenile Justice Advisory Board
16 created pursuant to KRS 15A.065 and to the oversight council created in KRS
17 15A.063 a three (3) year plan to address disproportionate minority contact with,
18 and involvement in, the juvenile justice system. By January 1 of each year
19 thereafter, the Administrative Office of the Courts shall submit an updated plan
20 and a report describing its progress in implementing the plan; and
- 21 (3) Develop and implement evidence-based professional development programs for
22 staff who interact with or who are responsible for the treatment, supervision, or
23 placement of children, that include training on juvenile justice research relating
24 to effectiveness of juvenile justice interventions, impacts of out-of-home
25 placement, alternatives to incarceration, use of graduated sanctions, case
26 planning, administration of a validated risk and needs assessment, and training
27 to address domestic violence, trauma, implicit bias, cultural competence, and

1 *family engagement.*

2 ➔ SECTION 4. A NEW SECTION OF KRS CHAPTER 158 IS CREATED TO
3 READ AS FOLLOWS:

4 *By January 1, 2019, the Kentucky Department of Education shall develop and submit*
5 *to the Juvenile Justice Advisory Board created pursuant to KRS 15A.065 and to the*
6 *oversight council created in KRS 15A.063 a three (3) year plan to address*
7 *disproportionate minority contact with school disciplinary systems and referrals from*
8 *schools to the juvenile justice system. By January 1 of each year thereafter, the*
9 *Kentucky Department of Education shall submit an updated plan and a report*
10 *describing its progress in implementing the plan.*

11 ➔ Section 5. KRS 156.095 is amended to read as follows:

12 (1) The Kentucky Department of Education shall establish, direct, and maintain a
13 statewide program of professional development to improve instruction in the public
14 schools.

15 (2) Each local school district superintendent shall appoint a certified school employee
16 to fulfill the role and responsibilities of a professional development coordinator who
17 shall disseminate professional development information to schools and personnel.
18 Upon request by a school council or any employees of the district, the coordinator
19 shall provide technical assistance to the council or the personnel that may include
20 assisting with needs assessments, analyzing school data, planning and evaluation
21 assistance, organizing districtwide programs requested by school councils or groups
22 of teachers, or other coordination activities.

23 (a) The manner of appointment, qualifications, and other duties of the
24 professional development coordinator shall be established by Kentucky Board
25 of Education through promulgation of administrative regulations.

26 (b) The local district professional development coordinator shall participate in the
27 Kentucky Department of Education annual training program for local school

1 district professional development coordinators. The training program may
2 include, but not be limited to, the demonstration of various approaches to
3 needs assessment and planning; strategies for implementing long-term,
4 school-based professional development; strategies for strengthening teachers'
5 roles in the planning, development, and evaluation of professional
6 development; and demonstrations of model professional development
7 programs. The training shall include information about teacher learning
8 opportunities relating to the core content standards. The Kentucky Department
9 of Education shall regularly collect and distribute this information.

10 (3) The Kentucky Department of Education shall provide or facilitate optional,
11 professional development programs for certified personnel throughout the
12 Commonwealth that are based on the statewide needs of teachers, administrators,
13 and other education personnel. Programs may include classified staff and parents
14 when appropriate. Programs offered or facilitated by the department shall be at
15 locations and times convenient to local school personnel and shall be made
16 accessible through the use of technology when appropriate. They shall include
17 programs that: address the goals for Kentucky schools as stated in KRS 158.6451,
18 including reducing the achievement gaps as determined by an equity analysis of the
19 disaggregated student performance data from the state assessment program
20 developed under KRS 158.6453; engage educators in effective learning processes
21 and foster collegiality and collaboration; and provide support for staff to incorporate
22 newly acquired skills into their work through practicing the skills, gathering
23 information about the results, and reflecting on their efforts. Professional
24 development programs shall be made available to teachers based on their needs
25 which shall include but not be limited to the following areas:

26 (a) Strategies to reduce the achievement gaps among various groups of students
27 and to provide continuous progress;

- 1 (b) Curriculum content and methods of instruction for each content area,
2 including differentiated instruction;
- 3 (c) School-based decision making;
- 4 (d) Assessment literacy;
- 5 (e) Integration of performance-based student assessment into daily classroom
6 instruction;
- 7 (f) Nongraded primary programs;
- 8 (g) Research-based instructional practices;
- 9 (h) Instructional uses of technology;
- 10 (i) Curriculum design to serve the needs of students with diverse learning styles
11 and skills and of students of diverse cultures;
- 12 (j) Instruction in reading, including phonics, phonemic awareness,
13 comprehension, fluency, and vocabulary;
- 14 (k) Educational leadership; and
- 15 (l) Strategies to incorporate character education throughout the curriculum.
- 16 (4) The department shall assist school personnel in assessing the impact of professional
17 development on their instructional practices and student learning.
- 18 (5) The department shall assist districts and school councils with the development of
19 long-term school and district improvement plans that include multiple strategies for
20 professional development based on the assessment of needs at the school level.
- 21 (a) Professional development strategies may include, but are not limited to,
22 participation in subject matter academies, teacher networks, training institutes,
23 workshops, seminars, and study groups; collegial planning; action research;
24 mentoring programs; appropriate university courses; and other forms of
25 professional development.
- 26 (b) In planning the use of the four (4) days for professional development under
27 KRS 158.070, school councils and districts shall give priority to programs that

1 increase teachers' understanding of curriculum content and methods of
2 instruction appropriate for each content area based on individual school plans.
3 The district may use up to one (1) day to provide district-wide training and
4 training that is mandated by state or federal law. Only those employees
5 identified in the mandate or affected by the mandate shall be required to attend
6 the training.

7 (c) State funds allocated for professional development shall be used to support
8 professional development initiatives that are consistent with local school
9 improvement and professional development plans and teachers' individual
10 growth plans. The funds may be used throughout the year for all staff,
11 including classified and certified staff and parents on school councils or
12 committees. A portion of the funds allocated to each school council under
13 KRS 160.345 may be used to prepare or enhance the teachers' knowledge and
14 teaching practices related to the content and subject matter that are required
15 for their specific classroom assignments.

16 (6) (a) By August 1, 2010, the Kentucky Cabinet for Health and Family Services
17 shall post on its Web page suicide prevention awareness information, to
18 include recognizing the warning signs of a suicide crisis. The Web page shall
19 include information related to suicide prevention training opportunities
20 offered by the cabinet or an agency recognized by the cabinet as a training
21 provider.

22 (b) By September 1, 2010, and September 1 of each year thereafter, every public
23 middle and high school administrator shall disseminate suicide prevention
24 awareness information to all middle and high school students. The
25 information may be obtained from the Cabinet for Health and Family Services
26 or from a commercially developed suicide prevention training program.

27 (7) (a) The Kentucky Department of Education shall develop and maintain a list of

- 1 approved comprehensive evidence-informed trainings on child abuse and
2 neglect prevention, recognition, and reporting that encompass child physical,
3 sexual, and emotional abuse and neglect.
- 4 (b) The trainings shall be Web-based or in-person and cover, at a minimum, the
5 following topics:
- 6 1. Recognizing child physical, sexual, and emotional abuse and neglect;
 - 7 2. Reporting suspected child abuse and neglect in Kentucky as required by
8 KRS 620.030 and the appropriate documentation;
 - 9 3. Responding to the child; and
 - 10 4. Understanding the response of child protective services.
- 11 (c) The trainings shall include a questionnaire or other basic assessment tool upon
12 completion to document basic knowledge of training components.
- 13 (d) Each local school board shall adopt one (1) or more trainings from the list
14 approved by the Department of Education to be implemented by schools.
- 15 (e) All current school administrators, certified personnel, office staff,
16 instructional assistants, and coaches and extracurricular sponsors who are
17 employed by the school district shall complete the implemented training or
18 trainings by January 31, 2017, and then every two (2) years after.
- 19 (f) All school administrators, certified personnel, office staff, instructional
20 assistants, and coaches and extracurricular sponsors who are employed by the
21 school district hired after January 31, 2017, shall complete the implemented
22 training or trainings within ninety (90) days of being hired and then every two
23 (2) years after.
- 24 (g) Every public school shall prominently display the statewide child abuse
25 hotline number administered by the Cabinet for Health and Family Services.
- 26 (8) The Department of Education shall establish an electronic consumer bulletin board
27 that posts information regarding professional development providers and programs

1 as a service to school district central office personnel, school councils, teachers, and
2 administrators. Participation on the electronic consumer bulletin board shall be
3 voluntary for professional development providers or vendors, but shall include all
4 programs sponsored by the department. Participants shall provide the following
5 information: program title; name of provider or vendor; qualifications of the
6 presenters or instructors; objectives of the program; program length; services
7 provided, including follow-up support; costs for participation and costs of materials;
8 names of previous users of the program, addresses, and telephone numbers; and
9 arrangements required. Posting information on the bulletin board by the department
10 shall not be viewed as an endorsement of the quality of any specific provider or
11 program.

12 (9) The Department of Education shall provide training to address the characteristics
13 and instructional needs of students at risk of school failure and most likely to drop
14 out of school. The training shall be developed to meet the specific needs of all
15 certified and classified personnel depending on their relationship with these
16 students. The training for instructional personnel shall be designed to provide and
17 enhance skills of personnel to:

18 (a) Identify at-risk students early in elementary schools as well as at-risk and
19 potential dropouts in the middle and high schools;

20 (b) Plan specific instructional strategies to teach at-risk students;

21 (c) Improve the academic achievement of students at risk of school failure by
22 providing individualized and extra instructional support to increase
23 expectations for targeted students;

24 (d) Involve parents as partners in ways to help their children and to improve their
25 children's academic progress; and

26 (e) Significantly reduce the dropout rate of all students.

27 (10) The department shall establish teacher academies to the extent funding is available

1 in cooperation with postsecondary education institutions for elementary, middle
 2 school, and high school faculty in core disciplines, utilizing facilities and faculty
 3 from universities and colleges, local school districts, and other appropriate agencies
 4 throughout the state. Priority for participation shall be given to those teachers who
 5 are teaching core discipline courses for which they do not have a major or minor or
 6 the equivalent. Participation of teachers shall be voluntary.

7 (11) **By January 1, 2019, the Kentucky Department of Education shall develop and**
 8 **implement evidence-based professional development programs for all certified**
 9 **personnel, school resource officers, and school security officers that include**
 10 **training on juvenile justice research relating to effectiveness of juvenile justice**
 11 **interventions, impacts of out-of-home placement, alternatives to incarceration,**
 12 **use of graduated sanctions, case planning, administration of a validated risk and**
 13 **needs assessment, and training to address domestic violence, trauma, implicit**
 14 **bias, cultural competence, and family engagement.**

15 (12) The department shall annually provide to the oversight council established in KRS
 16 15A.063~~1~~ the information received from local schools pursuant to KRS 158.449.

17 ➔Section 6. KRS 158.441 is amended to read as follows:

18 As used in this chapter, unless the context requires otherwise:

19 (1) "Intervention services" means any preventive, developmental, corrective, supportive
 20 services or treatment provided to a student who is at risk of school failure, is at risk
 21 of participation in violent behavior or juvenile crime, or has been expelled from the
 22 school district. Services may include, but are not limited to, screening to identify
 23 students at risk for emotional disabilities and antisocial behavior; direct instruction
 24 in academic, social, problem solving, and conflict resolution skills; alternative
 25 educational programs; psychological services; identification and assessment of
 26 abilities; counseling services; medical services; day treatment; family services;
 27 work and community service programs;

1 (2) "School resource officer" means a sworn law enforcement officer who has
 2 specialized training to work with youth at a school site. The school resource officer
 3 shall be employed through a contract between a local law enforcement agency and a
 4 school district **and shall be subject to training requirements of the school district;**
 5 and

6 (3) "School security officer" means a person employed by a local board of education
 7 who has been appointed a special law enforcement officer pursuant to KRS 61.902
 8 and who has specialized training to work with youth at a school site.

9 ➔Section 7. KRS 158.444 is amended to read as follows:

10 (1) The Kentucky Board of Education shall promulgate appropriate administrative
 11 regulations relating to school safety, student discipline, and related matters.

12 (2) The Kentucky Department of Education shall:

13 (a) Collaborate with the Center for School Safety in carrying out the center's
 14 mission;

15 (b) Establish and maintain a statewide data collection system by which school
 16 districts shall report by **age, race, gender**~~[sex, race]~~, and grade level:

17 1. a. All incidents of violence and assault against school employees and
 18 students;

19 b. All incidents of possession of guns or other deadly weapons on
 20 school property or at school functions;

21 c. All incidents of the possession or use of alcohol, prescription
 22 drugs, or controlled substances on school property or at school
 23 functions; and

24 d. All incidents in which a student has been disciplined by the school
 25 for a serious incident, including the nature of the discipline, or
 26 charged criminally for conduct constituting a violation of any
 27 offense specified in KRS Chapter 508; KRS 525.070 occurring on

1 school premises, on school-sponsored transportation, or at school
 2 functions; or KRS 525.080;

3 2. The number of arrests on school property, at school functions, or
 4 relating to incidents on school property or at school functions, the
 5 charges, the agency, office, or person initiating the charges, and
 6 whether civil damages were pursued by the injured party;

7 3. The number of suspensions, expulsions, and corporal punishments; and

8 4. Data required during the assessment process under KRS 158.445; ~~and~~

9 (c) Provide all data collected relating to this subsection to the Center for School
 10 Safety according to timelines established by the center;

11 (d) By October 2019, and by October 1 of each year thereafter, report all data
 12 collected pursuant to this subsection relating to use of physical restraint and
 13 seclusion to the Protection and Advocacy Division of the Department of
 14 Public Advocacy; and

15 (e) By October 2019, and by October 1 of each year thereafter, report all data
 16 collected pursuant to this subsection and all data collected pursuant to
 17 Sections 4 and 41 of this Act to the Criminal Justice Statistical Analysis
 18 Center created pursuant to Section 44 of this Act.

19 (3) The Department of Education shall provide the Office of Education Accountability
 20 and the Education Assessment and Accountability Review Subcommittee with an
 21 annual statistical report of the number and types of incidents reported under
 22 subsection (2)(b) of this section. The report shall include all monthly data and
 23 cumulative data for each reporting year. Reportable incidents shall be grouped in
 24 the report in the same manner that the reportable incidents are grouped in
 25 subsection (2)(b)1. of this section. Data in the report shall be sorted by individual
 26 school district, then by individual schools within that district, and then by individual
 27 grades within each school. The report shall not contain information personally

1 identifying any student. The reporting period shall be for an academic year, and
2 shall be delivered no later than August 31 of each year.

3 (4) All personally identifiable student data collected pursuant to subsection (2)(b) of
4 this section shall be subject to the confidentiality provisions of the Kentucky Family
5 Education Rights and Privacy Act, KRS 160.700 to 160.730, and to the federal
6 Family Educational Rights and Privacy Act, 20 U.S.C. sec. 1232g, and its
7 implementing regulations.

8 (5) Parents, legal guardians, or other persons exercising custodial control or supervision
9 shall have the right to inspect or challenge the personally identifiable student
10 records as permitted under the Kentucky Family Education Rights and Privacy Act
11 and the federal Family Educational Rights and Privacy Act and implementing
12 regulations.

13 (6) Data collected under this section on an individual student committing an incident
14 reportable under subsection (2)(b)1. of this section shall be placed in the student's
15 disciplinary record.

16 **(7) Race shall be reported using current categories which satisfy the standards**
17 **established by the United States Office of Management and Budget.**

18 ➔SECTION 8. A NEW SECTION OF KRS CHAPTER 31 IS CREATED TO
19 READ AS FOLLOWS:

20 **(1) The Protection and Advocacy Division may review all uses of physical restraint or**
21 **seclusion reported pursuant to subsection (2)d. of Section 7 of this Act which**
22 **involves:**

23 **(a) Repeated use for an individual student;**

24 **(b) Multiple uses in the same classroom; or**

25 **(c) Multiple uses by the same individual.**

26 **(2) The Protection and Advocacy Division may conduct a comprehensive**
27 **investigation of any incidents reviewed under subsection (1) of this section that**

1 involve a child with a disability. The division may receive unredacted copies of
 2 the school incident reports related to the use of restraint or seclusion, and the
 3 Cabinet for Health and Family Services' records and documentation regarding
 4 any investigation into allegations of abuse arising out of the use of restraint or
 5 seclusion. The division may also obtain the identity and contact information for
 6 the parent or guardian of any student subject to a restraint or seclusion or for
 7 whom the cabinet has investigated allegations that the student was an alleged
 8 victim of abuse relating to the use of restraint or seclusion at school. Information
 9 and record copies that are confidential under state or federal law and are
 10 provided to the division by the Cabinet for Health and Family Services, the
 11 Department for Community Based Services, the Kentucky Department of
 12 Education, or any local school district for review shall not become the
 13 information and records of the division and shall not lose their confidentiality by
 14 virtue of the division's access to the information and records. The division shall
 15 maintain the confidentiality of all information and records provided pursuant to
 16 this section. Information and record copies provided to the division for review
 17 shall be exempt from the Kentucky Open Records Act, KRS 61.870 to 61.844.

18 (3) The Protection and Advocacy Division shall report annually aggregated statistics
 19 of reports, findings from reviews and investigations, and recommendations for
 20 policy, regulatory, or statutory changes to the Juvenile Justice Advisory Board
 21 created pursuant to KRS 15A.065, the oversight council created in KRS 15A.063,
 22 and the Kentucky Department of Education..

23 ➔Section 9. KRS 158.449 is amended to read as follows:

24 Each local school shall annually provide to the Department of Education, through the
 25 Kentucky Department of Education's student information system, an assessment of school
 26 incidents relating to disruptive behaviors resulting in a complaint, including ~~whether~~:

27 (1) Whether the incident involved a public offense or noncriminal misconduct;

- 1 (2) **Whether** the incident was reported to law enforcement or the court-designated
 2 worker ~~and the charge or type of noncriminal misconduct that was the basis of the~~
 3 ~~referral or report]; [and]~~
- 4 (3) **Whether** the report was initiated by a school resource officer **or school security**
 5 **officer;**
- 6 **(4) The charge or type of noncriminal misconduct that was the basis of the referral**
 7 **or report; and**
- 8 **(5) The age, race, and gender of the student, whether the child's father is part of the**
 9 **household, and whether a disability is present. A child shall be identified as**
 10 **having a disability if the child has been referred for evaluation or admitted to**
 11 **Special Education in accordance with 707 KAR 1:300 or is eligible for**
 12 **accommodations under Section 504 of the Rehabilitation Act of 1973 or the**
 13 **Americans with Disabilities Act. Race shall be reported using current categories**
 14 **which satisfy the standards established by the United States Office of**
 15 **Management and Budget.**

16 ➔SECTION 10. A NEW SECTION OF KRS CHAPTER 194A IS CREATED
 17 TO READ AS FOLLOWS:

18 **The Cabinet for Health and Family Services shall:**

- 19 **(1) By the end of each quarter of the calendar year, report to the Criminal Justice**
 20 **Statistical Analysis Center created pursuant to Section 44 of this Act data on**
 21 **children in out-of-home care, including the number of children entering out-of-**
 22 **home care in that quarter. The report shall include monthly totals and a monthly**
 23 **breakdown by age, race, gender, presence of a disability, whether the child's**
 24 **father is part of the household, and type of placement. A child shall be identified**
 25 **as having a disability if the child has been referred for evaluation or admitted to**
 26 **Special Education in accordance with 707 KAR 1:300 or is eligible for**
 27 **accommodations under Section 504 of the Rehabilitation Act of 1973 or the**

1 Americans with Disabilities Act. Race shall be reported using current categories
 2 which satisfy the standards established by the United States Office of
 3 Management and Budget;

4 (2) By January 1, 2019, develop and submit to the Juvenile Justice Advisory Board
 5 created pursuant to KRS 15A.065 and to the oversight council created in KRS
 6 15A.063 a three (3) year plan to address disproportionate minority representation
 7 among children placed out of home or committed to the custody of the
 8 department. By January 1 of each year thereafter, the Cabinet for Health and
 9 Family Services shall submit an updated plan and a report describing its progress
 10 in implementing the plan; and

11 (3) Develop and implement evidence-based professional development programs for
 12 department staff who interact with or who are responsible for the treatment,
 13 supervision, or placement of children, that include training on juvenile justice
 14 research relating to effectiveness of juvenile justice interventions, impacts of out-
 15 of-home placement, alternatives to incarceration, use of graduated sanctions,
 16 case planning, administration of a validated risk and needs assessment, and
 17 training to address domestic violence, trauma, implicit bias, cultural competence,
 18 and family engagement

19 ➔Section 11. KRS 605.020 is amended to read as follows:

20 (1) Standards for the employment of court-designated workers shall be set by the
 21 Administrative Office of the Courts.

22 (2) If the Administrative Office of the Courts contracts with a public agency for the
 23 provision of the court-designated worker or workers, the contract shall specify that
 24 it is for the services, in part or in whole, of named personnel of that agency and no
 25 others. Personnel of a public agency under contract to the Administrative Office of
 26 the Courts selected as court-designated workers shall be selected in the manner set
 27 forth in the contract by and between the public agency and the Administrative

1 Office of the Courts; shall be under the control of the Administrative Office of the
2 Courts and the court to which they are assigned; and shall be subject to the same
3 powers, duties, and restrictions as are court-designated workers employed by the
4 Administrative Office of the Courts.

5 (3) Court-designated workers, whether employed by the Administrative Office of the
6 Courts or by a public agency under contract to the Administrative Office of the
7 Courts, may be disciplined or removed from the position of court-designated worker
8 in the manner specified in the:

9 (a) Personnel policies for employees of the Administrative Office of the Courts or
10 the personnel policies of the contract agencies as approved by the
11 Administrative Office of the Courts; and

12 (b) Contract by and between the public agency and the Administrative Office of
13 the Courts.

14 (4) The Administrative Office of the Courts shall not contract with private
15 corporations, persons, or agencies for the services of court-designated workers.

16 (5) The Administrative Office of the Courts shall provide training to all court-
17 designated workers in:
