- "Position of authority" means but is not limited to the position occupied by a 5 (a) 6 biological parent, adoptive parent, stepparent, foster parent, relative, 7 household member, adult youth leader, recreational staff, or volunteer who is 8 an adult, adult athletic manager, adult coach, teacher, classified school 9 employee, certified school employee, counselor, staff, or volunteer for either a 10 residential treatment facility or a detention facility as defined in KRS 11 520.010[(4)], staff or volunteer with a youth services organization, religious 12 leader, health-care provider, alcohol and drug counselor licensed or certified 13 under KRS Chapter 309, or employer;
 - (b) "Position of special trust" means a position occupied by a person in a position of authority who by reason of that position is able to exercise undue influence over the minor; and
 - (c) "Substantial sexual conduct" means penetration of the vagina or rectum by the penis of the offender or the victim, by any foreign object; oral copulation; or masturbation of either the minor or the offender.
- 20 (2)Notwithstanding other provisions of applicable law, probation shall not be granted to, nor shall the execution or imposition of sentence be suspended for, nor shall a finding bringing the defendant within the provision of this section be stricken for a person convicted of violating KRS 510.050, 510.080, 529.040, 529.070, 529.100 where the offense involves commercial sexual activity, 530.020, 531.310, 531.320, or 531.370, or criminal attempt to commit any of these offenses under KRS 506.010, and, who meets one (1) or more of the following criteria:

(3) If a person is not otherwise prohibited from obtaining probation or conditional discharge under subsection (2) *of this section*, the court may impose on the person a period of probation or conditional discharge. Probation or conditional discharge shall not be granted until the court is in receipt of the comprehensive sex offender presentence evaluation of the offender performed by an approved provider, as defined in KRS 17.500 or the Department of Corrections. The court shall use the comprehensive sex offender presentence evaluation in determining the appropriateness of probation or conditional discharge.

- 9 (4) If the court grants probation or conditional discharge, the offender shall be required,
 10 as a condition of probation or conditional discharge, to successfully complete a
 11 community-based sexual offender treatment program operated or approved by the
 12 Department of Corrections or the Sex Offender Risk Assessment Advisory Board.
- 13 (5) The offender shall pay for any evaluation or treatment required pursuant to this 14 section up to the offender's ability to pay but not more than the actual cost of the 15 comprehensive sex offender presentence evaluation or treatment.
- 16 (6) Failure to successfully complete the sexual offender treatment program constitutes 17 grounds for the revocation of probation or conditional discharge.
- The comprehensive sex offender presentence evaluation and all communications relative to the comprehensive sex offender presentence evaluation and treatment of a sexual offender shall fall under the provisions of KRS 197.440. The comprehensive sex offender presentence evaluation shall be filed under seal and shall not be made a part of the court record subject to review in appellate proceedings and shall not be made available to the public.
- 24 (8) Before imposing sentence, the court shall advise the defendant or his *or her* counsel
 25 of the contents and conclusions of any comprehensive sex offender presentence
 26 evaluation performed pursuant to this section and afford a fair opportunity and a
 27 reasonable period of time, if the defendant so requests, to controvert them. The
