

1 AN ACT relating to the Kentucky Horse Racing Commission and declaring an  
2 emergency.

3 *Be it enacted by the General Assembly of the Commonwealth of Kentucky:*

4 ➔SECTION 1. KRS 230.210 IS REPEALED AND REENACTED TO READ  
5 AS FOLLOWS:

6 *As used in this chapter, unless the context requires otherwise:*

- 7 *(1) "Advance deposit account wagering" means a form of pari-mutuel wagering in*  
8 *which an individual may establish an account with a person or entity licensed by*  
9 *the corporation, and may place a pari-mutuel wager through that account that is*  
10 *permitted by law;*
- 11 *(2) "Advance deposit account wagering licensee" means a person or entity licensed*  
12 *by the corporation to conduct advance deposit account wagering and accept*  
13 *deposits and wagers, issue a receipt or other confirmation to the account holder*  
14 *evidencing such deposits and wagers, and transfer credits and debits to and from*  
15 *accounts;*
- 16 *(3) "Amateur youth sporting event" means any sporting event in which an*  
17 *individual:*
- 18 *(a) Shall be less than eighteen (18) years of age to participate; and*  
19 *(b) Is prohibited, as a condition of participating in the sporting event, from*  
20 *receiving direct or indirect compensation for the use of the individual's*  
21 *athletic skill in any manner with respect to the sport in which the particular*  
22 *sporting event is conducted;*
- 23 *(4) "Appaloosa race" or "Appaloosa racing" means that form of horse racing in*  
24 *which each horse participating in the race is registered with the Appaloosa Horse*  
25 *Club of Moscow, Idaho, and is mounted by a jockey;*
- 26 *(5) "Arabian" means a horse that is registered with the Arabian Horse Registry of*  
27 *Denver, Colorado;*

- 1 (6) "Association" means any person licensed by the Kentucky Horse Racing and  
2 Gaming Corporation under Section 56 of this Act and engaged in the conduct of  
3 a recognized horse race meeting;
- 4 (7) "Charitable gaming" means gaming licensed by the corporation on and after  
5 July 1, 2025, as authorized under this chapter and KRS Chapter 238;
- 6 (8) "Corporation" means the Kentucky Horse Racing and Gaming Corporation;
- 7 (9) "Geofence" means a virtual geographic boundary defined by Global Positioning  
8 System (GPS) or Radio Frequency Identification (RFID) technology;
- 9 (10) "Harness race" or "harness racing" means trotting and pacing races of the  
10 standardbred horses;
- 11 (11) "Horse race meeting" means horse racing run at an association licensed and  
12 regulated by the Kentucky Horse Racing and Gaming Corporation, and may  
13 include Thoroughbred, harness, Appaloosa, Arabian, paint, and quarter horse  
14 racing;
- 15 (12) "Host track" means the track conducting racing and offering its racing for  
16 intertrack wagering, or, in the case of interstate wagering, means the Kentucky  
17 track conducting racing and offering simulcasts of races conducted in other  
18 states or foreign countries;
- 19 (13) "Intertrack wagering" means pari-mutuel wagering on simulcast horse races  
20 from a host track by patrons at a receiving track;
- 21 (14) "Interstate wagering" means pari-mutuel wagering on simulcast horse races  
22 from a track located in another state or foreign country by patrons at a receiving  
23 track or simulcast facility;
- 24 (15) "Kentucky quarter horse, paint horse, Appaloosa, and Arabian purse fund"  
25 means a purse fund established to receive funds as specified in Section 77 of this  
26 Act for purse programs established in Section 85 of this Act to supplement purses  
27 for quarter horse, paint horse, Appaloosa, and Arabian horse races. The purse

1 program shall be administered by the Kentucky Horse Racing and Gaming  
2 Corporation;

3 (16) "Kentucky resident" means:

4 (a) An individual domiciled within this state;

5 (b) An individual who maintains a place of abode in this state and spends, in  
6 the aggregate, more than one hundred eighty-three (183) days of the  
7 calendar year in this state; or

8 (c) An individual who lists a Kentucky address as his or her principal place of  
9 residence when applying for an account to participate in advance deposit  
10 account wagering;

11 (17) "Licensed facility for sports wagering" means the designated areas to conduct  
12 sports wagering for a track licensed to conduct sports wagering pursuant to  
13 Section 98 of this Act;

14 (18) "Licensed premises" means a track or simulcast facility licensed by the  
15 corporation under this chapter;

16 (19) "Paint horse" means a horse registered with the American Paint Horse  
17 Association of Fort Worth, Texas;

18 (20) "Pari-mutuel wagering," "pari-mutuel system of wagering," or "mutuel  
19 wagering" each means any method of wagering previously or hereafter approved  
20 by the corporation in which one (1) or more patrons wager on a horse race or  
21 races, whether live, simulcast, or previously run. Wagers shall be placed in one  
22 (1) or more wagering pools, and wagers on different races or sets of races may be  
23 pooled together. Patrons may establish odds or payouts, and winning patrons  
24 share in amounts wagered including any carryover amounts, plus any amounts  
25 provided by an association less any deductions required, as approved by the  
26 corporation and permitted by law. Pools may be paid out incrementally over time  
27 as approved by the corporation;

- 1 (21) "Person" means an individual, sole proprietorship, partnership, association,  
2 fiduciary, corporation, limited liability company, or any other business entity;
- 3 (22) "President" means the president of the Kentucky Horse Racing and Gaming  
4 Corporation, who shall serve as chief executive officer of the corporation;
- 5 (23) "Principal" means any of the following individuals associated with a partnership,  
6 trust, association, limited liability company, or corporation that is licensed to  
7 conduct a horse race meeting or an applicant for a license to conduct a horse  
8 race meeting:
- 9 (a) The chairman and all members of the board of directors of a corporation;
- 10 (b) All partners of a partnership and all participating members of a limited  
11 liability company;
- 12 (c) All trustees and trust beneficiaries of an association;
- 13 (d) The president or chief executive officer and all other officers, managers,  
14 and employees who have policymaking or fiduciary responsibility within the  
15 organization;
- 16 (e) All stockholders or other individuals who own, hold, or control, either  
17 directly or indirectly, five percent (5%) or more of stock or financial interest  
18 in the collective organization; and
- 19 (f) Any other employee, agent, guardian, personal representative, or lender or  
20 holder of indebtedness who has the power to exercise a significant influence  
21 over the applicant's or licensee's operation;
- 22 (24) "Quarter horse" means a horse that is registered with the American Quarter  
23 Horse Association of Amarillo, Texas;
- 24 (25) "Receiving track" means a track where simulcasts are displayed for wagering  
25 purposes. A track that submits an application for intertrack wagering shall meet  
26 all the regulatory criteria for granting an association license of the same breed as  
27 the host track, and shall have a heated and air-conditioned facility that meets all

1 state and local life safety code requirements and seats a number of patrons at  
2 least equal to the average daily attendance for intertrack wagering on the  
3 requested breed in the county in which the track is located during the  
4 immediately preceding calendar year;

5 (26) "Simulcast facility" means any facility approved pursuant to Section 81 of this  
6 Act to simulcast live racing and conduct pari-mutuel wagering on live racing;

7 (27) "Simulcasting" means the telecast of live audio and visual signals of horse races  
8 for the purpose of pari-mutuel wagering;

9 (28) "Sporting event" means an event at which two (2) or more persons participate in  
10 athletic contests, or an event that takes place in relation to athletic contests as  
11 approved by the corporation, but shall not include horse racing or amateur youth  
12 sports or athletic events in which the majority of participants are under the age of  
13 eighteen (18) years;

14 (29) "Sports governing body" means the organization, league, or association that  
15 oversees a sport, prescribes final rules, and enforces codes of conduct with  
16 respect to such sport and participants therein;

17 (30) "Sports wagering" means the wagering conducted under this chapter on sporting  
18 events or portions of sporting events, or on the individual performance statistics  
19 of athletes in a sporting event or combination of sporting events, in conformance  
20 with federal law and as authorized by the corporation pursuant to this chapter;

21 (31) "Sports wagering device":

22 (a) Means a mechanical, electrical, or computerized contrivance, terminal,  
23 device, apparatus, software, piece of equipment, or supply approved by the  
24 corporation for conducting sports wagering under this chapter; and

25 (b) Includes a personal computer, mobile device, or other device used in  
26 connection with sports wagering not conducted at a licensed facility for  
27 sports wagering;

- 1 (32) "Sports wagering service provider" or "service provider" means a person  
2 authorized to conduct or manage sports wagering through an agreement with a  
3 track and provide these services at a licensed facility for sports wagering,  
4 simulcast facility, or through a website or mobile interface approved by the  
5 corporation;
- 6 (33) "Telephone account wagering" means a form of pari-mutuel wagering where an  
7 individual may deposit money in an account at a track and may place a wager by  
8 direct telephone call or by communication through other electronic media owned  
9 by the holder of the account to the track;
- 10 (34) "Thoroughbred race" or "Thoroughbred racing" means a form of horse racing  
11 in which each horse participating in the race is a Thoroughbred, (i.e., meeting  
12 the requirements of and registered with The Jockey Club of New York) and is  
13 mounted by a jockey; and
- 14 (35) "Track" means any association duly licensed by the Kentucky Horse Racing and  
15 Gaming Corporation to conduct horse racing and includes:
- 16 (a) For facilities in operation as of 2010, the location and physical plant  
17 described in the "Commonwealth of Kentucky Initial/Renewal Application  
18 for License to Conduct Live Horse Racing, Simulcasting, and Pari-Mutuel  
19 Wagering," filed for racing to be conducted in 2010;
- 20 (b) Real property of an association, if the association received or receives  
21 approval from the corporation after 2010 for a location at which live racing  
22 is to be conducted; or
- 23 (c) One (1) facility or real property that is:
- 24 1. Owned, leased, or purchased by an association within a sixty (60) mile  
25 radius of the association's racetrack but not contiguous to racetrack  
26 premises, upon corporation approval; and
- 27 2. Not within a sixty (60) mile radius of another licensed track premise

1                   where live racing is conducted and not within a forty (40) mile radius  
2                   of a simulcast facility, unless any affected track or simulcast facility  
3                   agrees in writing to permit a noncontiguous facility within the  
4                   protected geographic area.

5           ➔Section 2. KRS 230.215 is amended to read as follows:

- 6       (1) (a) It is the policy of the Commonwealth of Kentucky, in furtherance of its  
7           responsibility to foster and to encourage legitimate occupations and industries  
8           in the Commonwealth and to promote and to conserve the public health,  
9           safety, and welfare, and it is hereby declared the intent of the Commonwealth  
10          to foster and to encourage the horse breeding industry within the  
11          Commonwealth and to encourage the improvement of the breeds of horses.
- 12       (b) Further, it is the policy and intent of the Commonwealth to foster and to  
13          encourage the business of legitimate horse racing with pari-mutuel wagering  
14          thereon in the Commonwealth on the highest possible plane. Further, it hereby  
15          is declared the policy and intent of the Commonwealth that all racing not  
16          licensed under this chapter is a public nuisance and may be enjoined as such.
- 17       (c) Further, it is hereby declared the policy and intent of the Commonwealth that  
18          the conduct of horse racing, or the participation in any way in horse racing, or  
19          the entrance to or presence where horse racing is conducted, is a privilege and  
20          not a personal right; and that this privilege may be granted or denied by the  
21          corporation~~[racing commission]~~ or its duly approved representatives acting in  
22          its behalf.
- 23       (d) Further, it is hereby declared the policy and intent of the Commonwealth that  
24          citizens shall be allowed to enjoy wagering on sporting events in a controlled  
25          environment that protects the citizens from cheating and fraud, and that such  
26          wagering shall be best controlled and overseen by the Kentucky Horse Racing  
27          and Gaming Corporation~~[Commission]~~, which has demonstrated a long and

1           successful history of regulating wagering.

2       (2)   (a)   It is hereby declared the purpose and intent of this chapter in the interest of  
3           the public health, safety, and welfare, to vest in the corporation~~[racing~~  
4           ~~commission]~~ forceful control of horse racing in the Commonwealth with  
5           plenary power to promulgate administrative regulations prescribing conditions  
6           under which all legitimate horse racing and wagering thereon is conducted in  
7           the Commonwealth so as to encourage the improvement of the breeds of  
8           horses in the Commonwealth, to regulate and maintain horse racing at horse  
9           race meetings in the Commonwealth of the highest quality and free of any  
10          corrupt, incompetent, dishonest, or unprincipled horse racing practices, and to  
11          regulate and maintain horse racing at race meetings in the Commonwealth so  
12          as to dissipate any cloud of association with the undesirable and maintain the  
13          appearance as well as the fact of complete honesty and integrity of horse  
14          racing in the Commonwealth.

15       (b)   In addition, it is hereby declared the purpose and intent of this chapter to vest  
16          in the corporation~~[racing commission]~~ exclusive jurisdiction over sports  
17          wagering in the Commonwealth, with plenary power to promulgate  
18          administrative regulations prescribing conditions under which all sports  
19          wagering is to be conducted.

20       (c)   In addition to the general powers and duties vested in the corporation~~[racing~~  
21          ~~commission]~~ by this chapter, it is the intent hereby to vest in the  
22          corporation~~[racing commission]~~ the power to eject or exclude from  
23          association grounds or any part thereof any person, licensed or unlicensed,  
24          whose conduct or reputation is such that his or her presence on association  
25          grounds may, in the opinion of the corporation~~[racing commission]~~, reflect on  
26          the honesty and integrity of horse racing or interfere with either the orderly  
27          conduct of horse racing or the orderly conduct of sports wagering.



1           ➔Section 3. KRS 230.215 is amended to read as follows:

- 2       (1) (a) It is the policy of the Commonwealth of Kentucky, in furtherance of its  
3           responsibility to foster and to encourage legitimate occupations and industries  
4           in the Commonwealth and to promote and to conserve the public health,  
5           safety, and welfare, and it is hereby declared the intent of the Commonwealth  
6           to foster and to encourage the horse breeding industry within the  
7           Commonwealth and to encourage the improvement of the breeds of horses.
- 8       (b) Further, it is the policy and intent of the Commonwealth to foster and to  
9           encourage the business of legitimate horse racing with pari-mutuel wagering  
10          thereon in the Commonwealth on the highest possible plane. Further, it hereby  
11          is declared the policy and intent of the Commonwealth that all racing not  
12          licensed under this chapter is a public nuisance and may be enjoined as such.
- 13       (c) Further, it is hereby declared the policy and intent of the Commonwealth that  
14          the conduct of horse racing, or the participation in any way in horse racing, or  
15          the entrance to or presence where horse racing is conducted, is a privilege and  
16          not a personal right; and that this privilege may be granted or denied by the  
17          corporation~~[racing commission]~~ or its duly approved representatives acting in  
18          its behalf.
- 19       (d) Further, it is hereby declared the policy and intent of the Commonwealth that  
20          citizens shall be allowed to enjoy wagering on sporting events in a controlled  
21          environment that protects the citizens from cheating and fraud, and that such  
22          wagering shall be best controlled and overseen by the Kentucky Horse Racing  
23          and Gaming Corporation~~[Commission]~~, which has demonstrated a long and  
24          successful history of regulating wagering.
- 25       (e) Further, it is hereby declared the policy and intent of the Commonwealth  
26          that charitable gaming conducted by charitable organizations is an  
27          important method of raising funds for legitimate charitable purposes and is

1 *in the public interest. The intent of this chapter and KRS Chapter 238 is to*  
2 *prevent the commercialization of charitable gaming, to prevent participation*  
3 *in charitable gaming by criminal and other undesirable elements, and to*  
4 *prevent the diversion of funds from legitimate charitable purposes, and that*  
5 *charitable gaming shall be best controlled and overseen by the Kentucky*  
6 *Horse Racing and Gaming Corporation.*

7 (2) (a) It is hereby declared the purpose and intent of this chapter in the interest of  
8 the public health, safety, and welfare, to vest in the *corporation*~~[racing~~  
9 ~~commission]~~ forceful control of horse racing in the Commonwealth with  
10 plenary power to promulgate administrative regulations prescribing conditions  
11 under which all legitimate horse racing and wagering thereon is conducted in  
12 the Commonwealth so as to encourage the improvement of the breeds of  
13 horses in the Commonwealth, to regulate and maintain horse racing at horse  
14 race meetings in the Commonwealth of the highest quality and free of any  
15 corrupt, incompetent, dishonest, or unprincipled horse racing practices, and to  
16 regulate and maintain horse racing at race meetings in the Commonwealth so  
17 as to dissipate any cloud of association with the undesirable and maintain the  
18 appearance as well as the fact of complete honesty and integrity of horse  
19 racing in the Commonwealth.

20 (b) In addition, it is hereby declared the purpose and intent of this chapter to vest  
21 in the *corporation*~~[racing commission]~~ exclusive jurisdiction over sports  
22 wagering in the Commonwealth, with plenary power to promulgate  
23 administrative regulations prescribing conditions under which all sports  
24 wagering is to be conducted.

25 (c) In addition to the general powers and duties vested in the *corporation*~~[racing~~  
26 ~~commission]~~ by this chapter, it is the intent hereby to vest in the  
27 *corporation*~~[racing commission]~~ the power to eject or exclude from

1 association grounds or any part thereof any person, licensed or unlicensed,  
2 whose conduct or reputation is such that his or her presence on association  
3 grounds may, in the opinion of the corporation~~[racing commission]~~, reflect on  
4 the honesty and integrity of horse racing or interfere with either the orderly  
5 conduct of horse racing or the orderly conduct of sports wagering.

6 *(d) In addition, it is hereby declared the purpose and intent of this chapter to*  
7 *vest in the corporation exclusive jurisdiction over charitable gaming in the*  
8 *Commonwealth, with plenary power to promulgate administrative*  
9 *regulations prescribing conditions under which all charitable gaming is to*  
10 *be conducted.*

11 *(e) In addition to the general powers and duties vested in the corporation by*  
12 *this chapter, it is the intent hereby to vest in the corporation the power to*  
13 *eject or exclude from charitable gaming facilities or any part thereof any*  
14 *person, licensed or unlicensed, whose conduct or reputation is such that his*  
15 *or her presence at a charitable gaming facility may, in the opinion of the*  
16 *corporation, reflect on the honesty and integrity of charitable gaming or*  
17 *interfere with the orderly conduct of charitable gaming.*

18 ➔SECTION 4. KRS 230.225 IS REPEALED AND REENACTED TO READ  
19 AS FOLLOWS:

20 *(1) There is hereby created and established the Kentucky Horse Racing and Gaming*  
21 *Corporation to regulate all forms of live horse racing, pari-mutuel wagering,*  
22 *sports wagering, breed integrity and development, and on and after July 1, 2025,*  
23 *charitable gaming, in the Commonwealth, exclusive of the state lottery*  
24 *established under KRS Chapter 154A. It shall be an independent, de jure*  
25 *municipal corporation and political subdivision of the Commonwealth of*  
26 *Kentucky which shall be a public body corporate and politic. The corporation*  
27 *shall be deemed a public agency within the meaning of KRS 61.805 and 61.870.*

1 *The corporation shall be managed in such a manner that enables the people of*  
2 *the Commonwealth to benefit from its actions and to enjoy the best possible*  
3 *racing and gaming experiences. The General Assembly hereby recognizes that*  
4 *the operations of racing and gaming are unique activities for state government*  
5 *and that a corporate structure will best enable racing and gaming to be managed*  
6 *in a businesslike manner. It is the intent of the General Assembly that the*  
7 *Kentucky Horse Racing and Gaming Corporation shall be accountable to the*  
8 *Governor, the General Assembly, and the people of the Commonwealth.*

9 *(2) (a) The Auditor of Public Accounts shall perform an annual audit of the*  
10 *corporation, a copy of which shall be sent to the Governor and the*  
11 *Legislative Research Commission.*

12 *(b) The corporation shall submit a written annual report to the Governor and*  
13 *the Legislative Research Commission on or before July 1 of each year. The*  
14 *first report shall be due July 1, 2025. The corporation shall file any*  
15 *additional reports requested by the Governor or the Legislative Research*  
16 *Commission. The annual report shall include the following information:*

17 *1. The receipts and disbursements of the corporation; and*

18 *2. Actions taken by the corporation.*

19 *(c) The corporation may submit any additional information and*  
20 *recommendations that the corporation considers useful or that the*  
21 *Governor or the Legislative Research Commission requests.*

22 *(3) The Kentucky Horse Racing and Gaming Corporation shall be administered by a*  
23 *board of directors to regulate the conduct of:*

24 *(a) Live horse racing;*

25 *(b) Pari-mutuel wagering;*

26 *(c) Sports wagering;*

27 *(d) Charitable gaming on and after July 1, 2025;*

1 (e) Breed integrity and development; and

2 (f) Related activities within the Commonwealth of Kentucky.

3 (4) (a) The corporation shall establish and maintain a general office for the  
4 transaction of its business and may, in its discretion, establish a branch  
5 office or offices.

6 (b) The corporation may hold meetings at any of its offices or at any other  
7 place at its convenience.

8 (c) A majority of the voting members of the corporation shall constitute a  
9 quorum for the transaction of its business or exercise of any of its powers.

10 (5) Except as otherwise provided, the corporation shall be responsible for the  
11 following:

12 (a) Developing and implementing programs designed to ensure the safety and  
13 well-being of horses, jockeys, and drivers;

14 (b) Developing programs and procedures that will aggressively fulfill its  
15 oversight and regulatory role on such matters as medical practices and  
16 integrity issues;

17 (c) Recommending tax incentives and implementing incentive programs to  
18 ensure the strength and growth of the equine industry;

19 (d) Designing and implementing programs that strengthen the ties between  
20 Kentucky's horse industry and the state's universities, with the goal of  
21 significantly increasing the economic impact of the horse industry on  
22 Kentucky's economy, improving research for the purpose of promoting the  
23 enhanced health and welfare of the horse, and other related industry issues;

24 (e) Developing and supporting programs which ensure that Kentucky remains  
25 in the forefront of equine research;

26 (f) Designing and implementing programs that support and ensure breed  
27 integrity and development;

1 (g) Developing monitoring programs to ensure the highest integrity of sporting  
2 events and sports wagering;

3 (h) Developing a program to share wagering information with sports governing  
4 bodies upon which sports wagering may be conducted. The program shall  
5 be designed to assist the corporation in determining potential problems or  
6 questionable activity and provide reports to sports governing bodies  
7 effectively;

8 (i) Developing programs and procedures that will aggressively fulfill its  
9 oversight and regulatory role to ensure the highest integrity in charitable  
10 gaming;

11 (j) Developing programs and procedures that will aggressively provide  
12 oversight and regulation for all current forms of gaming and wagering; and

13 (k) Ensuring that the correct responsibilities are assigned to each of its offices  
14 as established in Section 5 of this Act.

15 (6) (a) The corporation shall:

16 1. Conduct all procurements in accordance with procedures which are  
17 not inconsistent with the provisions of KRS Chapter 45A and this  
18 chapter; provided, however, that this chapter shall control if and to the  
19 extent that any provision in this chapter is expressly inconsistent with  
20 any provision of KRS Chapter 45A; or

21 2. Promulgate administrative regulations establishing its procurement  
22 procedures. If the corporation elects to promulgate administrative  
23 regulations establishing its procurement procedures rather than  
24 conduct procurements in accordance with KRS Chapter 45A, the  
25 corporation may include sections of KRS Chapter 45A as part of its  
26 administrative regulations.

27 (b) Major procurements for personal service contracts shall not be subject to

1 the requirements of KRS 45A.695(2)(b) due to the unique operational  
2 activities conducted for state government by the corporation. The  
3 corporation's procurement procedures or administrative regulations shall  
4 be designed to provide for the purchase of supplies, equipment, services,  
5 and construction items that provide the greatest long-term benefit to the  
6 state and the greatest integrity for the corporation and the public.

7 (c) In its bidding and negotiation processes, the corporation may do its own  
8 bidding and procurement, or may utilize the services of the Finance and  
9 Administration Cabinet, or a combination thereof. The president of the  
10 corporation may, in lieu of the secretary of the Finance and Administration  
11 Cabinet, declare an emergency for purchasing purposes.

12 (7) Corporation records shall be open and subject to public inspection in accordance  
13 with KRS 61.870 to 61.884 unless:

14 (a) A record is exempted from inspection under KRS 61.878;

15 (b) A record involves a trade secret or other legally protected intellectual  
16 property or confidential proprietary information of the corporation or of an  
17 applicant, licensee, individual, or entity having submitted information of  
18 such character to the corporation, in which case, the portion of the record  
19 relating to these subjects may be closed; or

20 (c) The disclosure of the record could impair or adversely affect the operational  
21 security of the corporation in the regulation of matters within its  
22 jurisdiction or could impair or adversely impact the operational security of  
23 applicants or licensees.

24 (8) Meetings of the corporation through its board of directors shall be open to the  
25 public in accordance with KRS 61.800 to 61.850 unless the exceptions set forth in  
26 KRS 61.810 apply or the meeting addresses trade secrets, confidential or  
27 proprietary information, or operational security issues as described in subsection

1 (7)(c) of this section. If this is the case, the corporation may meet in closed  
2 session and shall follow the procedures set forth in KRS 61.815.

3 (9) (a) The corporation is hereby authorized to accept and expend such moneys as  
4 may be appropriated by the General Assembly or such moneys as may be  
5 received from any source for effectuating its purposes, including without  
6 limitation the payment of the initial expenses of administration and  
7 operation of the corporation.

8 (b) After the transfer to the corporation of any funds appropriated in fiscal year  
9 2024-2025 and fiscal year 2025-2026 for the administration of this chapter  
10 and KRS Chapter 238, the corporation shall be self-sustaining and self-  
11 funded and moneys in the state general fund shall not be used or obligated  
12 to pay the expenses of the corporation.

13 (10) On July 1, 2024:

14 (a) The Kentucky Horse Racing and Gaming Corporation shall assume all  
15 responsibilities of the Kentucky Horse Racing Commission;

16 (b) The Kentucky Horse Racing Commission shall be abolished and all  
17 employees of the Kentucky Horse Racing Commission are transferred to the  
18 corporation; and

19 (c) All personnel, equipment, and funding shall be transferred from the  
20 Kentucky Horse Racing Commission to the Kentucky Horse Racing and  
21 Gaming Corporation.

22 (11) On July 1, 2025:

23 (a) The office regulating charitable gaming in the Kentucky Horse Racing and  
24 Gaming Corporation shall assume all responsibilities of the Department of  
25 Charitable Gaming;

26 (b) The Department of Charitable Gaming shall be abolished and all employees  
27 of the Department of Charitable Gaming are transferred to the corporation;



1           and  
2           (c) All personnel, equipment, and funding shall be transferred from the  
3           Department of Charitable Gaming to the Kentucky Horse Racing and  
4           Gaming Corporation.

5           (12) Notwithstanding any other law to the contrary, nothing in this chapter shall  
6           authorize the corporation to:  
7           (a) Regulate or control horse sales;  
8           (b) Require the licensure of horse breeders in their capacity as breeders; or  
9           (c) Exercise jurisdiction over matters within the exclusive national authority of  
10           entities designated by the laws of the United States of America.

11           ➔SECTION 5. A NEW SECTION OF KRS CHAPTER 230 IS CREATED TO  
12 READ AS FOLLOWS:

13           (1) The president of the Kentucky Horse Racing and Gaming Corporation shall  
14           establish offices within the corporation. Each office shall have specific duties  
15           assigned by the president. Topics addressed by the offices shall include but not be  
16           limited to the following:

17           (a) Pari-mutuel wagering;  
18           (b) Live horse racing;  
19           (c) Breed development and integrity;  
20           (d) Sports wagering;  
21           (e) Licensing, compliance, and investigations; and  
22           (f) Charitable gaming.

23           (2) Each office shall be led by an office manager, and the president shall appoint the  
24           manager of each office.

25           (3) Each office may propose the promulgation of administrative regulations related  
26           to its area of jurisdiction, but the corporation shall have final authority to  
27           promulgate administrative regulations under this chapter and on and after July

1 1, 2025, final authority to promulgate administrative regulations under KRS  
2 Chapter 238.

3 ➔SECTION 6. A NEW SECTION OF KRS CHAPTER 230 IS CREATED TO  
4 READ AS FOLLOWS:

5 (1) (a) The affairs and responsibilities of the corporation shall be administered by  
6 a board of directors composed of fifteen (15) members. All fifteen (15)  
7 members shall be appointed by the Governor.

8 (b) The Governor shall appoint a chair and vice chair of the board, subject to  
9 the advice and consent of the Senate. A chair or vice chair appointed when  
10 the Senate is not in session shall serve only until the next regular session, or  
11 special session if such matter is included in the call therefor of the General  
12 Assembly, at which time the chair or vice chair shall be subject to  
13 confirmation by the Senate. If the Senate is not in session, the appointments  
14 shall be subject to review by the Interim Joint Committee on State  
15 Government, which shall hold a public hearing and shall transmit its  
16 recommendations to the Senate. If the Senate refuses to confirm the chair  
17 or vice chair, then the chair or vice chair shall forfeit the office as of the  
18 date on which the Senate refuses to confirm the chair or vice chair.

19 (c) Members of the board appointed by the Governor shall serve a term of four  
20 (4) years, except as otherwise provided in this section.

21 (2) For appointments of the board of directors:

22 (a) Any member appointed to fill a vacancy occurring other than by expiration  
23 of a term shall be appointed for the remainder of the unexpired term.

24 (b) In making appointments, the Governor shall appoint members who meet the  
25 following qualifications:

26 1. Three (3) members who represent the Thoroughbred industry:

27 a. One (1) member shall serve a one (1) year term, with any

- 1                   subsequent terms lasting four (4) years;
- 2                   b. One (1) member shall serve a two (2) year term, with any
- 3                   subsequent terms lasting four (4) years; and
- 4                   c. One (1) member shall serve a three (3) year term, with any
- 5                   subsequent terms lasting four (4) years;
- 6                   2. One (1) member who represents the standardbred industry;
- 7                   3. One (1) equine veterinarian who currently practices with race horses;
- 8                   4. One (1) member shall be selected based on his or her training and
- 9                   experience in the fields of investigation and law enforcement;
- 10                  5. Three (3) experts in the gaming industry, with knowledge about the
- 11                  technical and logistical sides of the wagering experience. At least one
- 12                  (1) of these experts shall have expertise in the technical and logistical
- 13                  sides of pari-mutuel wagering on previously run horse races;
- 14                  6. One (1) expert in the operational aspects of the horse industry, with
- 15                  particular knowledge of horse breeding;
- 16                  7. One (1) expert in the operational aspects of the horse industry, with
- 17                  particular knowledge of horse racing;
- 18                  8. One (1) horse trainer licensed under this chapter;
- 19                  9. Two (2) charitable gaming representatives; and
- 20                  10. One (1) at-large member with no financial interest in the business or
- 21                  industry regulated.
- 22                  (3) (a) A member of the board of directors, by himself or herself or through others,
- 23                  shall not knowingly:
- 24                  1. Use or attempt to use the member's influence in any manner which
- 25                  involves a substantial conflict between his or her personal or private
- 26                  interest and the member's duties to the corporation;
- 27                  2. Use or attempt to use any means to influence the corporation in

- 1                   derogation of the corporation;
- 2                   3. Use the member's official position or office to obtain financial gain
- 3                   for himself or herself, or any spouse, parent, brother, sister, or child of
- 4                   the director; or
- 5                   4. Use or attempt to use his or her official position to secure or create
- 6                   privileges, exemptions, advantages, or treatment for the member or
- 7                   others in derogation of the interests of the corporation or of the
- 8                   Commonwealth.
- 9                   (b) A director shall not appear before the board or the corporation in any
- 10                   manner other than as a director.
- 11                   (c) A director shall abstain from action on an official decision in which he or
- 12                   she has or may have a personal or private interest, and shall disclose the
- 13                   existence of that personal or private interest in writing to each other
- 14                   member of the board on the same day on which the director becomes aware
- 15                   that the interest exists or that an official decision may be under
- 16                   consideration by the board. This disclosure shall cause the decision on these
- 17                   matters to be made in a meeting of the members of the board who do not
- 18                   have the conflict from which meeting the director shall be absent and from
- 19                   all votes on which matters the director shall abstain.
- 20                   (d) In determining whether to abstain from action on an official decision
- 21                   because of a possible conflict of interest, a director shall consider the
- 22                   following guidelines:
- 23                   1. Whether a substantial threat to the director's independence of
- 24                   judgment has been created by his or her personal or private interest;
- 25                   2. The effect of the director's participation on public confidence in the
- 26                   integrity of the corporation and of racing and gaming;
- 27                   3. Whether the director's participation is likely to have any significant

- 1                   effect on the disposition of the matter;
- 2                   4. The need for the director's particular contribution, such as special  
3                   knowledge of the subject matter, to the effective functioning of the  
4                   corporation; and
- 5                   5. Whether the official decision will affect the director in a manner  
6                   differently from the public, or will affect him or her as a member of a  
7                   business, profession, occupation, or group to no greater extent  
8                   generally than other members of the director's business, profession,  
9                   occupation, or group.
- 10                  Any director may request a vote of the disinterested members of the board  
11                  on whether any director shall abstain from action on an official decision.
- 12                  (e) A director shall not knowingly disclose or use confidential information  
13                  acquired in the course of his or her official duties in order to further the  
14                  director's own economic interests, or those of any person.
- 15                  (f) A director shall not knowingly receive, directly or indirectly, any interest or  
16                  profit arising from the use or loan of corporation funds or funds to be  
17                  raised through the corporation.
- 18                  (g) A director shall not knowingly accept compensation, other than that  
19                  provided in this section for directors, for performance of his or her official  
20                  duties.
- 21                  (h) A present or former director shall not, within one (1) year following  
22                  termination of the director's membership on the board, accept employment,  
23                  compensation, or other economic benefit from any person or business that  
24                  contracts or does business with the corporation in matters in which he or  
25                  she was directly involved during the director's tenure. This provision shall  
26                  not prohibit an individual from continuing in the same business, firm,  
27                  occupation, or profession in which he or she was involved prior to becoming

1 a director, provided that, for a period of one (1) year following termination  
2 of his or her position as a director, the director personally refrains from  
3 working on any matter in which the director was directly involved as a  
4 director. A director's involvement in an official decision or other action of  
5 the corporation impacting a broad class of persons or entities, and affecting  
6 the director to no greater extent generally than the members of the class,  
7 shall not prohibit the director's employment or engagement as a member of  
8 the class for any period after service as a director.

9 (i) A director, or a spouse, child, brother, sister, or parent of that director shall  
10 not have a financial interest of more than five percent (5%) of the total  
11 value of any vendor, other supplier of goods or services to the corporation,  
12 retailer, or related entity. The corporation shall provide each member of the  
13 board with a list of all current vendors, which shall be updated on at least a  
14 quarterly basis.

15 (4) The board of directors shall provide the president with private-sector perspectives  
16 on the operation of a large marketing enterprise. The board shall:

17 (a) Approve, disapprove, amend, or modify the budget recommended by the  
18 president for the operation of the corporation;

19 (b) Approve, disapprove, amend, or modify the terms of major procurements  
20 recommended by the president;

21 (c) Serve as a board of appeal for any denial, revocation, or cancellation by the  
22 president of a contract with a retailer;

23 (d) Promulgate administrative regulations to carry out and implement its  
24 powers and duties, the operation of the corporation, the conduct of live  
25 horse racing, pari-mutuel wagering, sports wagering, breed integrity and  
26 development, and on and after July 1, 2025, charitable gaming, and any  
27 other matters necessary or desirable for the efficient and effective operation

1 of the corporation or convenience of the public; and

2 (e) Review the performance of the corporation and:

3 1. Advise the president and make recommendations to him or her  
4 regarding operations of the corporation;

5 2. Identify potential improvements in this chapter, the administrative  
6 regulations of the corporation, and the management of the  
7 corporation; and

8 3. Request from the corporation any information the board determines to  
9 be relevant to its duties.

10 (5) In all other matters, the board shall advise and make recommendations.

11 (6) (a) The initial members of the board shall be the members of the Kentucky  
12 Horse Racing Commission serving as of July 1, 2024. Those members shall  
13 continue to serve as board members of the corporation for two (2)  
14 additional years until July 1, 2026.

15 (b) Any board member vacancy that occurs between July 1, 2024, and July 1,  
16 2026, shall be filled by appointment for the remainder of that time period.  
17 An appointment of the chair or vice chair created by a vacancy between  
18 July 1, 2024, and July 1, 2026, shall require confirmation of the  
19 appointment by the Senate as provided in KRS 11.160 and subsection (1) of  
20 this section.

21 (c) Beginning on July 1, 2026, board members shall be appointed for regular  
22 terms in accordance with this section.

23 (7) (a) Members of the board shall receive no compensation for serving on the  
24 board, but shall be reimbursed for travel expenses for attending meetings  
25 and performing other official functions consistent with the reimbursement  
26 policy for state employees established by KRS 45.101 and administrative  
27 regulations promulgated thereunder.

1       **(b) The vice chair may act in the absence of the chair.**

2       **(c) Before entering upon the discharge of their duties, all members of the board**  
3       **of directors of the Kentucky Horse Racing and Gaming Corporation shall**  
4       **take the constitutional oath of office.**

5       **(8) (a) All persons appointed to the corporation shall be of good moral character**  
6       **and shall not have been convicted of, or under indictment for, a felony in**  
7       **Kentucky, in any other state, in federal court, or in a foreign country.**

8       **(b) A board member of the corporation, or any family member of a member of**  
9       **the corporation, at the time of appointment or during the member's tenure**  
10       **on the corporation, shall not be a member of the legislature, a person**  
11       **holding any elective office in the state government, or any officer or official**  
12       **of any political party.**

13       **(9) Each appointed board member of the corporation shall be required to undergo a**  
14       **national and state criminal background investigation. The criminal background**  
15       **investigation shall be by means of a fingerprint check by the Department of**  
16       **Kentucky State Police or equivalent state police body in the member's home state**  
17       **and the Federal Bureau of Investigation, pursuant to the following requirements:**

18       **(a) The member shall provide his or her fingerprints to the Department of**  
19       **Kentucky State Police, or equivalent state police body in the member's home**  
20       **state, for submission to the Federal Bureau of Investigation after a state**  
21       **criminal background check is conducted;**

22       **(b) The results of the national and state criminal background check shall be**  
23       **sent to the corporation;**

24       **(c) The corporation shall be prohibited from releasing any criminal history**  
25       **record information to any private or public entity, or authorizing receipt by**  
26       **such private or public entity; and**

27       **(d) Any fee charged by the Department of Kentucky State Police or the Federal**



1           Bureau of Investigation shall be an amount no greater than the actual cost  
2           of processing the request and conducting the background check. The  
3           corporation may charge this fee to the member.

4           (10) (a) The Governor may remove any board member for misfeasance,  
5           malfeasance, or nonfeasance in office.

6           (b) The removal may be made after the member has been served with a copy of  
7           the charges against him or her and the member has a public hearing, if  
8           requested.

9           (c) The member charged may request a public hearing. The request shall be in  
10           writing and shall be submitted to the Governor's office within ten (10) days  
11           of the service of charges upon the member.

12           (d) If a public hearing is timely requested, the hearing shall be held before a  
13           hearing officer appointed by the Governor. The hearing officer shall make  
14           findings of fact and conclusions of law based upon the record of the  
15           hearing, and shall provide the Governor with a recommendation for action.  
16           The Governor's final decision, after recommendation by the hearing officer,  
17           may be appealed to the Circuit Court of the county in which the cause of  
18           action arose.

19           (11) Members of the board of directors shall be subject to all applicable provisions of  
20           KRS Chapter 11A.

21           (12) The provisions of KRS Chapters 18A and 64 shall not apply to the board,  
22           president, managers, or staff of the corporation.

23           ➔SECTION 7. KRS 230.230 IS REPEALED AND REENACTED TO READ  
24 AS FOLLOWS:

25           (1) The Governor shall appoint a president, who shall act as chief executive officer of  
26           the corporation, from a list of three (3) names provided by the board of directors  
27           of the corporation. The president shall serve at the pleasure of the Governor. The

1 president shall have the powers and duties described in this section and other  
2 duties directed or prescribed by the corporation.

3 (2) The president shall be compensated at a level determined by the board.

4 (3) The president shall have proven successful experience for a period of at least five  
5 (5) years at the management level in horse racing or gaming.

6 (4) The president shall conduct the day-to-day operations of the corporation for the  
7 purpose of carrying out the policies and procedures of this chapter and the board.

8 The duties of the president include but are not limited to:

9 (a) Administering and supervising all operations of the corporation in  
10 accordance with the direction of the board and administrative regulations  
11 promulgated by the board;

12 (b) 1. Preparing, submitting, and recommending to the board a proposed  
13 biennial budget of the corporation covering the operations of the  
14 corporation and, upon approval, submitting the budget, financial  
15 status, and actuarial condition of the corporation to the Governor and  
16 the General Assembly for their examination; and

17 2. With the approval of the board, amending or modifying the budget at  
18 any time in any manner deemed necessary for the proper operation of  
19 the corporation;

20 (c) Directing and controlling all expenditures of the approved budget;

21 (d) Recommending to the board and administering a system of personnel  
22 administration that includes benefits, grievance procedures, training, and  
23 compensation;

24 (e) Preparing and administering fiscal, payroll, accounting, data processing,  
25 and procurement procedures for the operation of the corporation;

26 (f) Recommending to the board bylaws and uniform procedures for the  
27 management of the corporation;

- 1        (g) Within the limitations of the budget, employing necessary personnel in  
2                accordance with the personnel policies of the board;
- 3        (h) Maintaining appropriate levels of property, casualty, and liability insurance  
4                as approved by the board to protect the president, managers, employees, and  
5                assets of the corporation;
- 6        (i) Attending meetings of the board or appointing a designee to attend on his or  
7                her behalf;
- 8        (j) Preparing annual reports of the corporation's program of work; and
- 9        (k) Performing all other duties and responsibilities required by law.
- 10      (5) (a) The president may hire a chief operating officer for the corporation.
- 11      (b) The president shall hire a chief financial officer for the corporation, who  
12                shall:
- 13              1. a. Be a certified public accountant licensed by the Commonwealth  
14                      of Kentucky or by another state; or
- 15                      b. Be a public accountant qualified to practice public accounting  
16                      under KRS Chapter 325; and
- 17              2. a. Have at least five (5) years of progressively responsible  
18                      experience in general accounting and a comprehensive  
19                      knowledge of the principles and practices of corporate finance;  
20                      or
- 21                      b. Possess the qualifications of an expert in the fields of corporate  
22                      finance, auditing, general finance, gaming, or economics.
- 23      (6) The president shall give an official bond in an amount and with sureties approved  
24                by the board. The premium for the bond shall be paid by the corporation.
- 25      (7) Following the president's confirmation, and during his or her entire term of  
26                office, the president shall reside in Kentucky.
- 27      (8) The president and the board may conduct an ongoing study of the operation and

1 administration of racing and gaming in other states or countries, of available  
 2 literature on the subject, of federal laws and regulations which may affect the  
 3 operation of the corporation, and of the reaction of citizens of this state to  
 4 existing or proposed racing and gaming, with a view toward implementing  
 5 improvements that will tend to serve the purposes of this chapter and, on and  
 6 after July 1, 2025, KRS Chapter 238.

7 (9) The president may:

8 (a) Require bond from corporate employees with access to corporate funds or  
 9 racing or gaming funds, in an amount promulgated in the administrative  
 10 regulations of the board. The president may also require bond from other  
 11 employees; and

12 (b) For good cause, suspend, revoke, or refuse to renew any contract entered  
 13 into in accordance with:

14 1. This chapter;

15 2. On and after July 1, 2025, KRS Chapter 238; or

16 3. The administrative regulations of the board.

17 (10) The president shall be subject to all applicable provisions of KRS Chapter 11A.

18 ➔SECTION 8. A NEW SECTION OF KRS CHAPTER 230 IS CREATED TO  
 19 READ AS FOLLOWS:

20 (1) (a) Notwithstanding any provision of KRS 61.520 to the contrary, the  
 21 corporation shall participate in the Kentucky Employees Retirement System  
 22 effective July 1, 2024, and all eligible employees shall participate in the  
 23 Kentucky Employees Retirement System effective July 1, 2024.

24 (b) Notwithstanding any provision of KRS 18A.205 to 18A.275 to the contrary,  
 25 employees of the corporation shall be:

26 1. Provided the same health insurance coverage as all other state  
 27 government employees as provided in KRS 18A.225 to 18A.2287;

- 1           2. Provided the same life insurance coverage provided all state employees  
2           as provided in KRS 18A.205 to 18A.220; and
- 3           3. Eligible to participate in the deferred compensation system provided  
4           for all state government employees as provided in KRS 18A.230 to  
5           18A.275.
- 6           (c) The Personnel Cabinet and the Kentucky Public Pensions Authority shall  
7           assist in the transfer of employees of the Kentucky Horse Racing  
8           Commission to the corporation by July 1, 2024, and the Department of  
9           Charitable Gaming to the corporation by July 1, 2025.
- 10          (2) A manager or employee of the corporation shall not have a financial interest in  
11          any vendor doing business or proposing to do business with the corporation.
- 12          (3) A manager or employee of the corporation with decision-making authority shall  
13          not participate in any decision involving a retailer with whom the manager or  
14          employee has a financial interest of five percent (5%) or more of the total value  
15          thereof.
- 16          (4) A manager or employee of the corporation who leaves the employ of the  
17          corporation shall not represent any vendor, retailer, or related entity before the  
18          corporation for a period of two (2) years following termination of employment  
19          with the corporation.
- 20          (5) A background investigation shall be conducted on every applicant who has  
21          reached the final selection process prior to employment by the corporation.  
22          Applicants may be fingerprinted as a condition of employment. In addition, all  
23          office managers of the corporation and employees of the corporation performing  
24          duties primarily related to security matters, prior to employment, shall be subject  
25          to a background investigation report conducted by the Department of Kentucky  
26          State Police. The Department of Kentucky State Police shall be reimbursed by the  
27          corporation for the cost of investigations conducted pursuant to this section. A

1 person who has been convicted of a felony, bookmaking or other forms of illegal  
2 gambling, or of a crime where dishonesty is a necessary element shall not be  
3 employed by the corporation. Any employee of the corporation who is or has been  
4 convicted of a felony, bookmaking or any other form of illegal gambling, or of a  
5 crime where dishonesty is a necessary element shall be terminated from  
6 employment by the corporation, except that this requirement shall not be  
7 interpreted to limit the right of the corporation to terminate the employment of  
8 any employee, at will, prior to any conviction.

9 (6) Employees of the corporation shall be subject to all applicable provisions of KRS  
10 Chapter 11A.

11 ➔SECTION 9. KRS 230.260 IS REPEALED AND REENACTED TO READ  
12 AS FOLLOWS:

13 The corporation shall have all powers necessary and proper to carry out and effectuate  
14 the purposes and provisions of this chapter on and after July 1, 2024, and the purposes  
15 and provisions of KRS Chapter 238 on and after July 1, 2025, including but not limited  
16 to the following:

17 (1) The corporation is vested with jurisdiction and supervision over all live horse  
18 racing, pari-mutuel wagering, sports wagering, breed integrity and development,  
19 and on and after July 1, 2025, charitable gaming, except for lottery games  
20 authorized under KRS Chapter 154A, in this Commonwealth and over all  
21 associations and all persons on association grounds and may eject or exclude  
22 therefrom or any part thereof, any person, licensed or unlicensed, whose conduct  
23 or reputation is such that the person's presence on association grounds may, in  
24 the opinion of the corporation, negatively reflect on the honesty and integrity of  
25 horse racing, or on sporting events upon which sports wagers may be placed, or  
26 interfere with the orderly conduct of horse racing or racing at horse race  
27 meetings, but no persons shall be excluded or ejected from association grounds

- 1 solely on the ground of race, color, creed, national origin, ancestry, or sex;
- 2 (2) The corporation is vested with jurisdiction over any person or entity that offers  
3 advance deposit account wagering to Kentucky residents. Any such person or  
4 entity under the jurisdiction of the corporation shall be licensed by the  
5 corporation, and the corporation may impose a license fee not to exceed ten  
6 thousand dollars (\$10,000) annually. The corporation shall, by administrative  
7 regulation promulgated in accordance with KRS Chapter 13A, establish  
8 conditions and procedures for the licensing of advance deposit account wagering  
9 providers to include but not be limited to:
- 10 (a) A fee schedule for applications for licensure; and
- 11 (b) Reporting requirements to include quarterly reporting on:
- 12 1. The amount wagered on Kentucky races; and
- 13 2. The total amount wagered by Kentuckians;
- 14 (3) The corporation is vested with jurisdiction over any totalisator company that  
15 provides totalisator services to a racing association located in the Commonwealth.  
16 A totalisator company under the jurisdiction of the corporation shall be licensed  
17 by the corporation, regardless of whether a totalisator company is located in the  
18 Commonwealth or operates from a location or locations outside of the  
19 Commonwealth, and the corporation may impose a license fee on a totalisator  
20 company. The corporation shall, by administrative regulation promulgated in  
21 accordance with KRS Chapter 13A, establish conditions and procedures for the  
22 licensing of totalisator companies, and a fee schedule for applications for  
23 licensure;
- 24 (4) The corporation is vested with jurisdiction over any manufacturer, wholesaler,  
25 distributor, or vendor of any equine drug, medication, therapeutic substance, or  
26 metabolic derivative which is purchased by or delivered to a licensee or other

8 (14) (a) An organization or a group of individuals that does not meet the licensing  
9 requirements of subsection (12) of this section may hold a raffle if:

- 10 1. The gross receipts do not exceed five hundred dollars (\$500);
- 11 2. All proceeds from the raffle are distributed to a charitable organization;
- 12 and
- 13 3. The organization or group of individuals holds no more than three (3)  
14 raffles each year;

15 and shall be exempt from complying with the notification, application, and

17 (b) An organization or a group of individuals that does not meet the licensing  
18 requirements of subsection (12) of this section may hold a raffle if:

- 26           3. The charitable organization pays a reinstatement fee established by the  
27           office[department].

1        ➔Section 21. KRS 238.536 is amended to read as follows:

- 2        (1) The net receipts from charitable gaming retained by a charitable organization for  
3        the previous calendar year, provided the charitable organization was licensed at the  
4        start of the calendar year, shall be equal to or greater than forty percent (40%) of the  
5        adjusted gross receipts of the charitable organization for the same period. A  
6        licensed charitable organization shall expend net receipts exclusively for purposes  
7        consistent with the charitable, religious, educational, literary, civic, fraternal, or  
8        patriotic functions or objectives for which the licensed charitable organization

12 (1) Charitable gaming shall be conducted by a licensed charitable organization at the  
13 location, date, and time which shall be stated on the license. The licensee shall  
14 request a change in the date, time, or location of a charitable gaming event by mail,  
15 electronic mail, or facsimile transmission, and shall submit a lease and an original  
16 signature of an officer. The office~~[department]~~ shall process this request and issue  
17 or deny a license within ten (10) days.

18 (2) All premises or facilities on which or in which charitable gaming is conducted shall  
19 meet all applicable federal, state, and local code requirements relating to life, safety,

18 supplies and equipment from any person not licensed as a distributor in the

20 (7) A licensed charitable organization shall not accept any merchandise prizes donated  
21 by any owner, officer, employee, or contractee of a licensed manufacturer,  
22 distributor, charitable gaming facility, or any of their affiliates, or any member of  
23 their immediate families.

24 (8) (a) Each organization's gaming supplies shall be maintained in a location separate  
25 from another organization's gaming supplies.

26 (b) This location shall also be locked and access shall be controlled.

27 (c) Unless otherwise directed by the office~~[department]~~, an organization's

1 supplies and equipment remain the property of the organization regardless of  
2 where they are stored and must be accessible to the organization at all  
3 reasonable times upon request.

4 (9) Any advertisement of charitable gaming, regardless of the medium used, shall  
5 contain the name of the charitable organization conducting the charitable gaming  
6 and its license number. An advertisement for a bingo session or sessions shall not  
7 advertise a bingo prize in excess of the limitation of five thousand dollars (\$5,000)  
8 per twenty-four (24) hour period set forth in KRS 238.545(1).

- 8 (f) No electronic pulltab device representation of a charity game ticket shall be  
9 sold in the Commonwealth of Kentucky that does not conform to the  
10 construction standards set forth in an administrative regulation promulgated  
11 by the corporation~~[department]~~. Electronic pulltab devices shall only be used  
12 for charitable gaming.
- 13 (g) No person under the age of eighteen (18) shall be permitted to purchase, or  
14 open in any manner, a charity game ticket.
- 15 (3) (a) Tickets for a raffle shall be sold separately, and each ticket shall constitute a  
16 separate and equal chance to win.
- 17 (b) All raffle tickets shall be sold for the price stated on the ticket, and no person  
18 shall be required to purchase more than one (1) ticket or to pay for anything  
19 other than a ticket to enter a raffle.
- 20 (c) Raffle tickets and tickets for charity fundraising raffle games approved by the  
21 office~~[department]~~ which are offered exclusively at charity fundraising events

4 suspend a license for failure by the licensee or other person participating in  
5 Kentucky horse racing to pay an administrative fine imposed upon the licensee by  
6 the stewards or the corporation~~[racing commission]~~. The corporation~~[racing~~  
7 ~~commission]~~, in the interest of honesty and integrity of horse racing, may  
8 promulgate administrative regulations under which any license may be denied,  
9 suspended, or revoked, and under which any licensee or other person participating  
10 in Kentucky horse racing may be assessed an administrative fine or required to  
11 forfeit or return a purse.

12 (2) (a) Following a hearing by the stewards, a person who has been disciplined by a  
13 ruling of the stewards may apply to the corporation~~[racing commission]~~ for a  
14 stay of the ruling, pending action on an appeal by the corporation~~[racing~~  
15 ~~commission]~~.

16 (b) An application for a stay shall be received by the president~~[executive~~  
17 ~~director]~~ or his or her designee within ten (10) calendar days of the issuance  
18 of the stewards' ruling.

19 (c) An application for a stay shall be in writing and include the following:

- 20 1. The name, address, telephone number, and signature of the person  
21 requesting the stay;
- 22 2. A statement of the justification for the stay; and
- 23 3. The period of time for which the stay is requested.

24 (d) On a finding of good cause, the president~~[executive director]~~ or his or her  
25 designee may grant the stay. The president~~[executive director]~~ or his or her  
26 designee shall issue a written decision granting or denying the request for stay  
27 within five (5) calendar days from the time the application for stay is received

1 by the president~~[executive director]~~ or his or her designee. If the

10 of the stay. The petition shall be filed in writing with the chairperson of the  
11 board of directors of the corporation~~[racing commission]~~ and received by the  
12 chairperson within ten (10) calendar days of the mailing of the  
13 president's~~[executive director's]~~ or designee's denial of the stay. The petition  
14 shall state the name, address, phone number, and signature of the petitioner; a  
15 statement of justification of the stay; and the time period for which the stay is  
16 requested. The chairperson shall convene a special meeting of the board of

1 (g) The fact that a stay is granted is not a presumption that the ruling by the  
2 stewards is invalid.

3 (3) If any license is denied, suspended, or revoked, or if any licensee or other person  
4 participating in Kentucky horse racing is assessed an administrative fine or required  
5 to forfeit or return a purse, after a hearing by the stewards or by the  
6 corporation~~[racing commission]~~ acting on a complaint or by its own volition, the  
7 corporation~~[racing commission]~~ shall grant the applicant, licensee, or other person  
8 the right to appeal the decision, and upon appeal, an administrative hearing shall be  
9 conducted in accordance with KRS Chapter 13B.

11 before the stewards be immediately transferred to the corporation~~[racing~~

14 (5) (a) In an administrative appeal to the corporation~~[racing commission]~~ by a  
15 licensee or other person participating in Kentucky horse racing, the  
16 corporation~~[racing commission]~~ may determine in its final order that the  
17 appeal is frivolous. If the corporation~~[racing commission]~~ finds that an appeal  
18 is frivolous:

- 19 1. This fact shall be considered an aggravating circumstance and may be  
20 considered in assessing any penalty against the licensee; and
- 21 2. The licensee or other person who raised the appeal may be required to  
22 reimburse the corporation~~[racing commission]~~ for the cost of the  
23 investigation of the underlying circumstances of the case and the cost of  
24 the adjudication of the appeal. Costs may include but are not limited to  
25 fees paid to a hearing officer or court reporter, attorneys fees, and  
26 laboratory expenses.

27 (b) The corporation~~[racing commission]~~ shall by administrative regulation



1           prescribe the conditions or factors by which an appeal may be determined to  
2           be frivolous.

3 (6) Any administrative action authorized in this chapter shall be in addition to any  
4 criminal penalties provided in this chapter or under other provisions of law.

5 PURPOSES

6 SECTION 1. Purposes.

7 The purposes of this compact are to:

- 8 1. Establish uniform requirements among the party states for the licensing of  
9 participants in live racing with pari-mutuel wagering, and ensure that all such  
10 participants who are licensed pursuant to this compact meet a uniform minimum  
11 standard of honesty and integrity.
- 12 2. Facilitate the growth of the pari-mutuel racing industry in each party state and  
13 nationwide by simplifying the process for licensing participants in live racing, and  
14 reduce the duplicative and costly process of separate licensing by the regulatory  
15 agency in each state that conducts live racing with pari-mutuel wagering.
- 16 3. Authorize the Kentucky Horse Racing and Gaming Corporation~~[Commission]~~ to  
17 participate in this compact.
- 18 4. Provide for participation in this compact by officials of the party states, and permit  
19 those officials, through the compact committee established by this compact, to enter  
20 into contracts with governmental agencies and nongovernmental persons to carry  
21 out the purposes of this compact.
- 22 5. Establish the compact committee created by this compact as an interstate  
23 governmental entity duly authorized to request and receive criminal history record  
24 information from the Federal Bureau of Investigation and other state and local law  
25 enforcement agencies.

26 ARTICLE II

27 DEFINITIONS

1 SECTION 2. Definitions.

2 "Compact committee" means the organization of officials from the party states that is  
3 authorized and empowered by this compact to carry out the purposes of this compact.

4 "Official" means the appointed, elected, designated or otherwise duly selected member of  
5 a racing commission or the equivalent thereof in a party state who represents that party  
6 state as a member of the compact committee.

7 "Participants in live racing" means participants in live racing with pari-mutuel wagering  
8 in the party states.

9 "Party state" means each state that has enacted this compact.

10 "State" means each of the several states of the United States, the District of Columbia, the  
11 Commonwealth of Puerto Rico and each territory or possession of the United States.

12 ARTICLE III

13 ENTRY INTO FORCE, ELIGIBLE PARTIES AND WITHDRAWAL

14 SECTION 3. Entry into force.

15 This compact shall come into force when enacted by any four (4) states. Thereafter, this  
16 compact shall become effective as to any other state upon both (i) that state's enactment  
17 of this compact and (ii) the affirmative vote of a majority of the officials on the compact  
18 committee as provided in Section 8.

19 SECTION 4. States eligible to join compact.

20 Any state that has adopted or authorized live racing with pari-mutuel wagering shall be  
21 eligible to become party to this compact.

22 SECTION 5. Withdrawal from compact and impact thereof on force and effect of  
23 compact.

24 Any party state may withdraw from this compact by enacting a statute repealing this  
25 compact, but no such withdrawal shall become effective until the head of the executive  
26 branch of the withdrawing state has given notice in writing of such withdrawal to the  
27 head of the executive branch of all other party states. If as a result of withdrawals

1 participation in this compact decreases to less than three (3) party states, this compact no  
2 longer shall be in force and effect unless and until there are at least three (3) or more  
3 party states again participating in this compact.

#### 5 COMPACT COMMITTEE

#### 6 SECTION 6. Compact committee established.

7 There is hereby created an interstate governmental entity to be known as the "compact  
8 committee," which shall be comprised of one (1) official from the racing commission or  
9 its equivalent in each party state who shall be appointed, serve and be subject to removal  
10 in accordance with the laws of the party state he represents. Pursuant to the laws of his  
11 party state, each official shall have the assistance of his state's racing commission or the  
12 equivalent thereof in considering issues related to licensing of participants in live racing  
13 and in fulfilling his responsibilities as the representative from his state to the compact  
14 committee. If an official is unable to perform any duty in connection with the powers and  
15 duties of the compact committee, the racing commission or equivalent thereof from his  
16 state shall designate another of its members as an alternate who shall serve in his place  
17 and represent the party state as its official on the compact committee until that racing  
18 commission or equivalent thereof determines that the original representative official is  
19 able once again to perform his duties as that party state's representative official on the  
20 compact committee. The designation of an alternate shall be communicated by the  
21 affected state's racing commission or equivalent thereof to the compact committee as the  
22 committee's bylaws may provide.

#### 23 SECTION 7. Powers and duties of compact committee.

24 In order to carry out the purposes of this compact, the compact committee is hereby  
25 granted the power and duty to:

- 26 1. Determine which categories of participants in live horse racing, including but not  
27 limited to owners, trainers, jockeys, grooms, mutuel clerks, racing officials,

1 veterinarians, and farriers, and which categories of equivalent participants in dog  
2 racing and other forms of live racing with pari-mutuel wagering authorized in two  
3 (2) or more of the party states, should be licensed by the committee, and establish  
4 the requirements for the initial licensure of applicants in each such category, the  
5 term of the license for each category, and the requirements for renewal of licenses  
6 in each category. Provided, however, that with regard to requests for criminal  
7 history record information on each applicant for a license, and with regard to the  
8 effect of a criminal record on the issuance or renewal of a license, the compact  
9 committee shall determine for each category of participants in live racing which  
10 licensure requirements for that category are, in its judgment, the most restrictive  
11 licensure requirements of any party state for that category and shall adopt licensure  
12 requirements for that category that are, in its judgment, comparable to those most  
13 restrictive requirements.

14 2. Investigate applicants for a license from the compact committee and, as permitted  
15 by federal and state law, gather information on such applicants, including criminal  
16 history record information from the Federal Bureau of Investigation and relevant  
17 state and local law enforcement agencies, and, where appropriate, from the Royal  
18 Canadian Mounted Police and law enforcement agencies of other countries,  
19 necessary to determine whether a license should be issued under the licensure  
20 requirements established by the committee as provided in paragraph 1 above. Only  
21 officials on, and employees of, the compact committee may receive and review  
22 such criminal history record information, and those officials and employees may  
23 use that information only for the purposes of this compact. No such official or  
24 employee may disclose or disseminate such information to any person or entity  
25 other than another official on or employee of the compact committee. The  
26 fingerprints of each applicant for a license from the compact committee shall be  
27 taken by the compact committee, its employees, or its designee and, pursuant to

- 1 Public Law 92-544 or Public Law 100-413, shall be forwarded to a state  
2 identification bureau, or to an association of state officials regulating pari-mutuel  
3 wagering designated by the Attorney General of the United States, for submission  
4 to the Federal Bureau of Investigation for a criminal history record check. Such  
5 fingerprints may be submitted on a fingerprint card or by electronic or other means  
6 authorized by the Federal Bureau of Investigation or other receiving law  
7 enforcement agency.
- 8 3. Issue licenses to, and renew the licenses of, participants in live racing listed in  
9 paragraph 1 of this section who are found by the committee to have met the  
10 licensure and renewal requirements established by the committee. The compact  
11 committee shall not have the power or authority to deny a license. If it determines  
12 that an applicant will not be eligible for the issuance or renewal of a compact  
13 committee license, the compact committee shall notify the applicant that it will not  
14 be able to process his application further. Such notification does not constitute and  
15 shall not be considered to be the denial of a license. Any such applicant shall have  
16 the right to present additional evidence to, and to be heard by, the compact  
17 committee, but the final decision on issuance or renewal of the license shall be  
18 made by the compact committee using the requirements established pursuant to  
19 paragraph 1 of this section.
- 20 4. Enter into contracts or agreements with governmental agencies and with  
21 nongovernmental persons to provide personal services for its activities and such  
22 other services as may be necessary to effectuate the purposes of this compact.
- 23 5. Create, appoint, and abolish those offices, employments, and positions, including an  
24 executive director, as it deems necessary for the purposes of this compact, prescribe  
25 their powers, duties and qualifications, hire persons to fill those offices,  
26 employments and positions, and provide for the removal, term, tenure,  
27 compensation, fringe benefits, retirement benefits and other conditions of

1 employment of its officers, employees and other positions.

2 6. Borrow, accept, or contract for the services of personnel from any state, the United  
3 States, or any other governmental agency, or from any person, firm, association,  
4 corporation or other entity.

5 7. Acquire, hold, and dispose of real and personal property by gift, purchase, lease,  
6 license, or in other similar manner, in furtherance of the purposes of this compact.

7 8. Charge a fee to each applicant for an initial license or renewal of a license.

8 9. Receive other funds through gifts, grants and appropriations.

9 SECTION 8. Voting requirements.

10 A. Each official shall be entitled to one (1) vote on the compact committee.

11 B. All action taken by the compact committee with regard to the addition of party  
12 states as provided in Section 3, the licensure of participants in live racing, and the  
13 receipt and disbursement of funds shall require a majority vote of the total number  
14 of officials (or their alternates) on the committee. All other action by the compact  
15 committee shall require a majority vote of those officials (or their alternates)  
16 present and voting.

17 C. No action of the compact committee may be taken unless a quorum is present. A  
18 majority of the officials (or their alternates) on the compact committee shall  
19 constitute a quorum.

20 SECTION 9. Administration and management.

21 A. The compact committee shall elect annually from among its members a chairman, a  
22 vice chairman, and a secretary/treasurer.

23 B. The compact committee shall adopt bylaws for the conduct of its business by a two-  
24 thirds (2/3) vote of the total number of officials (or their alternates) on the  
25 committee at that time and shall have the power by the same vote to amend and  
26 rescind these bylaws. The committee shall publish its bylaws in convenient form  
27 and shall file a copy thereof and a copy of any amendments thereto with the

1 Secretary of State or equivalent agency of each of the party states.

2 C. The compact committee may delegate the day-to-day management and  
3 administration of its duties and responsibilities to an executive director and his  
4 support staff.

5 D. Employees of the compact committee shall be considered governmental employees.

6 SECTION 10. Immunity from liability for performance of official responsibilities and  
7 duties.

8 No official of a party state or employee of the compact committee shall be held  
9 personally liable for any good faith act or omission that occurs during the performance  
10 and within the scope of his responsibilities and duties under this compact.

11 ARTICLE V

12 RIGHTS AND RESPONSIBILITIES OF EACH PARTY STATE

13 SECTION 11. Rights and responsibilities of each party state.

14 A. By enacting this compact, each party state:

15 1. Agrees (i) to accept the decisions of the compact committee regarding the  
16 issuance of compact committee licenses to participants in live racing pursuant  
17 to the committee's licensure requirements, and (ii) to reimburse or otherwise  
18 pay the expenses of its official representative on the compact committee or his  
19 alternate.

20 2. Agrees not to treat a notification to an applicant by the compact committee  
21 under paragraph 3 of Section 7 that the compact committee will not be able to  
22 process his application further as the denial of a license, or to penalize such an  
23 applicant in any other way based solely on such a decision by the compact  
24 committee.

25 3. Reserves the right (i) to charge a fee for the use of a compact committee  
26 license in that state, (ii) to apply its own standards in determining whether, on  
27 the facts of a particular case, a compact committee license should be

1           suspended or revoked, (iii) to apply its own standards in determining licensure  
2           eligibility, under the laws of that party state, for categories of participants in  
3           live racing that the compact committee determines not to license and for  
4           individual participants in live racing who do not meet the licensure  
5           requirements of the compact committee, and (iv) to establish its own licensure  
6           standards for the licensure of nonracing employees at pari-mutuel racetracks  
7           and employees to separate satellite wagering facilities. Any party state that  
8           suspends or revokes a compact committee license shall, through its racing  
9           commission or the equivalent thereof or otherwise, promptly notify the  
10          compact committee of that suspension or revocation.

11    B.   No party state shall be held liable for the debts or other financial obligations  
12          incurred by the compact committee.

### 13    ARTICLE VI

#### 14    CONSTRUCTION AND SEVERABILITY

##### 15    SECTION 12. Construction and severability.

16    This compact shall be liberally construed so as to effectuate its purposes. The provisions  
17    of this compact shall be severable, and, if any phrase, clause, sentence, or provision of  
18    this compact is declared to be contrary to the Constitution of the United States or of any  
19    party state, or the applicability of this compact to any government, agency, person or  
20    circumstance is held invalid, the validity of the remainder of this compact and the  
21    applicability thereof to any government, agency, person or circumstance shall not be  
22    affected thereby. If all or some portion of this compact is held to be contrary to the  
23    constitution of any party state, the compact shall remain in full force and effect as to the  
24    remaining party states and in full force and effect as to the state affected as to all  
25    severable matters.

26          ➔Section 75.   KRS 230.3761 is amended to read as follows:

27    The Governor of this Commonwealth is authorized and directed to execute a compact on



1 behalf of the Commonwealth with any of the United States, the District of Columbia, the  
2 Commonwealth of Puerto Rico, and each territory or possession of the United States,  
3 legally joining therein in the form substantially as follows:

4 ARTICLE I

5 PURPOSES

6 The purposes of this compact are:

- 7 (A) To enable member states to act jointly and cooperatively to create more uniform,  
8 effective, and efficient practices, programs, rules, and regulations relating to live  
9 pari-mutuel horse or greyhound racing and to pari-mutuel wagering activities, both  
10 on-track and off-track, that occur in or affect a member state;
- 11 (B) To facilitate the health and growth of the industry by simplifying the process of  
12 participating in live horse and greyhound racing and pari-mutuel wagering,  
13 improving the quality and integrity of racing and wagering, more effectively  
14 regulating simulcast and wagering systems and activities, and through cooperative  
15 action reducing the costs incurred by each member state or participant;
- 16 (C) To authorize the Kentucky Horse Racing and Gaming Corporation~~[Commission]~~  
17 to participate in this compact;
- 18 (D) To permit officials from the member states to participate in this compact and,  
19 through the compact commission established by this compact, to enter into  
20 contracts with governmental agencies and other persons to carry out the purposes of  
21 this compact; and
- 22 (E) To establish the compact commission created by this compact as an interstate  
23 governmental entity duly authorized to request and to receive criminal history  
24 record information from the Federal Bureau of Investigation and from state, local,  
25 and foreign law enforcement agencies.

26 ARTICLE II

27 DEFINITIONS

1 For the purposes of this compact, the following terms shall have the following meaning:

2 (A) "Commissioner" means the chairperson of the member state racing commission, or  
3 such person's designee, who represents the member state as a voting member of the  
4 compact commission and anyone who is serving as such person's alternate;

5 (B) "Compact commission" means the organization of officials from the member states  
6 that is authorized and empowered by this compact to carry out the purposes of this  
7 compact;

8 (C) "Compact rule" means a rule or regulation adopted by a member state through the  
9 compact to govern, for two (2) or more member states, any part of live pari-mutuel  
10 horse and greyhound racing or pari-mutuel wagering activities, whether on-track or  
11 off-track, that occur in or affect such states;

12 (D) "Live racing" means live horse or greyhound racing with pari-mutuel wagering;

13 (E) "Member state" means each state that has enacted this compact;

14 (F) "National industry stakeholder" means a non-governmental organization that the  
15 compact commission determines from a national perspective significantly  
16 represents one (1) or more categories of participants in live racing and pari-mutuel  
17 wagering;

18 (G) "Participants in live racing and pari-mutuel wagering" means all persons who  
19 participate in, operate, provide industry services for, or are involved with live  
20 racing and pari-mutuel wagering;

21 (H) "State" means each of the several states of the United States, the District of  
22 Columbia, the Commonwealth of Puerto Rico, and each territory or possession of  
23 the United States; and

24 (I) "State racing commission" means the state racing commission, or its equivalent, in  
25 each member state. Where a member state has more than one (1), it shall mean all  
26 such racing commissions, or their equivalents.

27

### ARTICLE III

## 1 COMPOSITION AND MEETINGS OF COMPACT COMMISSION

2 The member states shall create and participate in a compact commission as follows:

- 3 (A) This compact shall come into force when enacted by any six (6) eligible states, and  
4 shall thereafter become effective as to any other member state that enacts this  
5 compact. Any state that has adopted or authorized pari-mutuel wagering or live  
6 horse or greyhound racing shall be eligible to become a party to this compact. A  
7 compact rule, fee, practice, or program shall not become effective in a new member  
8 state based merely upon it entering the compact.
- 9 (B) The member states hereby create the racing and wagering commission, a body  
10 corporate and an interstate governmental entity of the member states, to coordinate  
11 the decision-making and actions of each member state racing commission through a  
12 compact commission.
- 13 (C) The compact commission shall consist of one (1) commissioner, the chairperson of  
14 the state racing commission or such person's designee, from each member state.  
15 When a commissioner is not present to perform any duty in the compact  
16 commission, a designated alternate may serve instead. The person who represents a  
17 member state in the compact commission shall serve and perform such duties  
18 without compensation or remuneration; provided that, subject to the availability of  
19 budgeted funds, each may be reimbursed for ordinary and necessary costs and  
20 expenses. The designation of a commissioner, including the alternate, shall be  
21 effective when written notice has been provided to the compact commission. The  
22 commissioner, including the alternate, must be a member or employee of the state  
23 racing commission.
- 24 (D) The compact commissioner from each state shall participate as an agent of the state  
25 racing commission. Each commissioner shall have the assistance of the state racing  
26 commission in regard to all decision making and actions of the state in and through  
27 the compact commission.

- 1 (E) Each member state, by its commissioner, shall be entitled to one (1) vote in the  
2 compact commission. A majority vote of the total number of commissioners shall  
3 be required to issue or renew a license, to receive and distribute any funds, and to  
4 adopt, amend, or rescind the by-laws. A compact rule, fee, practice, or program  
5 shall take effect in and for each member state whose commissioner votes  
6 affirmatively to adopt it. Other compact actions shall require a majority vote of the  
7 commissioners who are meeting.
- 8 (F) Meetings and votes of the compact commission may be conducted in person or by  
9 telephone or other electronic communication. Meetings may be called by the  
10 chairperson of the compact commission or by any two (2) commissioners.  
11 Reasonable notice of each meeting shall be provided to all commissioners serving  
12 in the compact commission.
- 13 (G) No action may be taken at a compact commission meeting unless there is a quorum,  
14 which is either a majority of the commissioners in the compact commission or,  
15 where applicable, all the commissioners from any member states who propose or  
16 are voting affirmatively to adopt a compact rule, fee, practice, or program.
- 17 (H) Once effective, the compact shall continue in force and remain binding according to  
18 its terms upon each member state; provided that, a member state may withdraw  
19 from the compact by repealing the statute that enacted the compact into law. The  
20 racing commission of a withdrawing state shall give written notice of such  
21 withdrawal to the compact chairperson, who shall notify the member state racing  
22 commissions. A withdrawing state shall remain responsible for any unfulfilled  
23 obligations and liabilities. The effective date of withdrawal from the compact shall  
24 be the effective date of the repeal.

#### ARTICLE IV

#### OPERATION OF COMPACT COMMISSION

27 The compact commission is hereby granted, so that it may be an effective means to

1 pursue and achieve the purposes of each member state in this compact, the power and  
2 duty:

- 3 (A) To adopt, amend, and rescind by-laws to govern its conduct, as may be necessary or  
4 appropriate to carry out the purposes of the compact; to publish them in a  
5 convenient form; and to file a copy of them with the state racing commission of  
6 each member state;
- 7 (B) To elect annually from among the commissioners (including alternates) a  
8 chairperson, vice-chairperson, and treasurer with such authority and duties as may  
9 be specified in the by-laws;
- 10 (C) To establish and appoint committees which it deems necessary for the carrying out  
11 of its functions, including advisory committees which shall be comprised of  
12 national industry stakeholders and organizations, and such other persons as may be  
13 designated in accordance with the by-laws, to obtain their timely and meaningful  
14 input into the compact rule, fee, practice, and program making processes;
- 15 (D) To establish an executive committee, with membership established in the by-laws,  
16 which shall oversee the day-to-day activities of compact administration and  
17 management by the executive director and staff; hire and fire as may be necessary  
18 after consultation with the compact commission; administer and enforce  
19 compliance with the provisions, by-laws, rules, fees, practices, and programs of the  
20 compact; and perform such other duties as the by-laws may establish;
- 21 (E) To create, appoint, and abolish all those offices, employments, and positions,  
22 including an executive director, useful to fulfill its purposes; to hire persons for  
23 them; to prescribe their powers, duties, and qualifications; and to provide for their  
24 term, tenure, removal, compensation, fringe and retirement benefits, and other  
25 conditions of employment;
- 26 (F) To delegate day-to-day management and administration of its duties, as needed, to  
27 an executive director and support staff, such as the Association of Racing

- 1 Commissioners International, Inc., or its successor;
- 2 (G) To adopt an annual budget sufficient to provide for the payment of the reasonable  
3 expenses of its establishment, organization, and ongoing activities. The budget shall  
4 be fully funded by means established by the compact commission. A member state  
5 may choose to participate in funding by means other than a compact fee or fees, in  
6 which case the compact commission shall make a finding of how much the member  
7 state, including its racing and wagering, may benefit from budget items (less  
8 program costs funded by user fees); and the member state may provide such  
9 funding by its own means. Indivisible benefits to live racing shall be allocated by  
10 proportion of annual purses. Nothing in this provision shall prevent the compact  
11 commission from paying obligations accrued in a prior year or from revising its  
12 finding of the benefit to a member state from the preceding year; and
- 13 (H) To provide a mediation and a binding dispute resolution service for member states  
14 who decide to use them to resolve a compact dispute among each other; provided,  
15 that the design and implementation of each program shall be established by  
16 compact rule making.

17 ARTICLE V

18 GENERAL POWERS AND DUTIES

19 To allow each member state, as and when it chooses, to achieve the purpose of this  
20 compact through joint and cooperative action, the member states are hereby granted the  
21 power and duty, by and through the compact commission:

- 22 (A) To act jointly and cooperatively to create a more equitable and uniform pari-mutuel  
23 racing and wagering interstate regulatory framework, including but not limited to  
24 the adoption of standardized rules of racing and equine drug regulations, closing  
25 inequalities in how regulatory standards and statutory requirements apply to  
26 industry participants; improving wagering monitoring and integrity; and making  
27 industry and participant information more available to government officials;

- 1 (B) To collaborate with national industry stakeholders and industry organizations, such  
2 as the Racing Medication and Testing Consortium, in the design and  
3 implementation of compact rules, fees, practices, and programs in a manner that  
4 serves the best interests of racing;
- 5 (C) To create more uniform, effective, or efficient practices and programs, with the  
6 consent of each member state that shall participate in them, relating to any part of  
7 live pari-mutuel horse or greyhound racing or pari-mutuel wagering activities,  
8 whether on-track or off-track, that occur in or affect a member state;
- 9 (D) To adopt compact rules, which shall have the force and effect of state rules or  
10 regulations in the member states who vote to adopt them, to govern all or any part  
11 of live pari-mutuel horse and greyhound racing or pari-mutuel wagering activities;
- 12 (E) To charge and collect a fee for services provided by the compact, including  
13 licensure and renewal of each license applicant, and for defraying the actual cost of  
14 compact commission administration, procedures, activities and programs; and
- 15 (F) To issue and renew licenses for participants in live racing and pari-mutuel wagering  
16 who are found by the compact commission to have met its licensure or renewal  
17 requirements in categories it chooses to license. It shall establish the term for each  
18 category, and the license criteria and weight given to character and integrity  
19 information that in its judgment meet the most restrictive requirements of the  
20 member states. The compact commission shall not have the power or authority to  
21 deny a license. If it determines that an applicant will not be eligible, it shall notify  
22 the applicant that it will not be able to process the application any further, which  
23 shall not constitute and shall not be considered to be the denial of a license.  
24 Although an applicant shall have the right to present further evidence and to be  
25 heard, the final decision on issuance or renewal of a license shall be made by the  
26 compact commission pursuant to its established requirements. The compact  
27 commission shall have the power and duty to investigate license applicants and, as

1 permitted by federal and state law, to gather information, including criminal history  
2 records from the Federal Bureau of Investigation and from state, local, and foreign  
3 country law enforcement agencies (including the Royal Canadian Mounted Police),  
4 necessary to decide whether an applicant meets its license requirements. Such  
5 criminal history record information may be received and reviewed only by the  
6 officials on, and employees of, the compact commission, and that information may  
7 be used only for the purposes of this compact. No such official or employee may  
8 disclose or disseminate such criminal history record information to any person or  
9 entity other than another official on, or employee of, the compact commission. The  
10 compact commission, its employees, or its designee shall take the fingerprints of  
11 each license applicant and, pursuant to Public Law 92-544 or Public Law 100-413,  
12 forward the fingerprints to a state identification bureau, the Association of Racing  
13 Commissioners International (an association of state officials regulating pari-mutuel  
14 wagering, designated by the Attorney General of the United States), or another  
15 entity with an equivalent designation, for submission to the Federal Bureau of  
16 Investigation or other receiving law enforcement agency. The compact commission  
17 shall cooperate with the Interstate Compact on Licensure of Participants in Live  
18 Racing with Pari-Mutuel Wagering and, if requested by that entity, assume all of its  
19 licensing and employer duties and responsibilities with the authority of and  
20 pursuant to all of the licensing standards, laws, rules and regulations applicable to  
21 that entity.

## 22 ARTICLE VI

### 23 OTHER POWERS AND DUTIES

24 The compact commission may exercise such incidental powers and duties as may be  
25 necessary and proper for it to function in a useful manner, including but not limited to the  
26 power and duty:

27 (A) To enter into contracts and agreements with governmental agencies and other



- 1 persons, including officers and employees of a member state, to provide personal  
2 services for its activities and such other services as may be necessary;
- 3 (B) To borrow, accept, and contract for the services of personnel from any state,  
4 federal, or other governmental agency, or from any other person or entity;
- 5 (C) To receive information from and to provide information to each member state  
6 racing commission, including its officers and staff, on such terms and conditions as  
7 may be established in the by-laws;
- 8 (D) To acquire, hold, and dispose of any real or personal property by gift, grant,  
9 purchase, lease, license, and similar means and to receive additional funds through  
10 gifts, grants, and appropriations;
- 11 (E) To purchase and maintain insurance and bonds, and to require others to do so;
- 12 (F) When authorized by a compact rule, to conduct hearings, issue subpoenas requiring  
13 the attendance and testimony of witnesses and the production of evidence, and  
14 render decisions and orders;
- 15 (G) To establish in the by-laws the requirements that shall describe and govern its  
16 duties to conduct open or public meetings and to provide public access to compact  
17 records and information, which shall include the exceptions established by law in  
18 one (1) or more member states and shield any confidential submissions made in  
19 connection with license applications; and
- 20 (H) To enforce compliance with the provisions, by-laws, rules, fees, practices, and  
21 programs of the compact using such means as may be consistent with this compact.

## 22 ARTICLE VII

### 23 COMPACT RULE MAKING

24 In the exercise of its rule making authority, the compact commission shall:

- 25 (A) Engage in formal rule making pursuant to a process that substantially conforms to  
26 the Model State Administrative Procedure Act of 1981 as amended, as may be  
27 appropriate to the actions and operations of the compact commission;

- 1 (B) Gather information and engage in discussions with advisory committees, national  
2 industry stakeholders, and others to foster and conduct a collaborative approach in  
3 the design and advancement of compact rules in a manner that serves the best  
4 interests of racing and as established in the by-laws;
- 5 (C) Not publish a proposed compact rule in a member state over its objection. The  
6 affirmative vote of a member state for a proposed compact rule shall be necessary  
7 and sufficient to adopt, amend, or rescind a compact rule as applicable to that  
8 member state; and
- 9 (D) Have a standing committee that reviews at least quarterly the participation in and  
10 value of compact rules and, when it determines that a revision is appropriate or  
11 when requested to by any member state, submits a revising proposed compact rule.  
12 To the extent a revision would only add or remove a member state or states from  
13 where a compact rule has been adopted, the vote required by this article shall be  
14 required of only such state or states.

15 ARTICLE VIII

16 COMPACT FEES

- 17 (A) The compact commission may charge and collect a fee for services provided by the  
18 compact, including licensure and renewal of each license applicant, and for  
19 defraying the actual cost of compact commission administration, procedures,  
20 activities, and programs; provided that such latter fee or fees shall not create a  
21 disproportionate cost for any member state.
- 22 (B) Compact fees must relate to participation in live horse or greyhound racing and  
23 pari-mutuel wagering activities, whether on-track or off-track, that occur in or  
24 affect a member state. No fee shall be adopted except after consultation with  
25 relevant advisory committees and interested national industry stakeholders.
- 26 (C) The establishment of a compact fee may include a requirement that a participant in  
27 live horse or greyhound racing with pari-mutuel wagering, as a condition of

1 continued participation, collect, hold, and remit to the compact commission funds  
2 that belong to a third party, with which it conducts related transactions, that is  
3 obliged to pay the compact fee.

4 (D) The compact commission may require fee payments to occur on a periodic basis,  
5 accompanied by a sworn report attesting to accuracy and completeness, and may  
6 provide that it shall have the power to examine the books and records of any  
7 persons required to pay or remit it, for the purpose of ascertaining whether the  
8 proper amounts are being paid. Such books and records shall not thereby be made  
9 available for public inspection.

10 (E) No fee shall be adopted before the completion of a period of public notice and  
11 participation substantially conforming, as may be appropriate to the actions and  
12 operations of the compact commission, for making rules under the Model State  
13 Administrative Procedure Act of 1981 as amended.

## 14 ARTICLE IX

### 15 STATUS AND RELATIONSHIP TO MEMBER STATES

16 (A) The compact commission, as an interstate governmental entity, shall be exempt  
17 from all taxation in and by the member states.

18 (B) The compact commission shall not pledge the credit of any member state except by  
19 and with the appropriate legal authority of that state.

20 (C) The compact commission shall adopt an annual budget that is sufficient to provide  
21 for the payment of the reasonable expenses of its establishment, organization, and  
22 ongoing activities, and by which member states shall fully fund the compact  
23 commission by the means set forth in this compact.

24 (D) Each member state shall reimburse or otherwise pay the expenses of its  
25 commissioner, including any alternate, in the compact commission.

26 (E) No member state, except as provided in Article XII of this compact, shall be held  
27 liable for the debts or other financial obligations incurred by the compact

1 commission.

- 2 (F) No member state shall have, while it participates in the compact commission, any  
3 claim to or ownership of any property held by or vested in the compact commission  
4 or to any compact commission funds held pursuant to this compact except for state  
5 license or other fees or moneys collected by the compact commission as its agent.
- 6 (G) The compact dissolves upon the date of the withdrawal of the member state that  
7 reduces membership in the compact to one (1) state. Upon dissolution, the compact  
8 becomes null and void and shall be of no further force or effect, although rules and  
9 programs adopted through this compact shall remain rules and programs in each  
10 member state that had adopted or consented to them, and the business and affairs of  
11 the racing and wagering compact shall be concluded and any surplus funds shall be  
12 distributed to the former member states in accordance with the by-laws.

13 ARTICLE X

14 RIGHTS AND RESPONSIBILITIES OF MEMBER STATES

- 15 (A) Each member state in the compact shall accept the decisions, duly applicable to it,  
16 of the compact commission in regard to compact rules, fees, practices, and  
17 programs, and the issuance or renewal of licenses.
- 18 (B) When the compact commission determines that an application shall not be  
19 processed further, the member states shall not treat this as the denial of a license or  
20 otherwise penalize the applicant because of such action by the compact  
21 commission.
- 22 (C) Each member state in the compact shall have and exercise the right:
- 23 (1) To charge a fee for the use of a compact license within that member state  
24 equal to the fee charged for a comparable state license;
- 25 (2) To apply its own standards and procedures to determine whether the use of a  
26 compact commission license should be suspended or revoked in its  
27 jurisdiction;

- 1           (3) To apply its own standards for licensure or renewal of state applicants who do  
2           not meet the licensure requirements of the compact commission, who are  
3           within a category of participants in racing and wagering that the compact  
4           commission does not license, or who apply to the member state for a state  
5           license; and
- 6           (4) To apply its own standards and procedures, except as may be provided by  
7           rule, to determine whether a participant in live racing or pari-mutuel wagering  
8           has violated any rule or regulation in its jurisdiction and to impose an  
9           appropriate penalty.
- 10       (D) Each member state racing commission shall promptly notify the compact  
11       commission, or its designee, whenever the member state has adjudged a violation of  
12       any state or compact rule and imposed a suspension or revocation upon a compact  
13       commission licensee.
- 14       (E) All departments, agencies, bodies, officers, and employees of each member state  
15       and its political subdivisions are authorized to cooperate with the compact  
16       commission and shall take all necessary and appropriate action, such as to publish  
17       proposed and adopted rules in state registries and administrative codes, to effectuate  
18       and in furtherance of compact duties or actions that may affect the state.
- 19       (F) This compact shall not be construed to diminish or limit the powers and  
20       responsibilities of the member state racing commission, or to invalidate any action  
21       it has previously taken, except to the extent it has, by its compact commissioner,  
22       expressed its consent to a specific rule or other action of the compact commission.  
23       The compact commissioner from each state shall serve as the agent of the state  
24       racing commission and shall possess substantial racing and wagering knowledge  
25       and experience as a regulator or participant in the racing and wagering industry in  
26       order to participate effectively in compact rule making.

## ENFORCEMENT OF COMPACT

- (A) Any member state in the compact and the compact commission may initiate legal action in the United States District Court, in any federal district where the compact commission has an office, to enforce compliance by any member state or the compact commission with the compact provisions, by-laws, fees, findings, practices, and programs.
- (B) Any member state in the compact and the compact commission may initiate legal action, in any state or federal court, to enforce the compact provisions, fees, practices, and programs against any person, including a non-member state or political subdivision. Member states that benefit from the compact commission, its employees, or one (1) of its provisions, by-laws, fees, findings, practices, or programs shall provide or share in the cost of legal services to defend or uphold them.
- (C) The compact commission shall have standing to intervene in any legal action that pertains to the subject matter of the compact and might affect its powers, duties, or actions.
- (D) The courts and executive in each member state shall enforce the compact and take all actions necessary and appropriate to effectuate its purposes and intent. Compact provisions, by-laws, and rules shall be received by all judges, departments, agencies, bodies, and officers of each member state and its political subdivisions as evidence of them.
- (E) The compact commission may require, from the date a compact fee was required to be paid, interest not to exceed the rate of one percent (1%) per month and a penalty not to exceed five percent (5%). The compact commission may, if it determines that any fees received by it were paid in error, and provided that an application for it is filed with the compact commission within one (1) year from the time the erroneous payment is made, correct the error by a refund, without interest, including from

1 other collected fees.

2 (F) The compact commission, if it determines that a payment or report is in error, may  
3 make a finding that fixes the correct amount of the fee. It must issue the finding  
4 within three (3) years from when a fee or report was due or filed. The finding shall  
5 be final and conclusive unless an application for a hearing is filed by the subject  
6 within thirty (30) days. The action of the compact commission in making a final  
7 finding, after a hearing, shall be reviewable in state court as provided in this  
8 compact.

## 9 ARTICLE XII

### 10 LEGAL ACTIONS AGAINST COMPACT

11 (A) Any person may commence a claim, action, or proceeding against the compact  
12 commission in state court for damages or to challenge a compact rule, fee, practice,  
13 or program that is duly applicable to that state. The compact commission shall have  
14 the benefit of the same limits of liability, defenses, rights to indemnity and defense  
15 by the state, and other legal rights and defenses for non-compact matters of the state  
16 racing commission in the state. All legal rights and defenses that arise from this  
17 compact shall also be available to the compact commission.

18 (B) A compact commissioner, alternate, or other member or employee of a state racing  
19 commission who undertakes compact activities or duties does so in the course of  
20 business of their state racing commission, and shall have the benefit of the same  
21 limits of liability, defenses, rights to indemnity and defense by the state, and other  
22 legal rights and defenses for noncompact matters of state employees in their state.  
23 The executive director and other employees of the compact commission shall have  
24 the benefit of these same legal rights and defenses of state employees in the  
25 member state in which they are primarily employed. All legal rights and defenses  
26 that arise from this compact shall also be available to them.

27 (C) Each member state shall be liable for and pay judgments filed against the compact

1 commission to the extent related to its participation in the compact. Where liability  
2 arises from action undertaken jointly with other member states, the liability shall be  
3 divided equally among the states for whom the applicable rule, fee, practice,  
4 program, or action or omission of the executive director or other employees of the  
5 compact commission was undertaken; and no member state shall contribute to or  
6 pay, or be jointly or severally or otherwise liable for, any part of any judgment  
7 beyond its share as determined in accordance with this article.

### 8 ARTICLE XIII

#### 9 RESTRICTIONS ON AUTHORITY

- 10 (A) Notwithstanding anything to the contrary herein, the compact commission shall not  
11 adopt any practice, program, or rule that may change Kentucky requirements  
12 governing the amount and distribution of the takeout, retention, or breakages on  
13 intrastate wagers or that imposes licensure requirements for non-racing or non-  
14 wagering employees of any racetrack or off-site wagering facility operating wholly  
15 within the state.
- 16 (B) Kentucky state laws applicable to pari-mutuel racing and wagering shall remain in  
17 full force and effect.
- 18 (C) Notwithstanding anything to the contrary herein, no fee except for services  
19 provided by the compact commission shall be adopted by the compact commission  
20 in Kentucky without the prior consent of any horsemen (as expressed by their  
21 recognized horsemen's organization) licensed by the state racing commission who,  
22 or any franchised or state racing commission licensed racing corporation that,  
23 would be obliged to pay the fee.

### 24 ARTICLE XIV

#### 25 CONSTRUCTION, SAVING AND SEVERABILITY

- 26 (A) This compact shall be liberally construed so as to effectuate its purposes. The  
27 provisions of this compact shall be severable and if any phrase, clause, sentence, or



1 provision of this compact is declared to be contrary to the Constitution of the  
2 United States or of any member state, or the applicability of this compact to any  
3 government, agency, person, or circumstance is held invalid, the validity of the  
4 remainder of this compact and its applicability to any government, agency, person,  
5 or circumstance shall not be affected. If all or some portion of this compact is held  
6 to be contrary to the constitution of any member state, the compact shall remain in  
7 full force and effect as to the remaining member states and in full force and effect  
8 as to the state affected as to all severable matters.

9 (B) In the event of any allegation, finding, or ruling against the compact or its  
10 procedures or actions, provided that a member state has followed the compact's  
11 stated procedures, any rule it purported to adopt using the procedures of this statute  
12 shall constitute a duly adopted and valid state rule, and any program that it  
13 purported to create or agree to using the procedures of this statute shall constitute a  
14 duly made and valid state program and multilateral agreement with the other  
15 consenting member states.

16 ➔Section 76. KRS 230.377 is amended to read as follows:

17 (1) Other provisions of the Kentucky Revised Statutes notwithstanding, a track may  
18 apply to the corporation~~[racing commission]~~ for simulcasting and intertrack  
19 wagering dates. Applications shall be submitted in accordance with KRS 230.300.  
20 The corporation~~[racing commission]~~ shall not approve the establishment or  
21 relocation of a receiving track within a radius of seventy-five (75) miles of a race  
22 track duly licensed as of July 15, 1992, without the prior written consent of the  
23 licensed track within whose seventy-five (75) mile radius the new receiving track  
24 would be located.

25 (2) On or before November 1 of each year, the corporation~~[racing commission]~~ shall  
26 meet and award intertrack wagering dates to all tracks for the entire succeeding  
27 calendar year. In a geographic area containing more than one (1) track within a fifty

- 1 (50) mile radius of another track, intertrack wagering, except for quarter horse

- 4 (3) The corporation~~[racing commission]~~ shall approve no more than nine (9) tracks for  
5 participation in horse racing, intertrack wagering, and simulcasting. Any approval  
6 by the corporation~~[racing commission]~~ of a change in location of these tracks shall  
7 be subject to the local-approval process contained in KRS 230.380.
- 8 (4) A track may by administrative regulation be required to simulcast its races to one  
9 (1) or more receiving tracks approved for simulcasting and intertrack wagering, as a  
10 prerequisite for the issuance of a license pursuant to KRS 230.300, provided that:
- 11 (a) Each track shall be permitted to exempt one (1) day of racing from  
12 simulcasting to both receiving tracks and simulcast facilities, at its discretion;
- 13 (b) Tracks in a county containing a city of the first class or a consolidated local  
14 government and tracks in an urban-county government shall not be required to  
15 simulcast to each other or to any other facility in those counties. This  
16 provision shall not be construed as requiring tracks within the same county to

- 18 (c) In the absence of a contract between a host track and a receiving track, the  
19 commission shall be split as provided for in KRS 230.378(3).
- 20 (5) A track may receive simulcasts and conduct interstate wagering thereon subject to  
21 the following limitations which shall be in addition to the limitations set forth in  
22 KRS 230.3771:
- 23 (a) A track licensed to conduct Thoroughbred racing may receive simulcasts and  
24 conduct interstate wagering on all Thoroughbred horse races designated as  
25 graded stakes races by the Graded Stakes Committee of the Thoroughbred  
26 Owners and Breeders Association, Inc., without further consents or approvals.
- 27 (b) A track licensed to conduct harness racing may receive simulcasts and

- 1           conduct interstate wagering on all harness horse races (both final and  
2           elimination) having a final purse in excess of seventy-five thousand dollars  
3           (\$75,000) without further consents or approvals.
- 4           (c) A track licensed to conduct quarter horse racing may receive simulcasts and  
5           conduct interstate wagering on all quarter horse races designated as graded  
6           stakes races by the graded stakes committee of the American Quarter Horse  
7           Association, without further consents or approvals.
- 8           (d) A track which applies to the corporation~~[racing commission]~~ to receive an  
9           interstate race of a different breed than the breed for which it is licensed by  
10          the corporation~~[racing commission]~~ shall receive any simulcast of an  
11          interstate race through the intertrack wagering system upon approval by the  
12          corporation~~[racing commission]~~. Notwithstanding the foregoing, a track  
13          licensed to conduct horse racing may receive simulcasts and conduct interstate  
14          wagering on quarter horse races, subject to the limitations of KRS 230.3771.
- 15          (e) A track may receive simulcasts of special event races conducted in other  
16          states or foreign countries which are determined by the corporation~~[racing  
17          commission]~~ to be of sufficient national or international significance or  
18          interest to warrant interstate wagering and if the simulcast of these races has  
19          been approved by the Kentucky Thoroughbred Owners and Breeders  
20          Association, Inc., the Kentucky Division of the Horseman's Benevolent and  
21          Protective Association, for Thoroughbred races, and the Kentucky Harness  
22          Horsemen's Association for harness racing, and any track conducting live  
23          horse races of the same breed at the same time as the simulcast race.
- 24          (f) A track may also receive simulcasts and conduct interstate wagering on  
25          Thoroughbred horse races other than those described in paragraphs (a) and (e)  
26          of this subsection if the simulcast of these races has been approved by the  
27          Kentucky Thoroughbred Owners and Breeders Association, Inc., and the

1 Kentucky Horsemen's Benevolent and Protective Association, for  
2 Thoroughbred races, and the Kentucky Harness Horsemen's Association, or  
3 its successor, for harness racing.

4 (g) The consent required by paragraph (f) of this subsection or by subsections  
5 (1)(g) and (2)(g) of KRS 230.3771 shall not be withheld:

- 6 1. For any reason not specifically related to financial harm to live horse  
7 racing; or
- 8 2. As a condition to the granting of any contractual or other concession not  
9 specifically related to the effects of interstate simulcasting on live horse  
10 racing in this Commonwealth, taken as a whole.

11 (h) A host track located in this state may receive simulcasting of not more than  
12 two (2) full cards of racing from another state, if both tracks race horses of the  
13 same breed and if:

- 14 1. The race date was previously granted by the Kentucky Horse Racing  
15 and Gaming Corporation~~Commission~~ to conduct live racing at the  
16 track located in this state;
- 17 2. Live racing was canceled due to weather conditions; and
- 18 3. The consent required by paragraph (e) of this subsection is obtained.

19 (i) The in-state track receiving the simulcast specified in paragraph (h) of this  
20 subsection shall offer that simulcast to all participating tracks and simulcast  
21 facilities in the intertrack wagering system.

22 (j) All interstate simulcasting shall be conducted in accordance with applicable  
23 federal laws.

24 (6) The corporation~~racing commission~~ may promulgate necessary and reasonable  
25 administrative regulations for the purpose of administering the conduct of intertrack  
26 or interstate wagering and regulating the conditions under which wagering shall be  
27 held and conducted. Administrative regulations shall provide for the prevention of

1 practices detrimental to the public interest and to impose penalties for violations.  
2 All administrative regulations shall be in conformity with the provisions of KRS  
3 Chapter 13A, KRS 138.510, and this chapter.

4 ➔Section 77. KRS 230.3771 is amended to read as follows:

- 5 (1) A Thoroughbred track licensed to conduct Thoroughbred racing may receive  
6 interstate simulcasts of Thoroughbred, quarter horse, paint horse, Appaloosa, and  
7 Arabian horse races, and conduct interstate wagering thereon, subject to the  
8 following limitations:
- 9 (a) A Thoroughbred receiving track may receive interstate simulcasts of  
10 Thoroughbred races and conduct interstate wagering thereon at any time of  
11 day and during any live Thoroughbred horse race meet conducted in the  
12 Commonwealth of Kentucky so long as the Thoroughbred receiving track

25 days awarded to the track in 1994 or one hundred percent (100%) of the  
26 number of races scheduled to be run by the track in 1993, if written approval  
27 is obtained from the Kentucky Horsemen's Benevolent and Protective

1 Association and the Kentucky Thoroughbred Owners and Breeders

3 (h) A separate accounting on all interstate simulcasting shall be submitted to the  
4 corporation~~[receiving commission]~~. The accounting shall be submitted in the  
5 same format and at the same time that the report for intertrack wagering is  
6 submitted.

7 (i) If the only simulcast or simulcasts a track participating as a host track makes  
8 available for interstate wagering through this state's intertrack wagering  
9 system on any race day are Thoroughbred horse races designated as graded  
10 stakes races by the Graded Stakes Committee of the Thoroughbred Owners  
11 and Breeders Association, Inc., then the commission of the receiving track on

3           (g) Notwithstanding paragraph (f) of this subsection, any harness track may apply  
4           for less than one hundred percent (100%) of the number of racing days  
5           awarded to the track in 1994 or one hundred percent (100%) of the number of  
6           races scheduled to be run by the track in 1993, if written approval is obtained  
7           from the Kentucky Harness Horsemen's Association, or its successor.

8           (h) A separate accounting on all interstate simulcasting shall be submitted to the  
9           corporation~~[racing commission]~~. This accounting shall be submitted in the  
10          same format and at the same time that the report for intertrack wagering is  
11          submitted.

12          (i) If the only simulcast or simulcasts a track participating as a harness host track  
13          makes available for interstate wagering through this state's intertrack  
14          wagering system on any race day are harness horse races (both final and  
15          elimination) having a final purse in excess of seventy-five thousand dollars  
16          (\$75,000), then the commission of the receiving track on these interstate  
17          wagers shall be split as prescribed by KRS 230.378(3); otherwise, the  
18          commission of the receiving track shall be split as prescribed by paragraph (j)  
19          of this subsection. Interstate simulcasts received by a harness host track under  
20          the conditions set forth in this paragraph shall not be subject to the conditions  
21          set forth in paragraphs (b), (c), (e), and (f) of this subsection.

22          (j) A receiving track's commission on interstate wagering, after deduction of  
23          applicable taxes and any amounts required to be paid by contract to the track  
24          from which the interstate simulcast originated, shall be split as follows:

- 25                1. Twenty-five percent (25%) to the receiving track where the interstate  
26                wagering occurs;
- 27                2. Twenty-five percent (25%) to the harness host track designated by

- 1 paragraphs (a) and (e) of this subsection. However, if no live meet is  
2 occurring, an additional twenty-five percent (25%) shall be retained by  
3 the receiving track where the interstate wagering occurs;
- 4 3. Twenty-five percent (25%) to the purse program of the receiving track  
5 where the interstate wagering occurs; and
- 6 4. Twenty-five percent (25%) to the purse program of the harness host  
7 track designated by paragraphs (a) and (e) of this subsection. However,  
8 if no live meet is occurring, an additional twenty-five percent (25%)  
9 shall be paid to the purse program of the receiving track where the  
10 interstate wagering occurs.
- 11 (k) A simulcast facility's commission on interstate wagering on harness races,  
12 after deduction of applicable taxes and any amount required to be paid by  
13 contract to the track from which the interstate simulcast originated, shall be  
14 split as provided in KRS 230.380(9).
- 15 (3) A harness track may only receive interstate simulcasts of Thoroughbred horse races  
16 and conduct interstate wagering thereon as provided in subsection (1)(b) of this  
17 section. A Thoroughbred track may only receive interstate simulcasts of harness  
18 horse races and conduct interstate wagering thereon as provided in subsection (2)(b)  
19 of this section. A simulcast facility may only receive interstate simulcasts of  
20 Thoroughbred and harness horse races and conduct interstate wagering thereon as  
21 provided in subsections (1)(b) and (2)(b) of this section.
- 22 (4) (a) A Thoroughbred track licensed to conduct horse racing may receive interstate  
23 simulcasts of quarter horse, paint horse, Appaloosa, and Arabian horse races  
24 and conduct interstate wagering thereon, subject to the limitations stated in  
25 paragraph (b) of this subsection.
- 26 (b) A receiving track's commission on interstate wagering, after deduction of  
27 applicable taxes and any amounts required to be paid by contract to the track

1 from which the interstate simulcast originated, shall be split as follows:

- 2 1. Twenty-five percent (25%) to the receiving track where the interstate  
3 wagering occurs;
- 4 2. Twenty-five percent (25%) to the host track; and
- 5 3. Fifty percent (50%) to the Kentucky quarter horse, paint horse,  
6 Appaloosa, and Arabian purse fund established by KRS 230.446 to  
7 supplement purses for quarter horse, paint horse, Appaloosa, and  
8 Arabian horse races in this state.

9 (5) (a) A harness track licensed to conduct horse racing may receive interstate  
10 simulcasts of quarter horse, paint horse, Appaloosa, and Arabian horse races  
11 and conduct interstate wagering thereon, subject to the limitations stated in  
12 paragraphs (b) and (c) of this subsection.

13 (b) A receiving track's commission on interstate wagering, after deduction of  
14 applicable taxes and any amounts required to be paid by contract to the track  
15 from which the interstate simulcast originated, shall be split as follows:

- 16 1. Twenty-five percent (25%) to the purse program of the receiving track;
- 17 2. Twenty-five percent (25%) to the purse program of the host track;
- 18 3. Twenty-five percent (25%) to the receiving track; and
- 19 4. Twenty-five percent (25%) to the host track.

20 (c) When a quarter horse, paint horse, Appaloosa, or Arabian horse race is run at  
21 a Kentucky race track, the commission to the Kentucky quarter horse, paint  
22 horse, Appaloosa, and Arabian purse fund established by KRS 230.446 shall  
23 be twenty-two percent (22%) from the host track's purse share.

24 (6) Other provisions of the Kentucky Revised Statutes notwithstanding, any track in a  
25 geographic area that contains more than one (1) track within a fifty (50) mile radius  
26 of any other track may only receive interstate simulcasts on racing of the same  
27 breed of horse as the track was licensed to race on or before July 15, 1998, except

1 any track may receive interstate simulcasts on quarter horse, paint horse,  
2 Appaloosa, or Arabian horse races.

3 ➔Section 78. KRS 230.3773 is amended to read as follows:

4 (1) As used in this section, "interstate common wagering pool" means a pari-mutuel  
5 pool established in one (1) horse racing jurisdiction that is combined with  
6 comparable pari-mutuel pools from at least one (1) horse racing jurisdiction for the  
7 purpose of establishing payoff prices in the various jurisdictions.

8 (2) Interstate wagers at a receiving track may form an interstate common wagering pool  
9 with wagers at a track in another jurisdiction, and the receiving track may adopt the  
10 commission and breakage rates of the track at which the race is being run. The  
11 corporation~~[racing commission]~~ may also approve types of wagering, distribution  
12 of winnings, and rules of racing for interstate common wagering pools that are  
13 different from those that normally apply in Kentucky.

14 (3) Wagers placed on any races run at track in Kentucky may be combined with wagers  
15 placed at tracks in other jurisdictions to form an interstate common wagering pool  
16 located either within or outside Kentucky.

17 (4) A track's participation in an interstate common wagering pool does not cause that  
18 track to be considered to be doing business in any jurisdiction other than the  
19 jurisdiction where the track is physically located. Excise taxes and commission  
20 rates may not be imposed on any interstate common wagering pool other than on  
21 amounts actually wagered in Kentucky. The combination of pari-mutuel pools as  
22 provided in this section constitutes the communication of wagering information for  
23 purposes of calculating odds and payoffs only and does not constitute the transfer of  
24 wagers in interstate commerce.

25 ➔Section 79. KRS 230.378 is amended to read as follows:

26 (1) A receiving track may accept wagers only at the track where it is licensed to  
27 conduct its race meeting or conduct intertrack wagering. A receiving track may

1 accept wagers through a telephone account wagering system. Wagers at a receiving  
2 track, simulcast facility, or on telephone account wagering shall form a common  
3 pool with wagers at a host track. This common pool requirement shall not apply to  
4 wagers made in connection with interstate simulcasting pursuant to KRS 230.3771;  
5 however, common pools shall be encouraged.

6 (2) Except as provided in KRS 230.3771(2), the commission of a receiving track,  
7 simulcast facility, or on telephone account wagering shall be the same as the

20 (5) A receiving track shall be exempt from any license fee imposed by statute or  
21 administrative regulation by the corporation~~[racing commission]~~.

22 ➔Section 80. KRS 230.379 is amended to read as follows:

23 (1) A track may engage in telephone account wagering, if all moneys used to place  
24 telephone account wagers are on deposit in an amount sufficient to cover the  
25 wagers at the track where the account is opened. All moneys wagered by telephone  
26 account wagering shall be subject to the applicable pari-mutuel tax levied in KRS  
27 138.510 and shall form a common pool with other pari-mutuel pools at the track for

1 each posted race. The corporation~~[racing commission]~~ shall have authority to  
2 promulgate necessary and reasonable administrative regulations to regulate the  
3 conduct of telephone account wagering, including regulations for the deposit of

12 (3) Telephone account wagering conducted in accordance with the provisions of this  
13 section shall not be considered a violation of KRS 528.110.

14 ➔Section 81. KRS 230.380 is amended to read as follows:

15 (1) Any track licensed by the corporation~~[racing commission]~~ to conduct horse racing  
16 and desiring to establish a simulcast facility shall apply for and may receive  
17 approval from the corporation~~[racing commission]~~ for each simulcast facility. Prior  
18 to considering an application for approval of a simulcast facility, the  
19 corporation~~[racing commission]~~ shall notify by regular mail, each state senator,  
20 state representative, county judge/executive, and mayor in the jurisdiction in which  
21 the proposed simulcast facility is located, at least ten (10) days in advance of the  
22 corporation~~[racing commission]~~ meeting at which the application is to be

- 1 (7) A simulcast facility shall not be subject to and shall not pay any excise tax imposed  
2 pursuant to KRS 138.510, or any license tax imposed under KRS 137.170.
- 3 (8) One percent (1%) of all moneys wagered at a simulcast facility shall be dedicated  
4 for local economic development and shall be allocated as follows:
- 5 (a) If a simulcast facility is located in an incorporated area, seventy-five percent  
6 (75%) shall be allocated to the governing body of the city in which the facility  
7 is located, and twenty-five percent (25%) to the governing body of the county  
8 in which the facility is located.
- 9 (b) If a simulcast facility is located in an unincorporated area, all moneys shall be

18          noncontiguous race track facility referenced in this subsection, unless there is a  
19          written agreement to the contrary between the track establishing the facility and the  
20          governing body of the local government jurisdiction in which the facility is to be

22          ➔Section 82. KRS 230.398 is amended to read as follows:

23          All sums reported and paid to the corporation~~[racing commission]~~ under the provisions  
24          of KRS 230.361 to 230.373 by any licensee conducting a harness race meeting shall be  
25          used by it for purses at harness racing events at county fairs within the Commonwealth of  
26          Kentucky that have been licensed and approved by it. The corporation may~~[racing~~  
27          ~~commission shall have the authority to]~~ promulgate administrative regulations~~[as may be~~

1 ~~necessary~~] for the conduct of these races.

2 ➔Section 83. KRS 230.400 is amended to read as follows:

- 3 (1) There is hereby created a trust and revolving fund for the Kentucky Horse Racing  
4 and Gaming Corporation~~[Commission]~~, designated as the Kentucky Thoroughbred  
5 development fund, consisting of money allocated to the fund under the provisions  
6 of KRS 138.510, together with other money contributed to or allocated to the fund

2 corporation~~[racing commission]~~ and compensation for these personnel shall

- 19 (6) (a) Kentucky Thoroughbred Owners and Breeders, Inc., is hereby recognized and  
20 designated as the sole official registrar of the Kentucky Thoroughbred  
21 development fund for the purposes of registering Kentucky Thoroughbred  
22 stallions and Kentucky-bred Thoroughbreds in accordance with the terms of  
23 this section and any administrative regulations promulgated by the Kentucky  
24 Horse Racing and Gaming Corporation~~[Commission]~~. When a Kentucky-  
25 bred Thoroughbred is registered with the official registrar, the registrar shall  
26 be authorized to stamp the Jockey Club certificate issued for the

- 1                   regular racetracks during races on said tracks;
- 2                   2.    Devices dispensing or selling combination or French pools on historical  
3                   races at licensed, regular racetracks as lawfully authorized by the  
4                   Kentucky Horse Racing and Gaming Corporation~~[Commission]~~;
- 5                   3.    Electro-mechanical pinball machines specially designed, constructed, set  
6                   up, and kept to be played for amusement only. Any pinball machine  
7                   shall be made to receive and react only to the deposit of coins during the  
8                   course of a game. The ultimate and only award given directly or  
9                   indirectly to any player for the attainment of a winning score or  
10                  combination on any pinball machine shall be the right to play one (1) or  
11                  more additional games immediately on the same device at no further  
12                  cost. The maximum number of free games that can be won, registered,

- 26                  6.    Devices used for wagering exempted from the application of this chapter  
27                  pursuant to KRS 436.480;

- 1           7.    Devices used in e-sports competitions; or
- 2           8.    Devices used in skill-based contests, provided such devices do not meet
- 3                 the definition of gambling devices in paragraph (a) of this subsection;
- 4   (8)   "Lottery and gift enterprise" means:
- 5       (a)   A gambling scheme in which:
- 6           1.   The players pay or agree to pay something of value for chances,
- 7                 represented and differentiated by numbers or by combinations of
- 8                 numbers or by some other media, one (1) or more of which are to be
- 9                 designated the winning ones;
- 10          2.   The ultimate winner is to be determined by a drawing or by some other
- 11                 method based upon the element of chance; and
- 12          3.   The holders of the winning chances are to receive something of value;
- 13                 and
- 14       (b)   A gift enterprise or referral sales plan which meets the elements of a lottery
- 15                 listed in paragraph (a) of this subsection is to be considered a lottery under
- 16                 this chapter;
- 17   (9)   "Mutuel" or "the numbers games" means a form of lottery in which the winning
- 18                 chances or plays are not determined upon the basis of a drawing or other act on the
- 19                 part of persons conducting or connected with the scheme, but upon the basis of the
- 20                 outcome or outcomes of a future contingent event or events otherwise unrelated to
- 21                 the particular scheme;
- 22   (10)  "Player" means a person who engages in any form of gambling solely as a
- 23                 contestant or bettor, without receiving or becoming entitled to receive any profit
- 24                 therefrom other than personal gambling winnings, and without otherwise rendering
- 25                 any material assistance to the establishment, conduct, or operation of the particular
- 26                 gambling activity. A person who engages in "bookmaking" as defined in subsection
- 27                 (2) of this section is not a "player." The status of a "player" shall be a defense to any

1 prosecution under this chapter;

2 (11) "Profiting from gambling activity" -- A person "profits from gambling activity"  
3 when, other than as a player, he or she accepts or receives or agrees to accept or  
4 receive money or other property pursuant to an agreement or understanding with  
5 any person whereby he or she participates or is to participate in the proceeds of  
6 gambling activity;

7 (12) "Simulated gambling program" means any method intended to be used by a person  
8 playing, participating, or interacting with an electronic device that may, through the  
9 application of any element of chance, either deliver money or property or an  
10 entitlement to receive money or property;

11 (13) "Skill" means the knowledge, dexterity, or any other ability or expertise of a natural  
12 person;

13 (14) "Skill-based contest" means a live, in-person competitive event among two (2) or  
14 more individuals or teams of individuals in which the ultimate winner is determined  
15 by skill and the competitive event does not utilize a gambling device; and

16 (15) (a) "Something of value" means any money or property, any token, object, or  
17 article exchangeable for money or property, or any form of credit or promise  
18 directly or indirectly contemplating transfer of money or property or of any  
19 interest therein, or involving extension of a service, entertainment, or a  
20 privilege of playing at a game or scheme without charge.

21 (b) "Something of value" does not include the award of a free, extended, or  
22 continuous play which is awarded as a prize for playing a game or scheme for  
23 a charge.

24 ➔Section 110. KRS 528.110 is amended to read as follows:

25 (1) Any person who, either for himself or as agent or employee of another, wagers  
26 money or anything of value on a horse race run or about to be run or advertised,  
27 posted, or reported as being run at any race track in or out of this state, or who

1 engages in the occupation of receiving, making, transmitting, or negotiating, either  
2 in person or by messenger, telephone, or telegraph, wagers on horse races run or  
3 about to be run or advertised, posted, or reported as being run or about to be run at  
4 any race track in or out of the state, shall, except in the case of wagers made within  
5 the enclosure of a race track licensed by the Kentucky Horse Racing and Gaming  
6 Corporation~~[Commission]~~ during an authorized race meeting at that track, or an  
7 enclosure during regular meetings in which running, trotting, or pacing races are  
8 being conducted by associations regularly organized for that purpose, be guilty of a  
9 Class A misdemeanor.

10 (2) In any prosecution under subsection (1) of this section, the state need not prove that  
11 the horse race upon which the wager was placed was actually run. Proof that the  
12 wager was made upon what purported to be or what was advertised, reported, or  
13 understood to be a horse race shall be sufficient to establish a prima facie case for  
14 the state.

15 ➔Section 111. The following KRS section is repealed:

17 ➔Section 112. By July 1, 2024, any records, files, or documents associated with  
18 functions previously performed for the Kentucky Horse Racing Commission by the  
19 Public Protection Cabinet, but for which that cabinet is no longer deemed responsible,  
20 shall be transferred to the Kentucky Horse Racing and Gaming Corporation.  
21 Additionally, the Public Protection Cabinet shall fully assist the Kentucky Horse Racing  
22 Commission in any reasonable way that will ensure a smooth agency transition process  
23 benefitting the public, licensees, and the corporation.

24 ➔Section 113. On July 1, 2024, the interim president of the Kentucky Horse  
25 Racing and Gaming Corporation shall be the executive director of the Kentucky Horse  
26 Racing Commission who was serving on January 1, 2024, and the interim president shall  
27 serve for two years. Thereafter, the president shall be appointed as authorized by this



1 Section 7 of this Act.

2 ➔Section 114. Between July 1, 2024, and July 1, 2025, the Department of  
3 Charitable Gaming shall not authorize additional locations for the play of electronic  
4 charity game tickets beyond the office location of the charitable organization, the location  
5 where the charitable organization is licensed to conduct bingo, and the location where  
6 pre-approved charitable fundraising events are authorized. This section shall not prevent  
7 electronic charity game ticket activities and electronic charity game ticket locations  
8 operating prior to July 1, 2024, from being resupplied or updated between July 1, 2024,  
9 and July 1, 2025.

10 ➔Section 115. By July 1, 2025, any records, files, or documents associated with

17 ➔Section 116. It is the intent of the General Assembly that the amendments to  
18 statutes in this Act to change the names of agencies and officers to effectuate the creation  
19 and authority of the Kentucky Horse Racing and Gaming Corporation shall not serve to  
20 void amendments in other bills enacted during the 2024 Regular Session, which are not in  
21 conflict with the reorganization effectuated by this Act and can be given effect and  
22 incorporated in a manner that will make the section intelligible, regardless of whether this  
23 Act is enacted before or after those other Acts.

24 ➔Section 117. Sections 3, 11, 13 to 28, 32, 34, 36, 37, 103, and 109 of this Act  
25 take effect July 1, 2025.

26 ➔Section 118. Whereas racing and gaming are crucial to the Commonwealth's  
27 economy, and strict regulation of racing and gaming is needed to prevent fraud and

1 criminal activity, an emergency is declared to exist, and Sections 1, 2, 4 to 10, 12, 29 to  
2 31, 33, 35, 38 to 102, 104 to 108, and 110 to 114 of this Act take effect July 1, 2024.
