

1 AN ACT relating to discriminatory practices by state agencies.

2 *Be it enacted by the General Assembly of the Commonwealth of Kentucky:*

3 ➔SECTION 1. A NEW SECTION OF KRS CHAPTER 344 IS CREATED TO
4 READ AS FOLLOWS:

5 *As used in Sections 1 and 2 of this Act:*

6 *(1) "Computer" means an electronic device that has the ability to store, retrieve, or*
7 *process information;*

8 *(2) "Digital identification" means any electronic process, procedure, or*
9 *documentation used to verify an individual's name, likeness, or other traits*
10 *unique to the individual;*

11 *(3) "Mobile device" means a portable device that has the capability to connect to the*
12 *Internet or communicate with other cellular devices;*

13 *(4) "Resident of the Commonwealth" means:*

14 *(a) An individual residing in the Commonwealth;*

15 *(b) A domestic business entity with a location in the Commonwealth;*

16 *(c) A foreign business entity registered with the Secretary of State;*

17 *(d) An individual that is employed and works at a location or locations within*
18 *the Commonwealth;*

19 *(e) An individual or business entity that owns real property within the*
20 *Commonwealth; or*

21 *(f) Any individual or business entity that has been authorized to act on behalf*
22 *of an individual or business entity defined in paragraphs (a) to (e) of this*
23 *subsection;*

24 *(5) "Social credit score" means a numeric or other designation assigned to an*
25 *individual based on his or her market behaviors, habits, or associations; and*

26 *(6) "State agency" means any department, commission, council, board, bureau,*
27 *committee, institution, legislative body, agency, government corporation, or other*

1 entity of the executive, judicial, or legislative branch of the state government.

2 ➔SECTION 2. A NEW SECTION OF KRS CHAPTER 344 IS CREATED TO
3 READ AS FOLLOWS:

4 (1) It is an unlawful practice for a state agency within the Commonwealth to:

5 (a) Require a resident of the Commonwealth to own, operate, or communicate
6 with any state agency using a mobile device, computer, or digital
7 identification in order to receive benefits or entitlements for which the
8 person would otherwise be eligible. An alternate method of communication
9 or validation shall be provided by the state agency;

10 (b) Deny a resident of the Commonwealth access to any state building, agency,
11 or department of the state that is responsible for providing benefits or
12 entitlements based on ownership of a mobile device, computer, or digital
13 identification. An alternate method of access shall be provided by the state
14 agency;

15 (c) Deny access to a court hearing based on ownership of a mobile device,
16 computer, or digital identification. An alternate method of access shall be
17 provided by the state agency;

18 (d) Utilize a social credit score system in order to:

19 1. Exclude a person from receiving benefits or entitlements for which he
20 or she would otherwise be eligible; or

21 2. Allow a person to receive benefits or entitlements for which he or she
22 would otherwise not be eligible; or

23 (e) Require exclusively credit or other electronic payment methods. A method
24 of accepting cash payments shall be required.

25 (2) Sections 1 and 2 of this Act shall be subject to KRS 344.450.

26 ➔Section 3. This Act may be cited as the Digital Identification Act.
