

1 AN ACT proposing an amendment to Section 54 of the Constitution of Kentucky.

2 ***Be it enacted by the General Assembly of the Commonwealth of Kentucky:***

3 ➔Section 1. Are you in favor of permitting the General Assembly to: (1) Place  
4 limits on the dollar amount potentially awarded in a lawsuit to recover noneconomic  
5 damages for injuries resulting in death; (2) Place limits on the dollar amount potentially  
6 awarded in a lawsuit to recover noneconomic damages for injuries to person or property;  
7 and (3) Create statutes of limitations or statutes of repose as to how long after the incident  
8 a lawsuit may be commenced, by amending the Constitution of Kentucky to read as  
9 proposed in Section 2 of this Act?

10 ➔Section 2. It is proposed that Section 54 of the Constitution of Kentucky be  
11 amended to read as follows:

12 The General Assembly shall have~~no~~ power to:

13 **(1) Limit the amount to be recovered *in noneconomic damages* for injuries**  
14 **resulting in death;~~;~~**

15 **(2) *Limit the amount to be recovered in noneconomic damages*~~;~~** for injuries  
16 to person or property; **and**

17 **(3) *Provide for a uniform statute of limitations or statutes of repose, or both,***  
18 ***for any civil action for injuries resulting in death or for injuries to persons or property.***

19 ➔Section 3. This amendment shall be submitted to the voters of the  
20 Commonwealth for their ratification or rejection at the time and in the manner provided  
21 for under Sections 256 and 257 of the Constitution and KRS 118.415 and under Sections  
22 4 and 5 of this Act.

23 ➔Section 4. Notwithstanding any language in KRS 118.415 to the contrary, the  
24 Secretary of State shall cause the entirety of the proposed amendment to the Constitution  
25 of Kentucky contained in Sections 1 and 2 of this Act to be published at least one time in  
26 a newspaper of general circulation published in this state, and shall also cause to be  
27 published at the same time and in the same manner the fact that the amendment will be

1 submitted to the voters for their acceptance or rejection at the next regular election at  
2 which members of the General Assembly are to be voted for. The publication required by  
3 this section and KRS 118.415 shall be made no later than the first Tuesday in August  
4 preceding the election at which the amendment is to be voted on.

5       ➔Section 5. Notwithstanding any language in KRS 118.415 to the contrary, the  
6 Secretary of State, not later than the second Monday after the second Tuesday in August  
7 preceding the next regular election at which members of the General Assembly are to be  
8 chosen in a year in which there is not an election for President and Vice President of the  
9 United States, or not later than the Thursday after the first Tuesday in September  
10 preceding a regular election in a year in which there is an election for President and Vice  
11 President of the United States, shall certify the entirety of the proposed amendment to the  
12 Constitution of Kentucky contained in Sections 1 and 2 of this Act to the county clerk of  
13 each county, and the county clerk shall have the entirety of the amendment, as so  
14 certified, indicated on the ballots provided to the voters in paper or electronic form as  
15 applicable to the voting machines in use in each county or precinct.
