

1 A JOINT RESOLUTION designating honorary names for various roads and
2 bridges.

3 WHEREAS, from time to time, the General Assembly has seen fit to honor various
4 Kentuckians by naming portions of state highways and erecting commemorative roadway
5 signs in their honor; and

6 WHEREAS, these Kentuckians have come from all walks of life, held a multitude
7 of jobs, and had a variety of accomplishments that made them deserving of the honor;
8 and

9 WHEREAS, these individuals have included former Governors, former members of
10 the General Assembly, decorated veterans, slain law enforcement officers, local elected
11 officials, astronauts, doctors, educators, distinguished athletes, and civic leaders; and

12 WHEREAS, every citizen of the Commonwealth owes a great debt of gratitude to
13 the patriotic men and women killed and wounded in service to their country in times of
14 great need; and

15 WHEREAS, the General Assembly has often honored the veterans of this state by
16 naming portions of several roads, from interstates to small two-lane country roads, in
17 their honor; and

18 WHEREAS, the General Assembly again sees fit to honor a group of individuals
19 who have made the lives of their fellow Kentuckians better and brought honor and
20 respect to the Commonwealth;

21 NOW, THEREFORE,

22 ***Be it resolved by the General Assembly of the Commonwealth of Kentucky:***

23 ➔Section 1. The Transportation Cabinet shall designate the portion of Kentucky
24 Route 293, within the city limits of Princeton, as the "Chief Deputy Jody Wayne Cash
25 Memorial Highway" and shall, within 30 days of the effective date of this Resolution,
26 erect appropriate signs denoting this designation.

27 ➔Section 2. The Transportation Cabinet shall designate the bridges on United

1 States Route 23, at mile point 11.272 (Bridge Numbers 58B00050L and 58B00050R) in
2 Johnson County, as the "Representative Hubert and Bea Collins Memorial Bridges" and
3 shall, within 30 days of the effective date of this Resolution, erect appropriate signs
4 denoting this designation.

5 ➔Section 3. The Transportation Cabinet shall designate Kentucky Route 371 in
6 Kenton County, from its intersection with Anderson Road to its intersection with Western
7 Reserve Road, as the "Michael Scott 'Bubba' Wilson Memorial Highway" and shall,
8 within 30 days of the effective date of this Resolution, erect appropriate signage denoting
9 this designation.

10 ➔Section 4. The Transportation Cabinet shall designate the portion of Kentucky
11 Route 49 in Marion County, from West Marion Elementary School (mile point 25.531)
12 north to Hughes Lane (mile point 26.253), as the "Tom Brahm Memorial Highway" and
13 shall, within 30 days of the effective date of this Resolution, erect appropriate signs
14 denoting this designation.

15 ➔Section 5. The Transportation Cabinet shall designate the bridge on Kentucky
16 Route 3091 crossing the Louie B. Nunn Cumberland Parkway in Pulaski County (Bridge
17 Number 100B00121N) as the "Reverend C.E. Jacobs Memorial Bridge," and shall, within
18 30 days of the effective date of this Resolution, erect appropriate signs denoting this
19 designation.

20 ➔Section 6. The Transportation Cabinet shall designate the bridge on United
21 States Route 27 in Pulaski County, crossing Pitman Creek (Bridge ID #100B00107L and
22 #100B00032R), as the "Jim and Mary Jo Sharpe Memorial Bridge" and shall, within 30
23 days of the effective date of this Resolution, erect signs denoting this designation.

24 ➔Section 7. The Transportation Cabinet shall honor the accomplishments of
25 Richie Weems and the Continental Five by including him on the Country Music Highway
26 on United States Highway 23 in Pike County, and shall, within 30 days of the effective
27 date of this Resolution, erect appropriate signs denoting this designation.

1 ➔Section 8. The Transportation Cabinet shall designate the portion of Kentucky
2 Route 292 in Martin County, from the intersection of KY-292 and KY-3213
3 (approximately mile point 26.1) to the intersection of KY-292 and KY-3 (mile point
4 28.9), as the "PFC Larry Gene Ratliff Memorial Highway" and shall, within 30 days of
5 the effective date of this Resolution, erect appropriate signs denoting this designation.

6 ➔Section 9. The Transportation Cabinet shall designate the portion of Kentucky
7 Route 2049 in Jefferson County, from its intersection with Kentucky Route 1934 to mile
8 point 1.7, as the "Cozy and Linnes Chester Memorial Highway" and shall, within 30 days
9 of the effective date of this Resolution, erect appropriate signs denoting this designation.

10 ➔Section 10. The Transportation Cabinet shall designate the bridge on Kentucky
11 Route 122 in Floyd County at mile point 23.334 (Bridge Number 036B00006N) as the
12 "L.G. Frazier Memorial Bridge" and shall, within 30 days of the effective date of this
13 Resolution, erect appropriate signs denoting this designation.

14 ➔Section 11. The Transportation Cabinet shall designate the bridge on Kentucky
15 Route 192 in Laurel County over the CSX Railroad at mile point 21.030 (Bridge Number
16 063B00098N) as the "Christopher Hubbard Memorial Bridge" and shall, within 30 days
17 of the effective date of this Resolution, erect appropriate signs denoting this designation.

18 ➔Section 12. The Transportation Cabinet shall designate the Mine Fork bridge on
19 Kentucky Route 1081 in Magoffin County at mile point 14.95 as the "Berry Caudill
20 Memorial Bridge" and shall, within 30 days of the effective date of this Resolution, erect
21 appropriate signs denoting this designation.

22 ➔Section 13. The Transportation Cabinet shall designate the Salyersville bridge
23 on Kentucky Route 7 in Magoffin County at mile point 25.055 as the "Julian Patrick
24 Memorial Bridge" and shall, within 30 days of the effective date of this Resolution, erect
25 appropriate signs denoting this designation.

26 ➔Section 14. The Transportation Cabinet shall designate the portion of Kentucky
27 Route 7 in Magoffin County, from mile point 1.08 to mile point 2.50, as the "Claude

1 Howard Memorial Highway" and shall, within 30 days of the effective date of this
2 Resolution, erect appropriate signs denoting this designation.

3 ➔Section 15. The Transportation Cabinet shall designate the portion of Kentucky
4 Route 2020 in Magoffin County, from mile point 0.00 to mile point 0.07, as the "Robert
5 Cheek Memorial Highway" and shall, within 30 days of the effective date of this
6 Resolution, erect appropriate signs denoting this designation.

7 ➔Section 16. The Transportation Cabinet shall designate the portion of Kentucky
8 Route 1593 in Magoffin County, from mile point 3.22 to mile point 3.63, as the "Oliver
9 Lykins Memorial Highway" and shall, within 30 days of the effective date of this
10 Resolution, erect appropriate signs denoting this designation.

11 ➔Section 17. The Transportation Cabinet shall designate the portion of Kentucky
12 Route 867 in Magoffin County, from mile point 3.28 to mile point 3.74, as the "Winford
13 Arnett Memorial Highway" and shall, within 30 days of the effective date of this
14 Resolution, erect appropriate signs denoting this designation.

15 ➔Section 18. The Transportation Cabinet shall designate the portion of Kentucky
16 Route 1471 in Magoffin County, from mile point 3.27 to mile point 4.16, as the "Henry
17 Bailey Memorial Highway" and shall, within 30 days of the effective date of this
18 Resolution, erect appropriate signs denoting this designation.

19 ➔Section 19. The Transportation Cabinet shall designate the portion of Kentucky
20 Route 1593 in Magoffin County, from mile point 2.157 to mile point 2.569, as the "Oval
21 Gray Amyx Memorial Highway" and shall, within 30 days of the effective date of this
22 Resolution, erect appropriate signs denoting this designation.

23 ➔Section 20. The Transportation Cabinet shall designate the bridge located at
24 Midway on Bull Creek, which goes over the Hal Rogers Parkway between the Hyden
25 Spur and the big bridge at Dryhill, in Leslie County as the "Amos and Twila Osborne
26 Memorial Bridge" and shall, within 30 days of the effective date of this Resolution, erect
27 appropriate signs denoting this designation.

1 ➔Section 21. The Transportation Cabinet shall honor the accomplishments of
2 Julie Reeves Davis by including her on the Country Music Highway on United States
3 Highway 23 in Boyd County near Ashland, and shall, within 30 days of the effective date
4 of this Resolution, erect appropriate signs denoting this designation.

5 ➔Section 22. The Transportation Cabinet shall designate the portion of Kentucky
6 Route 1 in Carter County, from United States Route 60 at mile point 10.646 to the
7 Interstate 64 overpass at mile point 11.546, as the "Assistant Fire Chief Duane Suttles
8 Memorial Highway" and shall, within 30 days of the effective date of this Resolution,
9 erect appropriate signs denoting this designation.

10 ➔Section 23. The Transportation Cabinet shall designate the bridge on Kentucky
11 Route 227, on the Owen-Carroll county line over Eagle Creek (Bridge #094B00029N), as
12 the "Staff Sergeant Christopher Stout Memorial Bridge" and shall, within 30 days of the
13 effective date of this Resolution, erect appropriate signs denoting this designation.
