1 A RESOLUTION adjourning the Senate in honor and loving memory of Robert 2 Collin Kratz, M.D. 3 WHEREAS, Dr. Robert Kratz was a graduate of the University of Cincinnati 4 Medical School and a proud World War II and Korean War veteran; and 5 WHEREAS, the pioneer of numerous surgical techniques that are in wide use today, 6 Dr. Robert Kratz was one of the early advocates for the founding of St. Luke Hospital in 7 Fort Thomas, Kentucky, and would become one of the first doctors in the world to 8 perform microscopic surgery on the head and neck; and 9 WHEREAS, Dr. Robert Kratz was a member of the American Laryngological, 10 Rhinological, and Ontological Society (Triological Society), an elite collective of the best 11 ear, nose, and throat doctors in the world; and 12 WHEREAS, Dr. Robert Kratz was a fellow of the American College of Surgeons 13 and a diplomat of the American College of Facial and Cosmetic Surgery, and he routinely 14 performed free surgeries for patients in Northern Kentucky and in other locales around 15 the world. He also started a community outreach program which provided free hearing 16 tests and counseling for hearing-impaired children; and 17 WHEREAS, Dr. Robert Kratz was a skilled pilot, an equestrian, an avid golfer, and 18 a talented athlete who had lettered in track and field and football at Withrow High 19 School; and 20 WHEREAS, Dr. Robert Kratz, beloved husband, father, and grandfather, departed 21 this earthly life on February 23, 2017, leaving his family, friends, and all those whose 22 lives he touched in solemn mourning; and 23 WHEREAS, Dr. Robert Kratz was preceded in death by his wife, Virginia 24 Daugherty Kratz, M.D.; parents, Florence Vanderhorst Kratz and J. Collin Kratz, D.O.; 25 and brother, Arthur W. Kratz, D.O. He is survived by his brother, Charles Kratz, D.O.; 26 son, Robert K.
