18	WHEREAS, in another instance, Larry Hurt opened a line of credit at a ladder
19	business for a longtime customer who owned a roofing company. The roofing company
20	expanded to another area in the state and was told by the ladder company that they
21	needed to go through a supplier in order to purchase necessary equipment. Larry Hurt did
22	not hesitate to help his longtime customer because that's the type of person he was; and
23	WHEREAS, in addition to serving his community, Larry Hurt proudly served his
24	country as a member of the United States Army. He was also a member of the Rizpah
25	Shriners and a faithful member of Scott's Grove Baptist Church; and
26	WHEREAS, on January 3, 2024, at the age of 88, Larry Hurt traversed these earthly
