1	A RESOLUTION honoring the extraordinary service of Senator Whitney H.
2	Westerfield to the Commonwealth of Kentucky upon the occasion of his retirement from
3	the General Assembly.
4	WHEREAS, born on November 29, 1980, in Hopkinsville, Kentucky, and a lifelong
5	resident of Christian County being raised with five brothers, Senator Whitney H.
6	Westerfield is known for his integrity and relentless work to protect unborn life,
7	strengthen families, create an environment for job growth, reduce income taxes, and
8	improve public safety through changes to strengthen the criminal justice system for both
9	offenders and victims; and
10	WHEREAS, Senator Whitney H. Westerfield graduated from Christian County
11	High School in 1999, earned a Bachelor of Science degree in communications from the
12	University of Kentucky in 2003, and earned his Juris Doctor degree from Southern
13	Illinois University School of Law in 2006; and
14	WHEREAS, Senator Whitney H. Westerfield has been an active member of the
15	Kentucky Bar Association since 2006 and the Tennessee Bar Association since 2012; and
16	WHEREAS, Senator Whitney H. Westerfield and his wife Amanda are the proud
17	parents of two precious children whom he fiercely loves and who mean more to him than
18	words can express; and
19	WHEREAS, Senator Whitney H. Westerfield was first elected to the Kentucky
20	Senate in 2012 to represent the citizens of Senate District 3 comprising Christian, Todd,
21	and Logan counties, and presently comprising Caldwell, Christian, and Muhlenberg
22	counties; and
23	WHEREAS, Senator Whitney H. Westerfield began his tenure as Chair of the
24	Senate Judiciary Committee on January 9, 2013, and continues to serve with distinction
25	in that position today; and
26	WHEREAS, Senator Whitney H. Westerfield was appointed Co-Chair of the

Unified Juvenile Code Task Force on April 24, 2013; and

WHEREAS, during the 2014 Regular Session of the General Assembly, Senator

2	Whitney H. Westerfield sponsored Senate Bill 200, reflecting the work of the Unified
3	Juvenile Code Task Force and bringing about the largest reform to Kentucky's juvenile
4	justice system in 30 years, serving as a beacon for other states to follow in the years that
5	followed; and
6	WHEREAS, Senator Whitney H. Westerfield has continued his commitment to
7	juvenile justice reform throughout his time in the Kentucky Senate, serving as Co-Chair
8	of the Juvenile Justice Oversight Council since its creation in 2014; and
9	WHEREAS, during the 2015 Regular Session of the General Assembly, Senator
10	Whitney H. Westerfield co-sponsored Senate Bill 192 relating to substance abuse
11	treatment, creating necessary offenses and penalties to respond to criminal behavior, and
12	establishing an evidence-based task force relating to addiction; and
13	WHEREAS, Senator Whitney H. Westerfield served as a member of the
14	Implementation Oversight Committee for Senate Bill 192 following its enactment from
15	June 2015 through April 2017; and
16	WHEREAS, Senator Whitney H. Westerfield continued his compassionate
17	commitment to address issues associated with substance abuse by sponsoring and
18	securing the passage of Senate Bill 90 during the 2022 Regular Session of the General
19	Assembly, establishing a pilot project in numerous counties to provide treatment in lieu
20	of incarceration upon meeting certain requirements; and
21	WHEREAS, Senator Whitney H. Westerfield, a stalwart advocate for the rights of
22	victims, sponsored Senate Bill 15 during the 2020 Regular Session of the General
23	Assembly proposing an amendment to the Constitution of Kentucky enshrining
24	fundamental rights for crime victims, a proposal resoundingly approved by the voters of
25	this Commonwealth; and
26	WHEREAS, Senator Whitney H. Westerfield served as Vice Chair of the Senate
27	Veterans, Military Affairs, and Public Protection Committee from 2013 to 2014, Co-

1 Chair of the Jail and Corrections Reform Task Force in 2020, and has faithfully served as 2 a member of many other committees, caucuses, and task forces, including his current 3 service as a member of the Commission on Race & Access to Opportunity, the 4 Agriculture Committee, the Natural Resources and Energy Committee, the Families and 5 Children Committee, and the Veterans, Military Affairs, and Public Protection 6 Committee; and 7 WHEREAS, in January 2021, Senator Whitney H. Westerfield was named as 8 national Co-Chairman of the National Conference of State Legislatures' Law, Criminal 9 Justice, and Public Safety Committee; and 10 WHEREAS, Senator Whitney H. Westerfield also served on the Hopkinsville 22 American Red Cross Advisory Committee and on the Board for the United Way of the 23 Pennyrile, as well as formerly serving as a member of the Board of Directors for the 24 Kentucky Association of Child Advocacy Centers; and 25 WHEREAS, Senator Whitney H. Westerfield has provided members of this 26 Chamber and all residents of Kentucky with a stunning array of views of the Kentucky 27 State Capitol campus and other areas of this Commonwealth through Flightdubs drone
