27 employees, and agents, and any other state or local entity or political subdivision that  
28 is responsible for providing information to the clerks of court"

32 On page 3, line 28, after "immunity" and before the period "." insert "available to public  
33 officials or public entities"

35 On page 4, delete lines 1 through 3 in their entirety

1 AMENDMENT NO. 22

2 On page 4, line 7, after "enforceable" delete the remainder of the line and delete line 8 in its  
3 entirety and insert "on March 1, 2024."

4 AMENDMENT NO. 23

5 On page 4, delete lines 9 through 17 in their entirety and insert the following:

6 "B. On or before August 1, 2024, the Louisiana Clerks' Remote Access  
7 Authority, or its duly authorized representative, shall submit a written report to the  
8 speaker of the House of Representatives, the president of the Senate, and the  
9 governor, which sets forth all of the following:

10 (1) Specific information detailing the progress made by it and the clerks of  
11 court towards compliance with the duties and obligations set forth in this Chapter.

12 (2) Specific information detailing any anticipated work to be completed to  
13 meet the duties and obligations set forth in this Chapter.

14 (3) Specific information detailing any anticipated dates that all remaining  
15 clerks of court are expected to be able to meet pursuant to the duties and obligations  
16 set forth in this Chapter.

17 C. Such written report shall be required to be submitted by the Louisiana  
18 Clerks' Remote Access Authority, or its duly authorized representative at least every  
19 one hundred and twenty days thereafter until such time as all clerks of court achieve  
20 compliance with the duties and obligations of this Chapter."

21 AMENDMENT NO. 24
