1 AMENDMENT NO. 1

2 On page 3, delete lines 19 through 30 in their entirety

3 AMENDMENT NO. 2

5 AMENDMENT NO. 3

6 On page 4, at the beginning of line 3, change "C." to "B."

7 AMENDMENT NO. 4

9 AMENDMENT NO. 5

10 On page 5, between lines 2 and 3, insert the following:

11 "C. The commissioner of administration shall review all existing leases for office and  
12 warehouse space and compare the rent per square foot of such space to the market rent of  
13 similar space in the same market. The commissioner of administration is authorized and  
14 directed to renegotiate all leases that are in excess of the market rent to bring the rent in line  
15 with the market rent. The commissioner of administration, upon approval of the Joint  
16 Legislative Committee on the Budget, shall have the authority to transfer between  
17 departments funds from any savings from renegotiated leases."

25 standards and shall have direct and unrestricted access to the commission, board, secretary,  
26 or equivalent head of the agency. The chief audit executive shall certify to the commission,  
27 board, secretary, or equivalent head of the agency that the internal audit function conforms  
28 to the Institute of Internal Auditors, International Standards for the Professional Practice of  
29 Internal Auditing."

35 event any one or more of House Bill Nos. 119, 218, 402, 549, 624, 629, 635, 779, 805,  
36 and 829 and House Concurrent Resolution No. 8 of the 2015 Regular Session of the

1 Louisiana Legislature are enacted into law" shall become effective in the event any one  
 2 or more of the bills listed in the supplementary budget recommendation are enacted into  
 3 law and in the event the official forecast for Fiscal Year 2015-2016 is revised to  
 4 incorporate State General Fund (Direct) revenues over and above the official forecast of  
 5 revenues available for appropriation on January 26, 2015.

6 (2) To the extent that additional revenues are available for appropriation, the  
 7 additional revenues shall be used to first fund the supplementary budget  
 8 recommendations to Higher Education, Board of Regents in the amount of \$573,591,363  
 9 and then shall be used to fund the supplementary budget recommendations to the  
 10 Department of Health and Hospitals, Medical Vendor Payments in the amount of  
 11 \$41,408,637.

12 (3) To the extent that additional revenues are available for appropriation above the  
 13 forecast amount required to satisfy the appropriation requirement in Paragraph (2) of this  
 14 Subsection, the additional revenues shall be used to fund the supplementary budget  
 15 recommendations to the departments and agencies as listed in Section 19 of this Act in  
 16 the manner and amounts designated in Section 19 of this Act.

17 (4) The commissioner of administration is authorized to adjust other means of  
 18 financing only to the extent necessary as a result of funding items contained herein from  
 19 any supplementary budget recommendation."

 26 in the total dollar value of contracts.

27 F. The commissioner of administration is hereby authorized and directed to reduce  
 28 the State General Fund (Direct) appropriations contained in each department and budget  
 29 unit contained in this Act, excluding for health care as contained in Schedule 09,  
 30 Department of Health and Hospitals, and for higher education as contained in Schedule  
 31 19, Higher Education and Louisiana State University Health Sciences Center Health  
 32 Care Services Division, to achieve a State General Fund (Direct) savings of at least  
 33 \$4,825,032 from a reduction based on historical differences between the budget authority  
 34 of each budget unit and the actual expenditures of the budget unit.

35 G. The commissioner of administration is hereby authorized and directed to reduce  
 36 the State General Fund (Direct) appropriations contained in each department and budget  
 37 unit contained in this Act, excluding for health care as contained in Schedule 09,  
 38 Department of Health and Hospitals, and for higher education as contained in Schedule  
 39 19, Higher Education and Louisiana State University Health Sciences Center Health  
 40 Care Services Division, to achieve a State General Fund (Direct) savings of at least  
 41 \$4,015,420 from the reduction of funding for vacant positions. The commissioner of  
 42 administration is hereby further authorized to reduce the authorized positions associated  
 43 with such funding."
