**HOUSE FLOOR AMENDMENTS**

2017 Second Extraordinary Session

Amendments proposed by Representative McFarland to Engrossed House Bill No. 1 by  
Representative Henry

1 AMENDMENT NO. 1

2 On page 12, delete lines 20 through 30 in their entirety and insert the following:

3 "E. The commissioner of administration is hereby authorized and directed to allocate up  
4 to \$17,900,775 in State General Fund (Direct) upon the approval of an employee  
5 compensation plan by the Civil Service Commission and the governor. The commissioner  
6 of administration is also authorized to adjust the other means of financing necessary to  
7 implement the approved plan. This authorization applies to the unclassified employees  
8 within this Act that are paid according to approved pay scales.

9 F. The commissioner of administration is authorized to require each budget unit to  
10 withhold a portion of the appropriation contained in this Act in the notification required  
11 under R.S. 39:57.1. Such withholdings shall be greater or equal to \$100,000,000 in  
12 aggregate. The commissioner of administration shall report the distribution of the  
13 withholdings to the Joint Legislative Committee on the Budget at its August meeting. The  
14 head of each agency or department is prohibited from expending or encumbering any  
15 withholdings until February 1, and then only if there has not been a budget status report  
16 presented to the Joint Legislative Committee on the Budget that indicates the total  
17 appropriation from the State General Fund (Direct) for Fiscal Year 2017-2018 will exceed  
18 the forecast for that fund or a budget status report that shows a deficit for State General Fund  
19 (Direct) at the close of the previous fiscal year. The monthly budget status report submitted  
20 to the Joint Legislative Committee on the Budget shall include a section reporting the  
21 amounts withheld."

12 "The commissioner of administration is hereby authorized and directed to adjust the means  
 13 of financing for Severe Combined Immunodeficiency screenings in the Payments to Public  
 14 Providers Program in this agency by reducing the appropriation out of the State General  
 15 Fund (Direct) by \$234,615 and the appropriation out of Federal Funds by \$405,360.

16 The commissioner of administration is hereby authorized and directed to adjust the means  
 17 of financing for the Payments to Private Providers Program in this agency by reducing the  
 18 appropriation out of the State General Fund (Direct) by \$146,458,245 and the appropriation  
 19 out of Federal Funds by \$537,101,241. Provided, further, that the department shall only  
 20 make twelve managed care checkwrites in Fiscal Year 2017-2018."
