1 AMENDMENT NO. 1

2 On page 1, line 4, after "531.1(B)," and before "571(A)(6)" insert "566.2(B),"

3 AMENDMENT NO. 24 On page 1, line 5, after "1300.32(A) and (B)(1)," and before "1308(A)(1)(b)," insert  
5 "1302(2),"6 AMENDMENT NO. 37 On page 2, line 10, after "voting machines;" and before "to provide for" insert "to provide  
8 relative to state board commissioners; to provide relative to the counting and tabulation of  
9 absentee by mail, early voting, and provisional ballots;"10 AMENDMENT NO. 4

11 On page 2, at the end of line 14, insert "566.2(B),"

18 On page 6, after line 26, insert the following:

19 "§566.2. Tabulation and counting of provisional ballots for federal office

20 \* \* \*

21 B. The parish board of election supervisors in each parish shall be  
22 responsible for the counting and tabulation of all provisional ballots for federal  
23 office. The board may utilize ~~absentee by mail and early voting~~ parish board  
24 commissioners to count the provisional ballots in the parish. If the board determines  
25 that ~~absentee by mail and early voting~~ parish board commissioners are necessary to  
26 count and tabulate the provisional ballots, it shall select ~~absentee by mail and early~~  
27 ~~voting~~ parish board commissioners in accordance with the provisions of R.S.  
28 18:1314(D). In a parish where no ~~absentee by mail and early voting~~ parish board  
29 commissioners are utilized during the counting and tabulation of absentee by mail  
30 and early voting ballots, the board may utilize commissioners to count the  
31 provisional ballots. The selection and compensation of such commissioners to count  
32 and tabulate provisional ballots shall be in the same manner as ~~absentee by mail and~~  
33 ~~early voting~~ parish board commissioners as provided for in R.S. 18:1314(D) and (E).

35 AMENDMENT NO. 8

36 On page 9, line 4, after "state." delete the remainder of the line and delete lines 5 and 6

1 AMENDMENT NO. 9

2 On page 9, line 10, after "presented to him for that purpose." and before "Each registrar"  
3 insert the following:

4 "If the final day for the registrar to certify the recall petition falls on a Saturday,  
5 Sunday, or legal holiday, then the next day which is not a Saturday, Sunday, or legal  
6 holiday shall be deemed to be the final day for certifying the recall petition."

7 AMENDMENT NO. 10

8 On page 11, between lines 13 and 14, insert the following:

9 "§1302. Definitions  
10 As used in this Chapter, unless the context clearly indicates otherwise, the  
11 following terms shall have the meanings hereafter ascribed to each:

13 (2) "Board" means the parish board of election supervisors of each parish.  
14 ~~If absentee by mail and early voting~~ parish board commissioners are utilized by the  
15 parish board of election supervisors to count and tabulate absentee ~~votes by mail and~~  
16 early voting ballots, the term "board" for the purposes of R.S. 18:1306, 1311, 1312,  
17 1313, 1315, and 1316 ~~may~~ shall also mean ~~absentee by mail and early voting~~ parish  
18 board commissioners.

20 AMENDMENT NO. 11

21 On page 12, line 21, after "each voted ballot" and before "as confidential" delete "that was  
22 transmitted electronically"
