2 On page 1, line 2, after "reenact" and before "relative" change "Children's Code Article  
3 312(B)," to "Children's Code Article 312(A) and (B)"

4 AMENDMENT NO. 2

5 On page 1, line 5, after "provide" and before "over" delete "an exception in certain parishes  
6 to the juvenile court's jurisdiction"

7 AMENDMENT NO. 3

8 On page 1, line 9, after "Section 1." change "Children's Code Article 312(B) is" to  
9 "Children's Code Article 312 (A) and (B) are"

10 AMENDMENT NO. 4

11 On page 1, delete lines 13 through 19 in there entirety and insert the following:

12 ~~"A. Except as provided in Paragraph B of this Article, a~~ A court exercising  
13 juvenile jurisdiction shall have exclusive original jurisdiction, in conformity with any  
14 special rules prescribed by law, to try an adult for the following offenses:

15 ~~(1) The crime of contributing to the delinquency of children as authorized~~  
16 ~~by R.S. 14:92, except R.S. 14:92(A)(7).~~

17 ~~(2) The crime of contributing to the delinquency or dependency of children~~

24 ~~B.(1) In East Baton Rouge Parish and Jefferson Parish, jurisdiction pursuant~~  
25 ~~to Subparagraphs (A)(1) and (3) of this Article is vested in the district court. Except~~  
26 ~~as provided in Subparagraph (2) of this Paragraph, a district court shall have~~  
27 ~~exclusive original jurisdiction, in conformity with any special rules prescribed by~~  
28 ~~law, to try an adult for the following offenses:~~
