Amendments proposed by House Committee on Transportation, Highways and Public Works  
to Original House Bill No. 527 by Representative Havard

1 AMENDMENT NO. 1

2 On page 1, at the end of line 3, change "216" to "217"

3 AMENDMENT NO. 2

4 On page 1, at the end of line 7, insert "to provide for requirements of transportation network  
5 company drivers;"

6 AMENDMENT NO. 3

7 On page 1, at the beginning of line 10, insert "audit procedures,"

8 AMENDMENT NO. 4

9 On page 2, line 7, change "216" to "217"

10 AMENDMENT NO. 5

11 On page 2, line 13, after "the" delete the remainder of the line and at the beginning of line  
12 14, delete "Development." and insert "Department of Agriculture and Forestry."

13 AMENDMENT NO. 6

14 On page 6, between lines 12 and 13, insert the following:

15 "B. The TNC or a third party shall conduct the background check and  
16 driving history research report set forth in Paragraphs (A)(2) and (A)(3) of this  
17 Section at least once every two years.

18 C. The TNC shall not authorize an individual to act as a TNC driver on its  
19 digital network if the driving history research report conducted when the individual  
20 first seeks access to the digital network reveals that the individual has had more than  
21 three moving violations in the prior three-year period."

22 AMENDMENT NO. 7

23 On page 6, delete lines 13 through 16 in their entirety and insert the following:

24 "D. The TNC shall not authorize an individual to act as a TNC driver on its  
25 digital network if the background check conducted when the individual first seeks  
26 access to the digital network or any subsequent background check reveals that  
27 individual:

28 (1) Has had one or more of the following violations in the prior three-year  
29 period:"

31 On page 6, line 27, after "license" and before the period "." insert "to operate a personal  
32 vehicle"

1 AMENDMENT NO. 9

2 On page 7, between lines 17 and 18, insert the following:

3 "§215. Audit Procedures; confidentiality of records4 A. For the sole purpose of verifying that a TNC is in compliance with the  
5 requirements of this Chapter and no more than annually, the department shall have  
6 the right to visually inspect a sample of records that the TNC is required to maintain.  
7 The sample shall be chosen randomly by the department in a manner agreeable to  
8 both parties. The audit shall take place at a mutually agreed location in the state.  
9 Any record furnished to the department may exclude information that would identify  
10 specific drivers or riders.11 B. In response to a specific complaint against any TNC driver or TNC, the  
12 department is authorized to inspect records held by the TNC that are necessary to  
13 investigate and resolve the complaint. The TNC and department shall endeavor to  
14 have the inspection take place at a mutually agreed location in the state. Any record  
15 furnished to the department may exclude information that would identify specific  
16 drivers or riders, unless the identity of a driver or rider is relevant to the complaint.17 C. Any records inspected by the department pursuant to this Section are  
18 designated confidential, are not subject to disclosure to a third party by the  
19 department without prior written consent of the TNC, and are exempt from  
20 disclosure under the Louisiana Public Records Law, R.S. 44:1, et seq. Nothing in  
21 this Section shall be construed as limiting the applicability of any other exemptions
