HOUSE FLOOR AMENDMENTS

Amendments proposed by Representative Leger to Engrossed House Bill No. 533 by Representative Kleckley

1 AMENDMENT NO. 1

2 On page 2, delete line 7 through 23 in their entirety and insert the following:

3 "(B) The treasurer is hereby authorized to establish a separate account within the
 4 fund for provider fees collected from each nursing facility according to law. Monies
 5 collected from the nursing facility provider fees, and the interest earned on those monies,
 6 shall be deposited into the account created for the nursing facility provider group.

7 "(C) The legislature is authorized to appropriate monies from the separate nursing
 8 facility account if the appropriation is eligible for federal financial participation under
 9 Title XIX of the Social Security Act, or its successor. The balance of the nursing facility
 10 account shall be appropriated for reimbursement of services to the nursing facility
 11 program."

12 AMENDMENT NO. 2

13 On page 2, line 24, change "(E)(1)" to "(D)(1)"

14 AMENDMENT NO. 3

15 On page 2, line 25, after "rates for" delete the remainder of the line and on line 26, delete
 16 "fund" and insert "the nursing facility program"

17 AMENDMENT NO. 4

18 On page 3, delete lines 7 and 8 in their entirety

19 AMENDMENT NO. 5

20 On page 3, line 9, change "(b)" to "(a)"

21 AMENDMENT NO. 6

22 On page 3, line 10, between "appropriations" and "for other" insert "and reimbursement"

23 AMENDMENT NO. 7

24 On page 3, at the end of line 10, change the period "." to a comma "," and insert "or its
 25 successor; and"

26 AMENDMENT NO. 8

27 On page 3, between lines 10 and 11, insert the following:

28 "(b)(i) If the legislature is in session, the reduction is consented to in writing by two-
 29 thirds of the elected members of each house in a manner provided by law; or

1 (ii) If the legislature is not in session, the reduction is approved by two-thirds of the
2 members of the Joint Legislative Committee on the Budget, or its successor.

3 Section 2. Be it further resolved by the Legislature of Louisiana, two thirds of the
4 members elected to each house concurring, that if the constitutional amendment proposed
5 by House Bill No. 532 of the 2013 Regular Session be approved by the electors of the state,
6 the Section of Article VII being added by this proposed amendment shall be designated as
7 Section 10.14 of Article VII of the Constitution of Louisiana."

8 AMENDMENT NO. 9

9 On page 3, at the beginning of line 11, change "Section 2." to "Section 3."

10 AMENDMENT NO. 10

11 On page 3, line 13, between "2014" and the period "." insert a comma "," and insert the
12 following:

13 "or the first statewide election occurring after the adoption of this Joint Resolution"

14 AMENDMENT NO. 11

15 On page 3, at the beginning of line 14, change "Section 3." to "Section 4."
