22 (1)(a) Twelve members shall be appointed by the governor from a
23 list of nominees submitted to the governor by the Louisiana Life Safety and
24 Security Association, the Louisiana Fire Sprinkler Association, and the
25 Louisiana Automatic Fire Alarm Association. Two members shall be
26 appointed by the governor, one of whom shall represent the major elevator
27 companies and one of whom shall represent those involved in the installation,
28 maintenance, and repair of elevators.
29 (b) The board shall consist of members representing all aspects of
30 life safety and property protection. Each of the technical endorsements shall
31 be represented by at least one board member licensed for such. Members
32 who have only a specialty endorsement may be appointed if all the technical
33 endorsements have representation.
34 (c) Any person appointed to the board shall be licensed pursuant to
35 this Subpart and shall have been engaged in life safety and property
36 protection contracting for a minimum of four years prior to his appointment,
37 except that ~~two~~ four members may be from an associate industry to life
38 safety and property protection for which no license is required but shall be
39 legally registered to do business in Louisiana.

2 D. ~~Five~~ Seven members of the board shall constitute a quorum for
3 the transaction of business. The board may take action by majority vote of
4 its members present and voting.
