29	A. There is hereby created in the state treasury, as a special fund, the Political
30	Subdivision Federal Grant Assistance Fund, hereafter referred to in this Section as
31	the "fund". After allocation of money to the Bond Security and Redemption Fund as
32	provided in Article VII, Section 9(B) of the Constitution of Louisiana, the treasurer
33	shall deposit in and credit to the fund all monies appropriated, transferred, or donated
34	for the fund. Monies in the fund shall be invested in the same manner as state general
35	fund monies and interest earned on investment of monies in the fund shall be
36	credited to the fund. Unexpended and unencumbered monies in the fund at the end
37	of the fiscal year shall remain in the fund.
38	B. Monies out of the fund shall be appropriated to the Division of
39	Administration via the process to adjust an agency's appropriation as provided for
40	in Section 2.A. of the Act that originated as House Bill No. 1 of the 2022 Regular
41	Session of the Legislature.
42	C. The fund shall be used for the administration of a program to assist
43	political subdivisions with competitive federal grant opportunities made pursuant to
44	the Infrastructure Investment and Jobs Acts (P.L. 117-58).
45	D. The program's guidelines shall be subject to approval by the Joint
46	Legislative Committee on the Budget.
47	Section 4.(A) Prior to June 30, 2022, the state treasurer is hereby authorized and
48	directed to transfer four hundred ninety-seven thousand two hundred sixty-six dollars from
