**1** AMENDMENT NO. 1**2** On page 1, line 2, after "(D)" and before the comma "," insert "and to repeal R.S.  
**3** 47:6030(C)(5)"**4** AMENDMENT NO. 2**5** On page 2, line 12, after "particular system" delete the comma "," delete the remainder of  
**6** the line, and insert the following:**7** "at a residence, regardless of the credit amount claimed, there shall be no additional  
**8** or subsequent tax credit authorized for installation of any equipment at that  
**9** residence"**10** AMENDMENT NO. 3**11** On page 2, line 18, after "shall be" delete the remainder of the line and delete lines 19 and  
**12** 20 in their entirety, and insert the following:**13** "subject to the following provisions:**14** (a) For a system purchased and installed on or after January 1, 2008, and  
**15** before July 1, 2015, the amount of the credit shall be equal to fifty percent of the first  
**16** twenty-five thousand dollars of the cost of the system.**17** (b) For a system purchased and installed on or after July 1, 2015, and before  
**18** January 1, 2018, the tax credit shall be equal to the lesser of:**19** (i) Two dollars multiplied by the total size of the system as measured in DC  
**20** watts;**21** (ii) Fifty percent of the cost of purchase and installation; or**22** (ii) Ten thousand dollars.**23** (c) There shall be no"**24** AMENDMENT NO. 4**25** On page 2, at the end of line 22, delete "December 31, 2017" and insert "on or after January  
**26** 1, 2018"**27** AMENDMENT NO. 5**28** On page 3, delete lines 12 and 13 in their entirety**29** AMENDMENT NO. 6**30** On page 3, at the beginning of line 16, delete "(b)" and insert "(a)"**31** AMENDMENT NO. 7**32** On page 3, at the beginning of line 18, delete "(c)" and insert "(b)"**33** AMENDMENT NO. 8**34** On page 4, delete line 15 in its entirety

22 and from the beginning of line 27, delete "Section 3." and insert the following:

23 "R.S. 47:6030(C)(5) is hereby repealed in its entirety.

24 Section 3. The provisions of this Act shall apply to any system installed on or after  
25 July 1, 2015.
