34	Section 2. R.S. 4:199 is hereby enacted to read as follows:
35	§199. Sports Wagering Purse Supplemental Fund; creation
36	A. There is hereby created in the state treasury a special fund to
37	be known as the Sports Wagering Supplemental Fund, hereafter
38	referred to in this Section as "fund".
39	<b>B.</b> Any appropriation by the legislature to the Louisiana State
40	Racing Commission from the fund shall be utilized to supplement purses
41	as provided in this Section.
42	C. Monies in the fund shall be invested by the state treasurer in
43	the same manner as monies in the state general fund. Interest earned on
44	the investments of monies in the fund shall be deposited in and credited

1	to the fund. Unexpended and unencumbered monies in the fund at the
2	end of the fiscal year shall remain in the fund.
3	<b>D.</b> Monies in the fund shall only be withdrawn pursuant to an
4	appropriation by the legislature solely to implement the provisions of
5	this Section.

7	appropriations received pursuant to R.S. 27:625(G)(4) as follows:
8	(1) Two-thirds of the funds appropriated to the commission
9	pursuant to this Paragraph shall be allocated and provided to the
10	licensed racing associations in the state which conduct live horse racing
11	<u>on the basis of the proportion of the number of thoroughbred race days</u>
12	each association conducted for the preceding year bears to the total
13	number of thoroughbred race days conducted statewide for the
14	preceding year, and such funds shall be used solely to supplement purses
15	in accordance with a schedule or formula established by the purse
16	committee of the Louisiana Thoroughbred Breeders Association on
17	Louisiana-bred thoroughbred races.
18	(2) One-third of the funds appropriated to the commission
19	pursuant to this Paragraph shall be allocated and provided to the
20	licensed racing associations in the state which conduct live horse racing
21	on the basis of the proportion of the number of quarter horse race days
22	each association conducted for the preceding year bears to the total
23	number of quarter horse race days conducted statewide for the
24	preceding year, and such funds shall be used solely to supplement purses
25	in accordance with a schedule or formula established by the purse
26	committee of the Louisiana Quarter Horse Breeders Association on
27	Louisiana-bred quarter horse races.
