10 **operations that satisfy the criteria for investment in prohibited nations**
11 **provided for in R.S. 39:100.151 including the issuer, and the name of the**
12 **investment.**

13 **(2) A detailed summary of the business operations in prohibited**
14 **nations of any company included on the list prepared pursuant to Paragraph**
15 **(1) of this Subsection.**

19 **"B. The treasurer, in compliance with Subsection A of this Section,**
20 **shall add or remove a nation from the list of prohibited nations as defined in**
21 **R.S. 39:100.150, if the United States Department of State adds or removes**
22 **that nation from the list of terror-sponsoring nations."**
