1 AMENDMENT NO. 1

2 On page 1, line 16, after "**Boundaries.**" delete the remainder of the line and delete line 17
 3 in its entirety and delete pages 2 through 24 in their entirety and on page 25, delete lines 1
 4 through 27 in their entirety and insert the following"

5 "A portion of the City of Baton Rouge, Louisiana, beginning at the point
 6 of intersection of north right-of-way line of Foss Street and east right-of-way
 7 line of Scenic Highway; thence northerly along the east right-of-way line of
 8 Scenic Highway to the intersection of the north boundary of Lot 1-A of the
 9 Grand-Odom Tract; thence southeasterly along the north boundary of said Lot
 10 1-A to the intersection of the northwest right-of-way line of Plank Road; thence
 11 northeasterly along the northwest right-of-way line of Plank Road to the
 12 intersection of the south boundary of Lot 1 of Bellevalle; thence continue
 13 northwesterly along the south boundary of said Lot 1 and Lot 13 of Bellevalle to
 14 the intersection of the west boundary of said Lot 13; thence continue northerly
 15 along the west boundary of said Lot 13 and across Bellvale Street to the
 16 intersection of the north right-of-way line of Bellvale Street; thence
 17 northwesterly along the north right-of-way line of Bellvale Street to the
 18 intersection of the east right-of-way line of Scenic Highway; thence northerly
 19 along the east right-of-way line of Scenic Highway to the intersection of the
 20 south right-of-way line of Cherry Street; thence northeasterly along the south
 21 right-of-way line of Cherry Street to the intersection of the east right-of-way
 22 line of Pocahontas Street; thence northerly along the east right-of-way line of
 23 Pocahontas Street to the intersection of the north boundary of Lot 18 of Suburb
 24 Istrouma, Block 3; thence continue easterly along the north boundary of Lot 18
 25 and 19 of Suburb Istrouma, Block 3 to the intersection of the west right-of-way
 26 of Interstate 110; thence turning approximately 66 degrees to the left and across
 27 Interstate 110 to the intersection of the east right-of-way of Interstate 110 and
 28 south boundary of Lot 3 Remnant of Ricaud; thence easterly along the south
 29 boundary of said Lot 3 Remnant to the intersection of the northwest
 30 right-of-way line of Plank Road; thence northeasterly along the northwest
 31 right-of-way line of Plank Road to the intersection of the south boundary of
 32 Tract H-1 of Suburb Istrouma, Block 7; thence westerly along the south
 33 boundary of said Tract H-1 to the intersection of the east right-of-way line of
 34 Hiawatha Street; thence northerly along the east right-of-way line of Hiawatha
 35 Street to the intersection of the south right-of-way line of Shawnee Street;
 36 thence easterly along the south right-of-way line of Shawnee Street a distance
 37 approximately 143 feet; thence turning approximately 71 degrees to the left and
 38 across Shawnee Street to the intersection of the north right-of-way line of
 39 Shawnee Street; thence easterly along the north right-of-way line of Shawnee
 40 Street to the intersection of the northwest right-of-way line of Plank Road;
 41 thence northeasterly along the northwest right-of-way line of Plank Road to the
 42 intersection of the south boundary of Lot 5-A of Suburb Istrouma, Block 14;
 43 thence westerly along south boundary of said Lot 5-A to the intersection of the
 44 west boundary of said Lot 5-A; thence continue northerly along the west
 45 boundary of Lots 5-A and 7-A of Suburb Istrouma, Block 14 to the intersection
 46 of the north boundary of said Lot 7-A; thence easterly along the north boundary
 47 of said Lot 7-A to the intersection of the west boundary of Lot 9 of Istrouma,
 48 Block 14; thence continue northeasterly along the west boundaries of Lots 9 and
 49 10 of Suburb Istrouma, Block 14 and across Madison Avenue to the intersection
 50 of the north right-of-way line of Madison Avenue; thence easterly along the

1 north right-of-way line of Madison Avenue to the intersection of the west
 2 boundary of Lot B of Suburb Istrouma, Block 15; thence northerly along the
 3 west boundary of said Lot B to the intersection of the intersection of the north
 4 boundary of said Lot B; thence easterly along the north boundary of Lot B to
 5 the intersection of the east boundary of Lot 7 of Suburb Istrouma, Block 15;
 6 thence northeasterly along the east boundary of said Lot 7 to the intersection
 7 of the south right-of-way line of Adams Avenue; thence turning approximately
 8 13 degrees to the right and across Adams Avenue to the intersection of north
 9 right-of-way line of Adams Avenue and southeast boundary Lot 10-A of Suburb
 10 Istrouma, Block 22; thence westerly along the north right-of-way line of Adams
 11 Avenue to the intersection of the west boundary of Lot 11 of Suburb Istrouma,
 12 Block 21; thence continue north along the west boundaries of Lots 11 and 10 of
 13 Suburb Istrouma, Block 21 to the intersection of the south boundary of Lot 14
 14 of Suburb Istrouma, Block 21; thence westerly along the south boundary of said
 15 Lot 14 to the intersection of the east right-of-way line of Hiawatha Street;
 16 thence continue northerly along the east right-of-way line of Hiawatha Street,
 17 across Monroe Avenue and CN Rail to the intersection of the centerline of
 18 Choctaw Drive; thence easterly along the centerline of Choctaw Drive a distance
 19 approximately 560 feet; thence turning approximately 92 degrees to the left and
 20 across Choctaw Drive to the intersection of the north right-of-way line of
 21 Choctaw Drive and east right-of-way line of Osceola Street; thence northerly
 22 along the east right-of-way line of Osceola Street to the intersection of the south
 23 right-of-way line of Seneca Street; thence easterly along the south right-of-way
 24 line of Seneca Street to the intersection of the west boundary of Lot 25 of
 25 Suburb Istrouma, Block 23; thence southerly, easterly and northerly along the
 26 west, south and east boundaries of said Lot 25 to the intersection of the south
 27 right-of-way line of Seneca Street; thence easterly along the south right-of-way
 28 line of Seneca Street a distance approximately 117 feet; thence turning
 29 approximately 86 degrees to the left and across Seneca Street to the intersection
 30 of the north right-of-way line of Seneca Street and east right-of-way line of
 31 Wenonah Street; thence northerly along the east right-of-way line of Wenonah
 32 Street to the intersection of the south right-of-way line of Iroquois Street; thence
 33 easterly along the south right-of-way line of Iroquois Street a distance
 34 approximately 129 feet; thence turning approximately 93 degrees to the left and
 35 across Iroquois Street to the intersection of the north right-of-way line of
 36 Iroquois Street and west boundary of Lot 9 of Suburb Istrouma, Block 34;
 37 thence continue northerly along the west boundaries of Lots 9 and 21 of Suburb
 38 Istrouma, Block 34 to the intersection of the south right-of-way line of
 39 Chippewa Street; thence easterly along the south right-of-way line of Chippewa
 40 Street a distance approximately 144 feet; thence turning approximately 87
 41 degrees to the left and across Chippewa Street to the intersection of the north
 42 right-of-way line of Chippewa Street and east right-of-way line of Canonicus
 43 Street; thence northerly along the east right-of-way line of Canonicus Street to
 44 the intersection of the north boundary of Lot 5 of Suburb Istrouma, Block 46;
 45 thence easterly along the north boundary of said Lot 5 to the intersection of the
 46 west boundary of Lot 10 of Suburb Istrouma, Block 46; thence continue
 47 northeasterly along the west boundaries of Lots 10, 11, 12, and 13 of Suburb
 48 Istrouma, Block 46 to the intersection of the south right-of-way line of Ontario
 49 Street; thence turning approximately 45 degrees to the right and across Ontario
 50 Street to the intersection of the north right-of-way line of Ontario Street and
 51 west boundary of Lot 12 of Suburb Istrouma, Block 60; thence northerly and
 52 easterly along the west and north boundaries of said Lot 12 to the intersection
 53 of the west boundary of Lot 17 of Suburb Istrouma, Block 60; thence continue
 54 northeasterly along the west boundaries of Lots 17, 18, 19 and 20 of Suburb
 55 Istrouma, Block 60, across Erie Street, along the west boundaries of Lots 5, 6,
 56 7, 8, 9, 10 and 11 of Suburb Istrouma, Block 61, across Huron Street and along
 57 the west boundaries of Lots 8, 9 and 10 of Suburb Istrouma, Block 108 to the
 58 intersection of the north boundary of Lot 10 of Suburb Istrouma, Block 108;
 59 thence easterly along the north boundary of said Lot 10 to the intersection of the

1 northwest right-of-way line of Plank Road; thence northeasterly along the
 2 northwest right-of-way line of Plank Road to the intersection of the south
 3 boundary of Lot 12 of Suburb Istrouma, Block 108; thence westerly,
 4 northeasterly and easterly along the south, northwest and north boundaries of
 5 said Lot 12 to the intersection of the northwest right-of-way line of Plank Road;
 6 thence northeasterly along the northwest right-of-way line of Plank Road to the
 7 intersection of the south right-of-way line of Winbourne Avenue; thence
 8 westerly along the south right-of-way line of Winbourne Avenue a distance
 9 approximately 201 feet; thence turning approximately 92 degrees to the right
 10 and across Winbourne Avenue to the intersection of the north right-of-way line
 11 of Winbourne Avenue and east right-of-way line of Geronimo Street; thence
 12 northerly along the east right-of-way line of Geronimo Street to the intersection
 13 of the north boundary of Lot 6 of Suburb Istrouma, Block 109; thence easterly
 14 along the north boundary of said Lot 6 to the intersection of the northwest
 15 boundary of Lot 10 of Suburb Istrouma, Block 109; thence northeasterly along
 16 the northwest boundaries of Lots 10, 11, 12, 13 and 14 of Suburb Istrouma,
 17 Block 109 to the intersection of the south right-of-way line of Ozark Street;
 18 thence turning approximately 6 degrees to the right and across Ozark Street to
 19 the intersection of the north right-of-way line of Ozark Street and west
 20 boundary of Lot B of Suburb Istrouma, Block 110; thence northerly and
 21 easterly along the west and north boundaries of said Lot B to the intersection
 22 of the northwest boundary of Lot 16 of Suburb Istrouma, Block 110; thence
 23 northeasterly along the northwest boundaries of Lots 16, 17, 18 and 19 of
 24 Suburb Istrouma, Block 110 to the intersection of the south right-of-way line of
 25 Calumet Street; thence turning approximately 4 degrees to the right and across
 26 Calumet Street to the intersection of the north right-of-way line of Calumet
 27 Street and west boundary of Lot 9-A of Suburb Istrouma, Block 114; thence
 28 easterly along the north right-of-way line of Calumet Street to the intersection
 29 of the west boundary of Lot 10-B of Suburb Istrouma, Block 114; thence
 30 northeasterly along the west boundary of said Lot 10-B to the intersection of the
 31 south boundary of Lot 11 of Suburb Istrouma, Block 114; thence westerly along
 32 the south boundary said Lot 11 to the intersection of the northwest boundary
 33 of said Lot 11; thence northeasterly along the northwest boundaries of Lots 11,
 34 12 and 13 of Suburb Istrouma, Block 114 to their intersection of the north
 35 boundary of said Lot 13; thence easterly along the north boundary of said Lot
 36 13 to the intersection of the northwest right-of-way line of Plank Road; thence
 37 northeasterly along the northwest right-of-way line of Plank Road to the
 38 intersection of the north right-of-way line of Navajo Street; thence westerly
 39 along the north right-of-way line of Navajo Street to the intersection of the west
 40 boundary of Lot 8-A of Suburb Istrouma, Block 113; thence northerly and
 41 easterly along the west and north boundaries of said Lot 8-A to the intersection
 42 of the northwest right-of-way line of Plank Road; thence northeasterly along the
 43 northwest right-of-way line of Plank Road to the intersection of the south
 44 boundary of Lot 12 of Suburb Istrouma, Block 113; thence westerly along the
 45 south boundary of said Lot 12 to the intersection of the southeast boundary of
 46 Lot 16 of Suburb Istrouma, Block 11; thence southwesterly and northerly along
 47 the southeast and west boundaries of said Lot 16 to the intersection of the south
 48 right-of-way line of Wyandotte Street; thence turning approximately 24 degrees
 49 to the left and across Wyandotte Street to the intersection of the north
 50 right-of-way line of Wyandotte Street and east right-of-way line of Keokuk
 51 Street; thence northerly along the east right-of-way line of Keokuk Street to the
 52 intersection of the north boundary of Lot 7 of Suburb Istrouma, Block 215;
 53 thence easterly along the north boundary of said Lot 7 to the intersection of the
 54 west boundary of Lot 12 Suburb Istrouma, Block 215; thence northerly and
 55 easterly along the west and north boundaries of said Lot 12 to the intersection
 56 of the northwest boundary of Lot 21 of Suburb Istrouma, Block 215; thence
 57 continue northeasterly along the northwest boundaries of Lot 21, 22 and 23 to
 58 the intersection of the south right-of-way line of Winnebago Street; thence
 59 turning approximately 7 degrees to the left continue northerly across

1 Winnebago Street to the intersection of the north right-of-way line of
 2 Winnebago Street and southeast right-of-way line of Lot 10 of Suburb
 3 Istrouma, Block 213; thence westerly along the north right-of-way line of
 4 Winnebago Street to the intersection of the east right-of-way line of Pawtucket
 5 Street; thence northerly along the east right-of-way line of Pawtucket Street to
 6 the intersection of the south right-of-way line of Weller Avenue; thence easterly
 7 along the south right-of-way line of Weller Avenue a distance approximately
 8 256 feet; thence turning approximately 90 degrees to the left and across Weller
 9 Avenue to the intersection of the north right-of-way line of Weller Avenue and
 10 east right-of-way line of Mayan Street; thence northerly along the east
 11 right-of-way line of Mayan Street to the south boundary of Lot 12 of Evergreen;
 12 thence continue easterly along the south boundary of Lots 12, 10, 8 and 6 of
 13 Evergreen to the intersection of the west boundary of Lot 4 of Evergreen;
 14 thence continue northeasterly along the northwest boundary of said Lot 4,
 15 across Pluskat Street and along the northwest boundary of Lot 3 of Evergreen
 16 to the intersection of the south boundary of Lot 35 of Dayton, Block 1; thence
 17 westerly, northerly and easterly along the south, west and north boundaries of
 18 said Lot 35 to the intersection of the west boundary of Lot 34 of Dayton, Block
 19 1; thence continue northerly along the west boundaries of Lots 34 and 33 of
 20 Dayton, Block 1 to the intersection of the south right-of-way line of Dayton
 21 Street; thence easterly along the south right-of-way line of Dayton Street a
 22 distance approximately 51 feet; thence turning approximately 90 degrees to the
 23 left and continue northerly across Dayton Street and along the west boundary
 24 of the west portion of Lot 36 of Dayton, Block 2 to the intersection of the north
 25 boundary of said west portion of Lot 36; thence easterly along the north
 26 boundaries of west portion of Lot 36 and east portion of Lot 36 to the
 27 intersection of the northwest right-of-way line of Plank Road; thence
 28 northeasterly along the northwest right-of-way line of Plank Road to the
 29 intersection of the south boundary of Lot 34-A of Dayton, Block 2; thence
 30 westerly and northerly along the south and west boundaries of said Lot 34-A to
 31 the intersection of the north boundary of said Lot 34-A; thence easterly along
 32 the north boundary of said Lot 34-A a distance approximately 75 feet; thence
 33 turning approximately 90 degrees to the left and across an unnamed alley to the
 34 intersection of the south and west boundaries of Lot 32 of Dayton, Block 3;
 35 thence continue northerly along the west boundaries of Lots 32, 31 and 30 to the
 36 intersection of the south right-of-way line of Sherwood Street; thence easterly
 37 along the south right-of-way line of Sherwood Street a distance approximately
 38 143 feet; thence turning approximately 90 degrees to the left and continue
 39 northerly across Sherwood Street and along the west boundary of Lot 36-A of
 40 Dayton, Block 4 to the intersection of the north boundary of said Lot 36-A;
 41 thence easterly along the north boundary of said Lot 36-A to the intersection of
 42 the northwest right-of-way line of Plank Road; thence northeasterly along the
 43 northwest right-of-way line of Plank Road to the intersection of the south
 44 right-of-way line of Shelley Street; thence turning approximately 19 degrees to
 45 the left and across Shelley Street to the intersection of the northwest
 46 right-of-way line of Plank Road and north right-of-way line of Shelley Street;
 47 thence westerly along the north right-of-way line of Shelley Street a distance
 48 approximately 117 feet; thence turning approximately 90 degrees to the right
 49 and across Lot 26-A of Delmont Place, Block 17 to the intersection of the north
 50 boundary of said Lot 26-A; thence westerly along the north boundary of said
 51 Lot 26-A to the intersection of the west boundary of Lot 22-A of Delmont, Block
 52 17; thence northerly along the west boundary of said Lot 22-A to the
 53 intersection of the south boundary of Lot 16 of Delmont, Block 17; thence
 54 westerly and northerly along the south and west boundaries of said Lot 16 to the
 55 intersection of the south right-of-way line of Evangeline Street; thence westerly
 56 along the south right-of-way line of Evangeline Street a distance approximately
 57 96 feet; thence turning approximately 88 degrees to the right and across
 58 Evangeline Street to the intersection of the north right-of-way line of Evangeline
 59 Street and west boundary of Lot 32 of Delmont Place, Block 16; thence

1 northerly along the west boundary of said Lot 32 to the intersection of the north
 2 boundary of said Lot 32; thence easterly along the north boundaries of Lots 32
 3 and 31 of Delmont Place, Block 16 to the intersection of the west boundary of
 4 Lot 14 of Delmont Place, Block 16; thence northerly along the west boundary
 5 of said Lot 14 to the intersection of the south right-of-way line of Byron Street;
 6 thence easterly along the south right-of-way line of Byron Street a distance
 7 approximately 342 feet; thence turning approximately 90 degrees to the left and
 8 continue northerly across Byron Street and along the west boundary of Lot 26
 9 of Delmont Place, Block 15; thence continue easterly along the north boundaries
 10 of Lots 26 and 23 of Delmont Place, Block 15 to the intersection of the east
 11 boundary of Lot 19 of Delmont Place, Block 15; thence northerly along the east
 12 boundary of Lot 19 to the intersection the south right-of-way line of Sycamore
 13 Street; thence continue northerly across Sycamore Street and the west
 14 boundary of Lot 26 of Delmont Place, Block 14 to the intersection of the south
 15 boundary of Lot 14 of Delmont Place, Block 14; thence continue westerly along
 16 the south boundaries of Lots 14 through 3 of Delmont Place, Block 14 to the
 17 intersection of the southeast right-of-way line of Longfellow Drive; thence
 18 northeasterly along the southeast right-of-way line of Longfellow Drive a
 19 distance approximately 755 feet; thence turning approximately 109 degrees to
 20 the left and continue westerly across Longfellow Drive and along the south
 21 boundary of Tract 6 of Delmont Place, Block 12 to the intersection of the east
 22 right-of-way line of Interstate 110; thence northeasterly along the east
 23 right-of-way line of Interstate 110 to the intersection of the north right-of-way
 24 line of Riley Street; thence continue easterly along the north right-of-way line
 25 of Riley Street and Longfellow Drive to the intersection of the southeast
 26 right-of-way line of Longfellow Drive; thence northeasterly along the southeast
 27 right-of-way line of Longfellow Drive to the intersection of the north boundary
 28 of Tract 7-B-1 of Delmont Place, Block 10; thence continue easterly along the
 29 north boundaries of said Tracts 7-B-1 and 7-B-2 of Delmont Place, Block 10 to
 30 the intersection of the west boundary of Lot 19 of Hollywood, Block 17; thence
 31 continue northerly along the west boundary of said Lot 19 and across
 32 Hollywood Street to the intersection of the north right-of-way line of Hollywood
 33 Street; thence easterly along the north right-of-way line of Hollywood Street to
 34 the intersection of the southeast boundary of Lot 29-A of Hollywood, Block 18;
 35 thence northeasterly, westerly and northerly along the southeast, northeast and
 36 east boundaries of said Lot 29-A to the intersection of the north boundary of
 37 Lot 26-A of Hollywood, Block 18; thence easterly along the north boundary of
 38 said Lot 26-A to the intersection of the west boundary of Lot 2 of Village Park;
 39 thence northerly along the west boundary of said Lot 2 to the intersection of the
 40 south right-of-way line of Amarillo Street; thence easterly along the south
 41 right-right-of-way line of Amarillo Street to the intersection of the east
 42 boundary of said Lot 2; thence turning approximately 95 degrees to the left and
 43 continue northerly across Amarillo Street to the intersection of the north
 44 right-of-way line of Amarillo Street and west boundary of Lot 10 of Village
 45 Park; thence continue northeasterly along the west boundaries of Lots 10 and
 46 13 of Village Park and across Vaughn Street to the intersection of the north
 47 right-of-way line of Vaughn Street; thence northwesterly along the north
 48 right-of-way line of Vaughn Street to the intersection of the west boundary of
 49 Lot 21 of Village Park; thence northeasterly along the west boundary of said
 50 Lot 21 to the intersection of the north boundary of said Lot 21; thence continue
 51 southeasterly along the north boundaries of Lots 21 and 22 of Village Park to
 52 the intersection of the west boundary of Lot 24-A of Village Park; thence
 53 northeasterly along the west boundary of said Lot 24-A to the intersection of the
 54 south right-of-way line of Greenwell Street; thence turning approximately 19
 55 degrees to the right and continue northeasterly across Greenwell Street to the
 56 intersection of the north right-of-way line of Greenwell Street and northwest
 57 right-of-way line of Plank Road; thence northeasterly along the northwest
 58 right-of-way line of Plank Road to the intersection of the south right-of-way line
 59 of J.H. Cooney Drive; thence westerly along the south right-of-way line of J.H.

1 Cooney Drive a distance approximately 665 feet; thence turning approximately
 2 90 degrees to the right and northerly across J.H. Cooney Drive to the
 3 intersection of the north right-of-way line of J.H. Cooney Drive and west
 4 boundary of Lot Y-1-A-2 of the J.H. Cooney Tract; thence continue northerly
 5 along the west boundaries of Lot Y-1-A-2 and Y-1-A-1-B of the J.H. Cooney
 6 Tract to the intersection of the north boundary of said Lot Y-1-A-1-B; thence
 7 continue easterly along the north boundaries of said Lot Y-1-A-1-B and Tract
 8 X of J.H. Cooney Tract tot the intersection of the northwest right-of-way line
 9 of Plank Road; thence northeasterly along the northwest right-of-way line of
 10 Plank Road to the intersection of the north right-of-way line of Cannon Street;
 11 thence westerly along the north right-of-way line of Cannon Street to the
 12 intersection of the west boundary of Lot 4-B of the J. Cannon Smith Tract;
 13 thence continue northerly along the west boundary of said Lot 4-B and across
 14 Vergie Street to the intersection of the right-of-way line of Vergie Street; thence
 15 easterly along the right-of-way line of Vergie Street to the intersection of the
 16 west boundary of Lot 6 of the Joseph Digerolamo Tract, Block 2; thence
 17 continue northeasterly along the west boundaries of Lots 6 through 1 of the
 18 Joseph Digerolamo Tract, Block 2, across Harriet Street and along the west
 19 boundaries of Lots 3, 2 and 1 of the Joseph Digerolamo Tract, Block 1 to the
 20 intersection of the southwest right-of-way line of Madison Avenue; thence
 21 northwesterly along the southwest right-of-way line of Madison Avenue to the
 22 intersection of the west boundary of the remainder of Lot 7-A of Beechnolia;
 23 thence continue northerly along the west boundary of the remainder of Lot 7-A,
 24 across Madison Avenue, Airline Highway (US 61), Monte Sano Avenue, and
 25 along the west boundaries of Lots A-1-A-3-A and A-1-A-1 of the Rosalie G.
 26 Moyse Tract to the intersection of the north boundary of said Lot A-1-A-1;
 27 thence easterly along the north boundary of said Lot A-1-A-1 to the west
 28 boundary of Lot B-3-A of the Rosalie G. Moyse Tract; thence northerly along
 29 the west boundary of said Lot B-3-A to the south right-of-way line of 72nd
 30 Avenue; thence easterly along the south right-of-way line of 72nd Avenue to the
 31 intersection of the northwest right-of-way line of Plank Road; thence
 32 northeasterly along the northwest right-of-way line of Plank Road to the
 33 intersection of the south boundary of Tract A-1-A-1-A-4-A of Howell
 34 Community Farms; thence continue westerly along the south boundaries of
 35 Tracts A-1-A-1-A-4-A and A-1-A-1-A-4-C of Howell Community Farms and

1 boundaries of said Lot 3-A to the intersection of the north right-of-way line of
 2 Chippewa Street; thence turning approximately 21 degrees to the left southerly
 3 across Chippewa Street and along the east boundary of Lot 3-B of Plank Road,
 4 Block 22 to the intersection of the south boundary of said Lot 3-B; thence
 5 westerly along the south boundary of said Lot 3-B to the intersection of the east
 6 boundary of Lot 2-B-1 of Plank Road, Block 22; thence continue southerly along
 7 the east boundaries of Lot 2-B-1 of Plank Road, Block 22, Lots 3-A and a
 8 combination of Lots 1, 2 and south portions of 5 and 6 of Pitchford-Ourso,
 9 Block 1 and across Iroquois Street to the intersection of the south right-of-way
 10 line of Iroquois Street; thence westerly along the south right-of-way line of
 11 Iroquois Street to the east boundary of Lot 6 of Pitchford-Ourso, Block 2;
 12 thence southerly along the east boundary of said Lot 6 to the intersection of the
 13 south boundary of said Lot 6; thence continue westerly along the south

 26 thence turning approximately 31 degrees to the left southeasterly to the
 27 intersection of the north boundary of the remainder of Lot 1 of Forest Park,
 28 Block 5 and west right-of-way line of Interstate 110; thence southerly along the
 29 west right-of-way line of Interstate 110 a distance approximately 712 feet;
 30 thence turning approximately 64 degrees to the right continue westerly across
 31 North 22nd Street, along the south boundary of Lot being a combination of Lots
 32 1, 2, 3, Alma Jenkins Property and Reine H. Guidry Property of the Mary L.
 33 Leblanc Tract, across Plank Road and along the north right-of-way line of Foss
 34 Street to the intersection of the east right-of-way line of Scenic Highway, being
 35 the point of beginning."
