

HOUSE COMMITTEE AMENDMENTS

2016 Regular Session

Amendments proposed by House Committee on Transportation, Highways, and Public Works to Reengrossed Senate Bill No. 227 by Senator Colomb

1 AMENDMENT NO. 1

2 On page 1, line 2, delete "R.S. 32:410(E)" and insert "R.S. 32:409.1(A)(2)(d)(ix) and 410(E)
3 and (F)"

4 AMENDMENT NO. 2

5 On page 1, line 5, delete "in compliance with the REAL ID Act of 2005" and after the semi-
6 colon ";" insert "to require applicants for either a driver's license or special identification
7 card to provide proof of Louisiana residency;"

8 AMENDMENT NO. 3

9 On page 1, line 6, after "of the REAL ID Act" delete the semi-colon ";" and insert " of 2005;
10 to require certain documents or photographs obtained in the process of applying for a driver's
11 license be retained or purged in certain circumstances;"

12 AMENDMENT NO. 4

13 On page 1, line 9, delete "R.S. 32:410(E) is" and insert "R.S. 32:409.1(A)(2)(d)(ix) and
14 410(E) and (F) are"

15 AMENDMENT NO. 5

16 On page 1, between lines 9 and 10, add the following:

17 "§409.1. Application or special certificate applications; penalties for false
18 information

21 (2) An applicant for a driver's license shall provide the following
22 information:
23 * * *
24 **(ix) Proof of Louisiana residency. Proof of residency shall include but**
25 **not be limited to paid receipts for utility bills and bank statements.**
26 * * *"

27 AMENDMENT NO. 6

28 On page 2, delete line 12 through 24 in their entirety and insert in lieu thereof the following:

29 **"(3) Any person applying for a driver's license pursuant to the**
30 **provisions of this Chapter, who elects not to apply for a driver's license that**
31 **complies with REAL ID standards, and who is otherwise eligible to be issued a**
32 **driver's license pursuant to the provisions of this Chapter, shall be issued a**
33 **driver's license which indicates the driver's license is not in compliance with**
34 **REAL ID. If the person has elected not to apply for a REAL ID compliant**
35 **driver's license, the department shall not require the applicant to comply with**
36 **any REAL ID requirements that were not required by the state as of January**
37 **1, 2016, or require the applicant to submit to a facial image capture in**
38 **connection with such application prior to determining if such applicant is**
39 **eligible to be issued a driver's license pursuant to the provisions of this Chapter.**

1 **If the person has elected not to apply for a REAL ID compliant driver's license,**
2 **the department shall not copy, scan, maintain, or share a copy of the applicant's**
3 **documents proving his identity. This includes but is not limited to the**
4 **applicant's birth certificate, social security card, or United States issued**
5 **passport."**

6 AMENDMENT NO. 7

7 On page 3, delete lines 2 through 7 in their entirety and insert in lieu thereof the following:

8 **"(b) The department shall provide each applicant for a driver's license**
9 **a printed document that includes the following information:**

10 **(i) The documents that an applicant is required to provide to**
11 **obtain a REAL ID compliant driver's license, and the documents an**
12 **applicant is required to provide to obtain a driver's license that is not**
13 **REAL ID compliant.**

14 **(ii) The purposes for which a REAL ID compliant driver's license**
15 **may be utilized, and the purposes for which a driver's license that is not**
16 **REAL ID compliant may be utilized.**

17 **(iii) The electronic technology incorporated into a REAL ID**
18 **compliant driver's license, and the electronic technology incorporated**
19 **into a driver's license that is not REAL ID compliant."**

20 AMENDMENT NO. 8

21 On page 3, line 17, after "issued" insert "such driver's license at the cost of"

22 AMENDMENT NO. 9

23 On page 3, between lines 17 and 18 insert the following:

24 **"(7) Upon the request of any applicant for a driver's license, the**
25 **department shall record and retain the applicant's name, date of birth,**
26 **certificate numbers, date filed, and issuing agency in lieu of retaining an image**
27 **or copy of the applicant's birth certificate."**

28 AMENDMENT NO. 10

29 On page 3, at the beginning of line 18, change "(7)" to "(8)"

30 AMENDMENT NO. 11

31 On page 3, between lines 22 and 23, insert the following:

32 **""F.(1) Upon request of any person, any personal identifying source**
33 **documents or photographs of such person obtained by the department or a**
34 **contractor in the process of a person applying for or renewing a driver's license**
35 **between July 7, 2008, and the effective date of this Subsection that were not**
36 **required by state law to be captured by the department or a contractor as of**
37 **July 7, 2008, shall be disposed of as follows:**

38 **(a) Personal identifying source documents shall be removed and**
39 **purged from department and contractor databases and systems.**

40 **(b) All photographs of persons obtained by the department**
41 **which are in the possession of a contractor shall be purged from the**
42 **database or system of that contractor.**

43 **(2) As used in this Subsection, the following terms shall mean and**
44 **include:**

45 **(a) "Contractor" shall mean and include any contractor of the**
46 **department, any affiliate or subsidiary of such contractor, and any**

1 subcontractor of such contractor or any affiliate or subsidiary of such
2 subcontractor.

3 (b) "Personal identifying source documents" shall mean and include
4 any document provided by any person to prove his identity or residence. It
5 shall include all copies, scans, or digital images of such documents.

6 (c) "Photographs" shall mean and include any captured image, digital
7 or otherwise, of a person's face. It shall include all copies, scans, or digital
8 images of such image."

9 AMENDMENT NO. 12

10 On page 4, delete lines 18 through 26 in their entirety and on line 27, delete "of January 1,
11 2016." and insert in lieu thereof the following:

12 "(3) Any person applying for a special identification card pursuant to
13 the provisions of this Section who elects not to apply for a special identification
14 card that complies with REAL ID standards and who is otherwise eligible to be
15 issued a special identification card pursuant to the provisions of this Section
16 shall be issued a special identification card which indicates the special
17 identification card is not in compliance with REAL ID. If the person has elected
18 not to apply for a REAL ID compliant special identification card, the
19 department shall not require the applicant to comply with any REAL ID
20 requirements that were not required by the state as of January 1, 2016."

21 AMENDMENT NO. 13

22 On page 5, delete lines 10 through 16 in their entirety, and insert in lieu thereof the
23 following:

24 "(b) The department shall provide each applicant for a special
25 identification card a printed document that includes the following information:

26 (i) The documents that are required to be provided by the applicant to
27 obtain a REAL ID compliant special identification card, and the documents that
28 are required to be provided by the applicant to obtain a special identification
29 card that is not REAL ID compliant.

30 (ii) The purposes for which a REAL ID compliant special identification
31 card may be utilized and the purposes for which a special identification card
32 that is not REAL ID compliant may be utilized.

33 (iii) The electronic technology incorporated into a REAL ID compliant
34 special identification card and the electronic technology incorporated into a
35 special identification card that is not REAL ID compliant."
