HOUSE FLOOR AMENDMENTS

Amendments proposed by Representative Mike Johnson to Reengrossed Senate Bill No. 227
by Senator Colomb

1 AMENDMENT NO. 1

2 On page 1, line 2, delete "R.S. 40:1321(O)" and insert "R.S. 40:1321(O) and (P)"

3 AMENDMENT NO. 2

4 In Amendment No. 3 by the House Committee on Transportation, Highways and Public
5 Works (#4466), on page 1, delete line 11 in its entirety and insert in lieu thereof "license or
6 special identification card be disposed of in certain circumstances;"

7 AMENDMENT NO. 3

8 On page 3, at the end of line 1, insert the following:

9 **"Additionally, each applicant shall indicate receipt of the printed**
10 **document required by Subparagraph (b) of this Paragraph on the application**
11 **for a driver's license."**

12 AMENDMENT NO. 4

13 On page 3, delete lines 18 through 22 and in lieu thereof insert the following:

14 **"(8) The department shall not participate in any programs that**
15 **exchange or allow the access of facial biometric data of Louisiana citizens**
16 **obtained in the issuance or renewal of a Louisiana driver's license to the**
17 **agencies, governments, or contractors of other states or nations without a**
18 **warrant or a court order issued for access to that data."**

19 AMENDMENT NO. 5

20 Delete House Amendment No. 10 by the House Committee on Transportation, Highways
21 and Public Works (#4466)

22 AMENDMENT NO. 6

23 On page 3, line 23, delete ""R.S. 40:1321(O) is" and insert "R.S. 40:1321(O) and (P) are"

24 AMENDMENT NO. 7

25 In Amendment No. 12 by the House Committee on Transportation, Highways and Public
26 Works (#4466), on page 3, at the end of line 20, delete the period "." and insert a comma ","
27 and the following:

28 **", or require the applicant to submit to a facial image capture in**
29 **connection with such application prior to determining if such applicant is**
30 **eligible to be issued a special identification card. If the person has elected not**
31 **to apply for a REAL ID compliant special identification card, the department**

1 shall not copy, scan, maintain, or share a copy of the applicant's documents
 2 proving his identity obtained from any person in the process of applying for the
 3 issuance or renewal of a special identification card. Documents proving identity
 4 shall include but not be limited to the applicant's birth certificate, social
 5 security card, or United States issued passport. "

6 AMENDMENT NO. 8

7 On page 5, at the end of line 9, insert the following:

8 "Additionally, each applicant shall indicate receipt of the printed
 9 document required by Subparagraph (b) of this Paragraph on the application
 10 for a special identification card."

11 AMENDMENT NO. 9

12 On page 5, delete lines 28 and 29 in their entirety and on page 6, delete lines 1 and 2 in their
 13 entirety and insert the following:

14 "(7) Upon the request of any applicant for a special identification card,
 15 the department shall record and retain the applicant's name, date of birth,
 16 certificate numbers, date filed, and issuing agency in lieu of retaining an image
 17 or copy of the applicant's birth certificate.

18 (8) The department shall not participate in any programs that exchange
 19 or allow the access of facial biometric data of Louisiana citizens obtained in the
 20 issuance or renewal of a Louisiana special identification card to the agencies,
 21 governments, or contractors of other states or nations without a warrant or a
 22 court order issued for access to that data.

23 P. (1) Upon the request of any person, any personal identifying source
 24 documents or photographs of such person obtained by the department or a
 25 contractor in the process of a person applying for or renewing a special
 26 identification card between July 7, 2008, and the effective date of this
 27 Subsection that were not required by state law to be captured by the
 28 department or a contractor as of July 7, 2008, shall be disposed of as follows:

29 (a) Personal identifying source documents shall be removed and purged
 30 from department and contractor databases and systems.

31 (b) All photographs of persons obtained by the department which are
 32 in the possession of a contractor shall be purged from the database or system
 33 of that contractor.

34 (2) As used in this Subsection, the following terms shall mean and
 35 include:

36 (a) "Contractor" shall mean and include any contractor of the
 37 department or any affiliate or subsidiary of such contractor and any
 38 subcontractor of such contractor or any affiliate or subsidiary of such
 39 subcontractor.

40 (b) "Personal identifying source documents" shall mean and include
 41 any document provided by any person to prove his identity or residence. It
 42 shall include all copies, scans, or digital images of such documents.

43 (c) "Photographs" shall mean and include any captured image, digital
 44 or otherwise, of a person's face. It shall include all copies, scans, or digital
 45 images of such image."
