Amendments proposed by House Committee on Education to Reengrossed Senate Bill No. 336 by Senator Appel

1 AMENDMENT NO. 1

2 On page 4, at the beginning of line 1, change "**B.(1)**" to "**B.(1)(a)**"

3 AMENDMENT NO. 2

4 On page 4, between lines 8 and 9, insert the following:

5 **"(b) The department may review textbooks and other instructional**
 6 **materials at such times as it deems necessary and appropriate but shall review**
 7 **textbooks and other instructional materials in the core subject areas of English**
 8 **language arts, mathematics, science, and social studies at least every six years."**

9 AMENDMENT NO. 3

10 On page 4, line 20, after "**composed of**" delete the remainder of the line and insert
 11 "**Louisiana public school educators and Louisiana content**"

12 AMENDMENT NO. 4

13 On page 5, at the end of line 2, insert "**Publishers and content providers shall be given the**
 14 **opportunity to review any evaluation prior to its posting online and shall be given at**
 15 **least thirty days to respond and make any correction to the content that they deem**
 16 **necessary.**"

17 AMENDMENT NO. 5

18 On page 5, line 6, between "**all**" and "**textbooks**" insert "**printed**"

19 AMENDMENT NO. 6

20 On page 5, line 8, between "**Accessibility**" and "**and can**" change "**Standards**" to
 21 "**Standard, is consistent with the Individuals With Disabilities Education Act,**"

22 AMENDMENT NO. 7

23 On page 6, line 1, after "**by**" delete the remainder of the line and delete line 2 and insert "**the**
 24 **policies of the governing authority of such school or school district.**"

25 AMENDMENT NO. 8

26 On page 6, line 11, after "**composed of**" delete the remainder of the line and insert "**teachers**
 27 **and educators, all of whom shall be employees of Louisiana public schools, parents of**
 28 **students enrolled in Louisiana public schools, and other**"

29 AMENDMENT NO. 9

30 On page 6, line 12, after "**stakeholders**" and before "**who**" insert "**in Louisiana**"

2 On page 7, line 7, after "**feasible**" change the period "." to a comma "," and insert "**and**
3 **through the central depository.**"

5 On page 7, line 10, between "**contract,**" and "**through a school**" insert "**through the central**

7 AMENDMENT NO. 12

8 On page 7, line 10, after "**cooperative**" delete the comma ","

9 AMENDMENT NO. 13

10 On page 7, between lines 22 and 23, insert the following:

11 **"(c) Require the publisher or other content provider to make textbooks**
12 **and other instructional materials available for purchase through the central**
