Authorizes higher education employees who are veterans to take paid leave on Veterans' Day to attend certain events

Present law requires each institution of higher education to designate a maximum of 14 legal holidays per calendar year to be observed by its employees.

Proposed law requires the institution to allow employees who are veterans as defined by R.S. 29:251.2 to attend events related to Veterans' Day with compensation for no more than four hours when such activities occur on a regularly scheduled workday.
