PUBLIC CONTRACTS RE SEE FISC NOTE GF EX See Note Page 1 of 1
Requires prior approval of the Joint Legislative Committee on the Budget of requests for proposals and contracts over a specific dollar amount

Proposed bill provides for any request for proposals for professional, personal, consulting or social services contracts with a total maximum compensation of \$100 million or more shall be reviewed and approved by the Joint Legislative Committee on the Budget (JLCB) on or after August 1, 2014 unless it has been reviewed and approved by the JLCB. Proposed bill provides that any request for proposals for professional, personal, consulting or social services contracts with a total maximum compensation of \$100 million or more for a contract that must be approved by DHH, CMS shall be reviewed by the Joint Legislative Committee on the Budget prior to the advertisement of the request for proposal. Proposed bill provides that no request for proposals or contracts for professional, personal, consulting or social services shall be divided into multiple proposals in order to circumvent the requirements of this legislation. Proposed bill provides that any amended contract entered into with the same party for the same purpose as an existing contract which causes payment to exceed \$100 million in a one-year period shall be reviewed and approved by the Joint Legislative Committee on the Budget.
