Provides for the Recovery School District to return certain unused facilities and programs to the original school board under certain circumstances. (gov sig)

The proposed legislation requires the Recovery School District (RSD) to submit a report on the current status of all school facilities transferred to the RSD's jurisdiction to BESE, the school system that originally transferred the facility to the RSD and the House and Senate Education Committees no later than August 1, 2014 and annually thereafter. Provides for the information to be contained in the report, including the operational status of the facility, an assessment of the condition, operator information, and planned status. The bill requires that facilities identified in the report as vacant and useable with no planned or assigned operator be returned to the local school board that originally transferred the facility no later than December 31, 2014 and annually thereafter.
