Provides relative to distribution of certain monies as purses. (8/1/13)

Proposed law changes the threshold amount to determine whether money is delivered to the Horsemen's Benevolent and Protective Association or retained by the association from more than an amount equal to the average daily purse distribution at the race meeting to more than an amount equal to two times the average daily purse distribution at thoroughbred race meetings at which generated. Proposed law provides for the Horseman's Benevolent and Protective Association (HBPA) to retain in an interest bearing account to be used for purses at the next meeting conducted by that association. Proposed law only impacts the LA State Fairgrounds.
