2 To appropriate funds out of the General Fund of the state of Louisiana for Fiscal Year 2016-3 2017 to be used to pay the consent judgment in the suit entitled "Jeanne Aguillard 4 and Laura Smith v. Charles Guidry, et al."; and to provide for related matters. 5 Be it enacted by the Legislature of Louisiana: 6 Section 1. The sum of Seven Thousand and NO/100 (\$7,000.00) Dollars in favor of 7 Jeanne Aguillard is hereby appropriated out of the General Fund of the state of Louisiana 8 for Fiscal Year 2016-2017 to be used to pay the consent judgment in the suit entitled "Jeanne 9 Aguillard and Laura Smith v. Charles Guidry, et al.", bearing Number 20145136 on the 10 docket of the 15th Judicial District Court, parish of Lafayette, state of Louisiana. 11 Section 2. The sum of Twenty-Three Thousand and NO/100 (\$23,000.00) Dollars 12 in favor of Laura Smith is hereby appropriated out of the General Fund of the state of 13 Louisiana for Fiscal Year 2016-2017 to be used to pay the consent judgment in the suit 14 entitled "Jeanne Aguillard and Laura Smith v. Charles Guidry, et al.", bearing Number 15 20145136 on the docket of the 15th Judicial District Court, parish of Lafayette, state of 16 Louisiana. 17 Section 3. This Act shall become effective on July 1, 2016; if vetoed by the governor 18 and subsequently approved by the legislature, this Act shall become effective on July 1, 19 2016, or on the day following such approval by the legislature, whichever is later.
