SEX EDUCATION: Requires certain state agencies to meet biannually to discuss and make recommendations in an effort to reduce teen pregnancy and sexually transmitted diseases

AN ACT

2	To enact Chapter 42 of Title 46 of the Louisiana Revised Statutes of 1950, to be comprised
3	of R.S. 46:2551 through 2553, relative to sex education programs; to provide for
4	legislative findings; to require certain agencies to meet and review state programs
5	aimed at reducing teen pregnancy and preventing the spread of sexually transmitted
6	diseases; to require the agencies to review available programs aimed at reducing teen
7	pregnancy and preventing the spread of sexually transmitted diseases; to require a
8	written report to the legislature; and to provide for related matters.
9	Be it enacted by the Legislature of Louisiana:
10	Section 1. Chapter 42 of Title 46 of the Louisiana Revised Statutes of 1950,
11	comprised of R.S. 46:2551 through 2553, is hereby enacted to read as follows:
12	CHAPTER 42. AGENCY COOPERATION IN PREVENTION OF TEEN
13	PREGNANCY AND SEXUALLY TRANSMITTED DISEASES
14	§2551. Declaration of purpose
15	A. The legislature hereby recognizes all of the following:
16	(1) It is imperative to protect and assist the youth of Louisiana if this state
17	is to move forward and realize its potential in the future.

1	(2) It is imperative to reduce the rate of teen pregnancies and prevent the
2	spread of HIV and other sexually transmitted diseases among the youth of Louisiana
3	in order to build stronger families and a healthier future for Louisiana.
4	(3) In order to improve the lives of Louisiana families and ensure a better
5	future for youth of Louisiana, it is imperative for state agencies to collaborate to
6	create a comprehensive strategy to reduce the rate of teen pregnancies and prevent
7	the spread of HIV and other sexually transmitted diseases among the youth of
8	Louisiana.
9	§2552. Prevention of teen pregnancy and sexually transmitted diseases; agency
10	<u>cooperation</u>
11	A. The state superintendent of education, the secretary of the Department of
12	Children and Family Services, and the secretary of the Department of Health and
13	Hospitals shall meet together not less than twice annually to review and evaluate the
14	effectiveness of current state programs, including but not limited to sex education
15	provided by public schools, aimed at reducing the rate of teen pregnancy and
16	preventing the spread of HIV and other sexually transmitted diseases among the
17	youth of Louisiana.
18	B. The state superintendent of education, the secretary of the Department of
19	Children and Family Services, and the secretary of the Department of Health and
20	Hospitals shall review and evaluate any programs that are available for
21	implementation in Louisiana to educate the youth of Louisiana about the importance
22	of preventing teen pregnancy and the spread of HIV and other sexually transmitted
23	diseases by providing culturally competent education and outreach.
24	<u>§2553. Report</u>
25	The state superintendent of education, the secretary of the Department of
26	Children and Family Services, and the secretary of the Department of Health and
27	Hospitals, jointly, shall submit a written report of their findings and
28	recommendations, including proposed legislation if necessary, for a comprehensive
29	strategy to reduce the rate of teen pregnancy and prevent the spread of HIV and other

**Abstract:** Requires certain agencies to meet and review state programs aimed at reducing the rate of teen pregnancy and preventing the spread of sexually transmitted diseases and to report their findings to the legislature.

Proposed law provides for legislative findings.

<u>Proposed law</u> requires the state superintendent of education, the secretary of the Dept. of Children and Family Services, and the secretary of the Dept. of Health and Hospitals to meet together not less than twice annually to review and evaluate the following:

- (1) The effectiveness of current state programs, including but not limited to sex education provided by public schools, aimed at reducing the rate of teen pregnancy and preventing the spread of HIV and other sexually transmitted diseases among the youth of La.
- (2) Programs that are available for implementation in La. to educate the youth of La. about the importance of preventing teen pregnancy and the spread of HIV and other sexually transmitted diseases by providing culturally competent education and outreach.

<u>Proposed law</u> requires the state superintendent of education, the secretary of the Dept. of Children and Family Services, and the secretary of the Dept. of Health and Hospitals, jointly, to submit a written report of their findings and recommendations, including proposed legislation if necessary, for a comprehensive strategy to reduce the rate of teen pregnancy and prevent the spread of HIV and other sexually transmitted diseases among the youth of La. on an annual basis to the legislature not later than 60 days prior to the commencement of the regular legislative session.
