PROCUREMENT: Requires public entities receiving federal funds to set goals for disadvantaged business enterprise participation

AN ACT

2	To enact R.S. 38:2212.8 and R.S. 39:1502.2 and 1598.1, relative to disadvantaged business
3	enterprises; to provide for participation goals for disadvantaged business enterprises
4	in certain public contracts; to provide for definitions; and to provide for related
5	matters.
6	Be it enacted by the Legislature of Louisiana:
7	Section 1. R.S. 38:2212.8 is hereby enacted to read as follows:
8	§2212.8. Goals for disadvantaged business enterprise participation
9	A. A public entity soliciting a bid or contract in which any portion of the
10	executed contract will be paid with federal funds shall adhere to any participation
11	goals for disadvantaged business enterprises which may be established by the federal
12	agency providing the funds.
13	B. For the purpose of this Section, "disadvantaged business enterprise" shall
14	mean a business certified under the Unified Certified Program for Disadvantaged
15	Business Enterprises.
16	Section 2. R.S. 39:1502.2 and 1598.1 are hereby enacted to read as follows:
17	§1502.2. Goals for disadvantaged business enterprise participation

HB No. 1284 Girod Jackson

Abstract: Requires public entities receiving federal funds to adhere to any goals for participation by disadvantaged business enterprises established by the federal agency.

<u>Proposed law</u> provides that a public entity soliciting a bid or contract in which any portion of the executed contract will be paid with federal funds shall adhere to any participation goals for disadvantaged business enterprises which may be established by the federal agency providing the funds.

Proposed law defines "disadvantaged business enterprise" as a business certified under the Unified Certified Program for Disadvantaged Business Enterprises.
