APPROPRIATIONS/JUDGMENT: Appropriates funds for the payment of judgment against DOTD in the matter of "Debra A Warden v. Amy Leblanc Richoux, et al"

AN ACT

2 To appropriate funds out of the General Fund of the state of Louisiana for Fiscal Year 2011-3 2012 to be used to pay the judgment in the suit entitled "Debra A. Warden v. Amy 4 LeBlanc Richoux, et al"; to provide for interest; to provide for court costs; to provide 5 for future medical expenses; and to provide for related matters. 6 Be it enacted by the Legislature of Louisiana: 7 Section 1.A. The sum of One Million Four Hundred Ninety-One Thousand Nine 8 Hundred and No/100 (\$1,491,900.00) Dollars, plus legal interest from March 6, 2002 until 9 paid, plus court costs in the amount of Twenty-Five Thousand Nine Hundred Forty-Eight 10 and 61/100 (\$25,948.61) Dollars, is hereby appropriated out of the General Fund of the state 11 of Louisiana for Fiscal Year 2011-2012 to be used to pay the judgment in the suit entitled 12 "Debra A. Warden v. Amy LeBlanc Richoux, et al", bearing Number 578-136, Division M, 13 on the docket of the Twenty-Fourth Judicial District Court, parish of Jefferson, state of 14 Louisiana. 15 B. Monies awarded in this judgment to Debra A. Warden in the amount of Fifty-16 Three Thousand Nine Hundred Nine and No/100 (\$53,909.00) Dollars shall be payable as 17 incurred from the Future Medical Care Fund pursuant to R.S. 39:1533.2. 18 Section 2. The judgment provided for in Section 1 hereof shall be deemed to have 19 been paid on the effective date of this Act and legal interest shall cease to run as of that date.

- 1 Section 3. This Act shall become effective on July 1, 2011; if vetoed by the governor
- 2 and subsequently approved by the legislature, this Act shall become effective on July 1,
- 3 2011, or on the day following such approval by the legislature, whichever is later.
