1	AN ACT
2	To amend and reenact R.S. 48:512(C), 1309.2(A)(2), and 2106(A), relative to provisions of
3	Title 48 (Roads, Bridges and Ferries) of the Louisiana Revised Statutes of 1950
4	which are limited in applicability to certain political subdivisions or local areas based
5	upon population classifications; to specify applicability to one or more political
6	subdivisions or local areas; and to provide for related matters.
7	Be it enacted by the Legislature of Louisiana:
8	Section 1. R.S. 48:512(C), 1309.2(A)(2), and 2106(A) are hereby amended and
9	reenacted to read as follows:
10	§512. Prohibition against closing, obstruction, or changing legal roads; restoring to
11	former condition; exceptions
12	* * *
13	C. The governing authority of a parish with a population in excess of four
14	hundred seventy-five thousand Orleans Parish may authorize a person to close,
15	obstruct, or change a public road or street for a period not to exceed twelve
16	consecutive months, provided that the governing authority determines that it is for
17	a public purpose and in the best interests and for the benefit of the parish or
18	municipality, provided further that such closing shall occur only after consultation
19	with and approval by the secretary of the department, provided further that all
20	obstructions be removed therefrom and the public roads or streets be restored for use
21	by the general public at the sole expense of the person authorized to close, obstruct,
22	or change a public road or street, and provided further that the removal of
23	obstructions and the restoration of the public roads or streets be completed within the
24	period authorized by the governing authority, which period shall not exceed twelve
25	months.

§1309.2. Service charge authorized for road lighting districts

(2) In Ward 8 of any parish having a population between one hundred ninety-one thousand and two hundred twenty thousand persons according to the most recent federal decennial census <u>St Tammany Parish</u>, only one service charge shall be assessed to any person occupying a residential or nonresidential structure on two or more contiguous lots, subdivided portions of ground, or individual tracts having the same owner, or to the owner of two or more contiguous lots, subdivided portions of ground, or individual tracts having the same owner, on which an unoccupied structure or no structure is located.

- 13 §2106. Membership requirements

A. The board of directors for each expressway commission with boundaries 14 15 and jurisdiction which are coterminous with parishes having a population between 16 one hundred eighty-five thousand and one hundred ninety-one thousand, according 17 to the latest federal decennial census Lafayette Parish, shall include one director 18 from an adjacent parish having a population between seventy thousand and seventy-19 five thousand Iberia Parish and one director from an adjacent parish having a 20 population between fifty-three thousand eight hundred and fifty-five thousand, 21 according to the latest federal decennial census Vermilion Parish.
