APPROPRIATIONS/JUDGMENT: Appropriates funds for payment of judgment against the state in the matter of "Mardel Von Solow, et al, and Paul Williams Marks and Belinda Boutte Migues, et al v. DOTD"

AN ACT

2 To appropriate funds out of the General Fund of the state of Louisiana for Fiscal Year 2012-3 2013 to be used to pay the consent judgment in the suit entitled "Mardel Von Solow, 4 individually, and as Natural Tutrix of her minor child, Paul Jason Sokol, and Paul 5 William Marks and Belinda Boutte Migues, individually, and as Natural Co-Tutors 6 of their minor child, Daylan Joseph Marks v. State of Louisiana, through the 7 Department of Transportation and Development"; and to provide for related matters. 8 Be it enacted by the Legislature of Louisiana: 9 Section 1. The sum of Twenty-Five Thousand and No/100 (\$25,000.00) Dollars in 10 favor of Mardell Von Solow; the sum of Seven Thousand Four Hundred Thirty-Seven and 11 47/100 (\$7,437.47) Dollars in favor of Paul Sokol; and the sum of Nine Thousand Five 12 Hundred Nine and 04/100 (\$9,509.04) Dollars in favor of Daylan Marks is hereby 13 appropriated out of the General Fund of the state of Louisiana for Fiscal Year 2012-2013 to 14 be used to pay the consent judgment in the suit entitled "Mardel Von Solow, individually, 15 and as Natural Tutrix of her minor child, Paul Jason Sokol, and Paul William Marks and 16 Belinda Boutte Migues, individually, and as Natural Co-Tutors of their minor child, Daylan 17 Joseph Marks v. State of Louisiana, through the Department of Transportation and 18 Development", bearing Number 95947, Division "H", on the docket of the Sixteenth Judicial 19 District Court, parish of Iberia, state of Louisiana.
