SUNSET LAW: Re-creates the Louisiana Department of Health

1 AN ACT

2 To enact R.S. 49:191(2)(b) and to repeal R.S. 49:191(12)(h), relative to the Louisiana  
3 Department of Health, including provisions to provide for the re-creation of the  
4 Louisiana Department of Health and the statutory entities made a part of the  
5 department by law; to provide for the effective termination date for all statutory  
6 authority for the existence of such statutory entities; to provide for an effective date;  
7 and to provide for related matters.

8 Be it enacted by the Legislature of Louisiana:

9 Section 1. Pursuant to R.S. 49:193, the Louisiana Department of Health and the  
10 statutory entities made a part of the department by law shall be re-created effective June 30,  
11 2024, and all statutory authority therefor is continued in accordance with the provisions of  
12 Part XII of Chapter 1 of Title 49 of the Louisiana Revised Statutes of 1950.

13 Section 2. All statutory authority for the existence of the Louisiana Department of  
14 Health and the statutory entities made a part of the department as re-created by Section 1 of  
15 this Act shall cease as of July 1, 2029, pursuant to R.S. 49:191. However, the Louisiana  
16 Department of Health may be re-created prior to such date in accordance with the provisions  
17 of Part XII of Chapter 1 of Title 49 of the Louisiana Revised Statutes of 1950.

18 Section 3. The provisions of R.S. 49:193 are hereby superseded to the extent that  
19 those provisions are in conflict with the provisions of this Act.

1 Section 4. R.S. 49:191(2)(b) is hereby enacted to read as follows:

2 §191. Termination of legislative authority for existence of statutory entities; phase-  
3 out period for statutory entities; table of dates

4 Notwithstanding any termination dates set by any previous Act of the  
5 legislature, the statutory entities set forth in this Section shall begin to terminate their  
6 operations on July first of each of the following years, and all legislative authority  
7 for the existence of any statutory entity, as defined in R.S. 49:190, shall cease as of  
8 July first of the following year, which shall be the termination date:

10 (2) July 1, 2028:

12 (b) The Louisiana Department of Health and all statutory entities made a part  
13 of the department by law.

14 Section 5. R.S. 49:191(12)(h) is hereby repealed in its entirety.

15 Section 6. This Act shall become effective on June 30, 2024; if vetoed by the  
16 governor and subsequently approved by the legislature, this Act shall become effective on  
17 June 30, 2024, or on the day following such approval by the legislature, whichever is later.

**Abstract:** Re-creates the La. Dept. of Health.

Present law (Sunset) provides that the La. Dept. of Health and all the statutory entities made a part of that department by law begin to terminate their operations on July 1, 2024, and that all legislative authority for such entities shall cease as of July 1, 2025, unless the legislature enacts a bill authorizing the re-creation of the department and its statutory entities prior thereto.

Proposed law provides for the general re-creation of the La. Dept. of Health and its statutory entities, effective June 30, 2024, in accordance with the "sunset" law.

Proposed law supersedes the provisions of the "sunset" law which set out the procedure for review and re-creation and which require a separate bill to re-create such statutory entity within the department along with additional provisions.

Proposed law makes July 1, 2029, the new termination date and termination would begin July 1, 2028, unless the department is re-created again.  
Effective June 30, 2024.
