APPROPRIATIONS/JUDGMENT: Appropriates funds for payment of judgment against DOTD in "Elveta Daigre et al v. International Truck and Engine Corporation, et al"

1 AN ACT

2 To appropriate funds out of the General Fund of the state of Louisiana for Fiscal Year 2010-
3 2011 to be used to pay the consent judgment against the Department of
4 Transportation and Development in the suit entitled "Elveta Daigre, et al v.
5 International Truck and Engine Corporation, et al"; and to provide for related
6 matters.

7 Be it enacted by the Legislature of Louisiana:

8 Section 1. The sum of Four Hundred Fifty Thousand and No/100(\$450,000.00)
9 Dollars, to be apportioned and paid as follows: the sum of One Hundred Fifty Thousand and
10 No/100 (\$150,000.00) Dollars to William R. Daigre, IV, and his attorney, Michael J.
11 Mestayer, APLC; the sum of One Hundred Fifty Thousand and No/100 (\$150,000.00)
12 Dollars to Richard Daigre and his attorney, Michael J. Mestayer, APLC; the sum of One
13 Hundred Fifty Thousand and No/100 (\$150,000.00) Dollars to Scott Daigre and his attorney,
14 Michael J. Mestayer, APLC is hereby appropriated out of the General Fund of the state of
15 Louisiana for Fiscal Year 2010-2011 to be used to pay the consent judgment in the suit
16 entitled "Elveta Daigre, et al v. International Truck and Engine Corporation, et al", bearing
17 Number 04-03727, Division "J" on the docket of the Civil District Court, parish of Orleans,
18 state of Louisiana.

19 Section 2. This Act shall become effective on July 1, 2010; if vetoed by the governor
20 and subsequently approved by the legislature, this Act shall become effective on July 1,
21 2010, or on the day following such approval by the legislature, whichever is later.
