HOUSE BILL NO. 257

BY REPRESENTATIVE RITCHIE

Prefiled pursuant to Article III, Section 2(A)(4)(b)(i) of the Constitution of Louisiana.

1 AN ACT

2 To amend and reenact R.S. 22:2294(B) and to enact R.S. 22:2294(A)(11) and 2303(A)(4),  
3 relative to the Louisiana Citizens Property Insurance Corporation; to provide for an  
4 additional board member; to allow the Louisiana Chapter of the National Association  
5 of Insurance and Financial Advisors to nominate three possible board members; to  
6 allow the commissioner of insurance to appoint a board member from the  
7 association's nominees; to change the quorum requirement of the board; to provide  
8 with respect to rates, rating plans, and rate rules applicable to Louisiana Citizens  
9 Property Insurance Corporation; and to provide for related matters.

10 Be it enacted by the Legislature of Louisiana:

11 Section 1. R.S. 22:2294(B) is hereby amended and reenacted and R.S.  
12 22:2294(A)(11) and 2303(A)(4) are hereby enacted to read as follows:

13 §2294. Board of directors of corporation

14 A. The governing body of the corporation shall be a board of directors which  
15 shall consist of the following members, who shall be representative of the state's  
16 population as near as practicable:

18 (11) One member appointed by the commissioner from a list of three  
19 nominees from the Louisiana Chapter of the National Association of Insurance and  
20 Financial Advisors, or its successor.

21 B. The quorum necessary for transaction of business is hereby established  
22 as ~~seven~~ eight members of the board in attendance.

1           §2303. Rates, rating plans, and rate rules applicable

4                   (4) When it is deemed necessary to implement a parish-wide average rate  
5                   increase in excess of twenty-five percent on wind and hail insurance coverage in any  
6                   single parish, the corporation shall notify the House and Senate committees on  
7                   insurance. Upon such notification, a hearing may be requested by either committee  
8                   chairman or by a majority of the membership of either committee. In the event of  
9                   a request for a hearing, the House and Senate committees shall meet jointly. If a  
10                   joint meeting of the committees is called, the chief executive officer and the staff or  
11                   consulting actuary for the corporation shall provide testimony at the meeting which  
12                   specifies, by parish, the basis and methodology used in determining the proposed rate  
13                   increase.
