APPROPRIATIONS/SUPPLEML: To make supplemental appropriations for the 2023-2024 Fiscal Year

1 AN ACT

2 To appropriate funds and to make certain reductions from certain sources to be allocated to
3 the designated agencies and purposes in specific amounts for the making of
4 supplemental appropriations and reductions for said agencies and purposes for Fiscal
5 Year 2023-2024; to provide for an effective date; and to provide for related matters.

6 Be it enacted by the Legislature of Louisiana:

7 Section 1. The following sums are hereby appropriated from the sources specified
8 for the purpose of making supplemental appropriations for Fiscal Year 2023-2024.
9 Reductions are denoted in parentheses.

11 DEPARTMENT OF CHILDREN AND FAMILY SERVICES

12 The Department of Children and Family Services is hereby directed to notify the United
13 States Department of Agriculture's Food and Nutrition Service that it will participate in the
14 Summer Electronic Benefit Transfer (EBT) Program and to take all necessary actions to
15 facilitate the expenditure of funds as authorized in this Act.

1 Section 2. This Act shall become effective upon signature by the governor or, if not
2 signed by the governor, upon expiration of the time for bills to become law without signature
3 by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If
4 vetoed by the governor and subsequently approved by the legislature, this Act shall become
5 effective on the day following such approval.
