PROPERTY/IMMOVABLE: Provides relative to the application of the New Home Warranty Act

2	To amend and reenact R.S. 9:3143(3) and 3150, relative to the New Home Warranty Act;
3	to provide relative to applicability to certain structures; to exclude application to
4	certain unimproved land; and to provide for related matters.
5	Be it enacted by the Legislature of Louisiana:
6	Section 1. R.S. 9:3143(3) and 3150 are hereby amended and reenacted to read as
7	follows:
8	§3143. Definitions
9	For purposes of this Chapter the following words, phrases, and terms shall
10	be defined and construed as follows:
11	* * *
12	(3) "Home" means any new structure designed and used only for residential
13	use, together with all attached and unattached structures, constructed by the builder
14	whether or not the land was purchased from the builder. Such term includes
15	structures containing multiple family dwellings or residences, but does not include
16	the unimproved land beyond the foundation upon which new attached and unattached
17	structures are located.

1	§3150. Exclusiveness
2	A. This Chapter provides the exclusive remedies, warranties, and peremptive
3	periods as between builder and owner relative to home construction, and no other
4	provisions of law relative to warranties and redhibitory vices and defects shall apply.
5	<u>B.</u> Nothing herein in this Chapter shall be construed as affecting or limiting
6	any of the following:
7	(1) any <u>Any</u> warranty of title to land or improvements.
8	(2) Any warranty to the unimproved land beyond the foundation upon which
9	new attached and unattached structures are located.

Abstract: Provides for the application of the New Home Warranty Act to only the new attached and unattached structures and foundation upon which such structures are located.

<u>Present law</u> defines "home" as any new structure designed and used only for residential use, together with all attached and unattached structures, constructed by the builder whether or not the land was purchased from the builder, and further provides that "home" includes structures containing multiple family dwellings or residences.

<u>Proposed law</u> retains <u>present law</u> except it provides that "home" does not include the unimproved land beyond the foundation upon which all new attached and unattached structures are located.

<u>Present law</u> provides that the New Home Warranty Act provides the exclusive remedies, warranties, and peremptive periods as between builder and owner relative to home construction, and no other provisions of law relative to warranties and redhibitory vices and defects shall apply.

<u>Present law</u> provides that the New Home Warranty Act shall not be construed as affecting or limiting any warranty of title to land or improvements.

<u>Proposed law</u> retains <u>present law</u> and also provides that the New Home Warranty Act shall not be construed as affecting or limiting any warranty to the unimproved land beyond the foundation upon which new attached and unattached structures are located.
