COURTS/CITY: Authorizes an increase in fees for criminal bonds posted in the Denham Springs City Court

1	AN ACT
2	To enact R.S. 15:85.3, relative to posting of criminal bonds; to provide for an increase in
3	fees assessed for criminal bonds in Denham Springs; to provide for collection of fees
4	by the marshal of the Denham Springs City Court; to provide for allocation of funds
5	to the marshal's general fund; to provide for use of funds for the operational expenses
6	of the marshal's office; and to provide for related matters.
7	Be it enacted by the Legislature of Louisiana:
8	Section 1. R.S. 15:85.3 is hereby enacted to read as follows:
9	§85.3. Posting of criminal bonds; Denham Springs Marshal's Office; additional fee
10	assessed
11	A. An additional fee of twenty dollars shall be assessed for every criminal
12	bond posted in the city court of Denham Springs. This fee shall be in addition to any
13	other fees or fines as provided by law. Any person seeking release by means of a
14	criminal bond, or his designated representative, shall pay the fee to the marshal for
15	the Denham Springs City Court who shall deposit the funds in the marshal's general
16	fund for the city court of Denham Springs.
17	B. The monies collected pursuant to the provisions of Subsection A of this
18	Section shall be used to supplement the operational expenses of the marshal's office
19	for the city court of Denham Springs. The expenditure of the funds shall be at the
20	sole discretion of the marshal of the court.

1	C. Any person found not guilty or any person against whom criminal charges
2	are brought and thereafter dismissed may petition the city court of Denham Springs
3	for a refund of the fee assessed pursuant to the provisions of this Section.
4	D. The assessment and disposition of any funds pursuant to this Section shall
5	not affect the responsibilities of the city and parish governing authority provided by
6	law for the financing of the marshal's office of the city court of Denham Springs.

Abstract: Authorizes an increase in fees for criminal bonds posted in the Denham Springs City Court to supplement the operational expenses of the marshal's office.

<u>Proposed law</u> authorizes a fee increase of \$20 for all criminal bonds posted in the city court of Denham Springs to be collected by the marshal for deposit into the marshal's general fund.

<u>Proposed law</u> requires the additional fees to be used to supplement the operational expenses for the marshal's office, at the sole discretion of the marshal.

<u>Proposed law</u> authorizes any person to petition the court for a refund of the fee if the person who is found not guilty or the criminal charges have been dismissed.

<u>Proposed law</u> provides that the financing of the marshal's office by the city and parish governing authorities shall not be affected by the increase in fees.
