RETIREMENT/PAROCHIAL EMP: Authorizes certain employees of Plaquemines Parish government to remain in the Parochial Employees' Retirement System of Louisiana

1 AN ACT

2 To amend and reenact R.S. 11:1922(G), relative to membership of the Parochial Employees  
3 Retirement System of Louisiana; to provide for membership of certain employees  
4 of the Plaquemines Parish Fire Department; and to provide for related matters.

5 Notice of intention to introduce this Act has been published  
6 as provided by Article III, Section 13 and Article X, Section  
7 29(C) of the Constitution of Louisiana.

8 Be it enacted by the Legislature of Louisiana:

9 Section 1. R.S. 11:1922(G) is hereby amended and reenacted to read as follows:

10 §1922. Persons not eligible for membership; persons becoming eligible for  
11 membership in other systems

12 \* \* \*

13 G.(1) Any person who is ineligible for membership in the publicly funded  
14 retirement system covered by his employment because of his failure to meet  
15 requirements or qualifications shall not be eligible for membership in this system.

16 (2) Notwithstanding Paragraph (1) of this Subsection or any other provision  
17 of law to the contrary, an employee of the Plaquemines Parish fire department whose  
18 employment was transferred from the Plaquemines Parish ambulance department  
19 pursuant to ordinance number 15-71 adopted by the Plaquemines Parish governing  
20 authority and who, due to his age on the date of transfer, is not eligible to participate

1           in the Firefighters' Retirement System or to transfer service credit to the Firefighters'  
 2           Retirement System pursuant to R.S. 11:143, shall as a condition of employment  
 3           continue membership in this system as of the date of transfer.

**Abstract:** Provides that certain employees of Plaquemines Parish government whose employment was transferred to the parish fire department shall remain members of the Parochial Employees' Retirement System of La. (PERS) rather than becoming members of the Firefighters' Retirement System (FRS).

Present law relative to FRS requires that any person who is in a position defined in the municipal fire and police civil service system and who is employed by a parish fire department become a member of FRS as a condition of his employment; however, no person age 50 or over shall become a member of the system.

Present law relative to PERS provides that a person who is employed as a permanent employee of a parish and who is not eligible for any other public retirement in this state is a member of the system. However, present law provides that any person who is ineligible for membership in the publicly funded retirement system covered by his employment because of failure to meet requirements or qualifications for membership shall not be eligible for membership in PERS.

Present local law (Plaquemines Parish) consolidates the parish ambulance department into the parish fire department. Fire department employees are members of FRS. Prior to consolidation, ambulance department employees were members of PERS. Upon consolidation, employees of the ambulance department became members of FRS if they were eligible to do so.

Proposed law requires employees of the Plaquemines Parish fire department who were former employees of the ambulance department and who are ineligible to transfer service credit to or become members of FRS due to their age to remain in PERS.
