STUDENT/SCH ATTENDANCE: Provides relative to prekindergarten instruction and age requirements at public and nonpublic elementary schools

AN ACT

2	To amend and reenact R.S. 17:24.8 and 222(C), relative to prekindergarten programs at
3	nonpublic elementary schools; to authorize certain nonpublic schools to develop and
4	offer prekindergarten instruction; to provide for the minimum age at which children
5	enter prekindergarten at nonpublic schools; to provide for rules and regulations; and
6	to provide for related matters.
7	Be it enacted by the Legislature of Louisiana:
8	Section 1. R.S. 17:24.8 and 222(C) are hereby amended and reenacted to read as
9	follows:
10	§24.8. Prekindergarten programs
11	A. Each city, and parish, or other local public school board may develop and
12	offer prekindergarten instruction. The youngest age at which a child may enter
13	prekindergarten provided for by this Section Subsection shall be two years younger
14	than the age required for that child to enter first grade as provided by R.S. 17:222(A)
15	or, two years younger than the age required by the city or parish school board
16	pursuant to R.S. 17:222(C).
17	B. (1) The governing authority of any approved nonpublic elementary school
18	may develop and offer prekindergarten instruction. The youngest age at which a
19	child may enter prekindergarten provided for by this Subsection shall be three years
20	old by September thirtieth of the year in which the child enrolls in prekindergarten

(3) Notwithstanding the provisions of Subsections A and B of this Section, the parish school boards in Jefferson and Orleans parishes may adopt, by rule, and enforce ages for entrance into first grade in the schools in its system their systems which vary from the provisions of this Section. All children admitted into school as a result of a rule adopted pursuant to this Subsection shall be counted in reports submitted for funding under the Minimum Foundation Program and money allocated pursuant to such program shall be based on the report which includes such children.

Guinn HB No. 373

Abstract: Authorizes certain nonpublic schools to offer pre-K and provides that the minimum entrance age shall be three years old by Sept. 30 of the year of such pre-K entrance.

<u>Present law</u> authorizes public school boards to develop and offer prekindergarten instruction (pre-K). <u>Proposed law</u> additionally grants this authority to approved nonpublic elementary schools and provides that the minimum age for pre-K entrance at such schools shall be three years old by Sept. 30 of the year of pre-K entrance. Further requires the State Board of Elementary and Secondary Education, in consultation with the Nonpublic School Commission, to adopt rules and regulations to protect the health and safety of three-year-old children who attend pre-K at such schools.

<u>Present law</u> requires public school boards, prior to implementing a pre-K program, to set forth a statement of needs the program is intended to address, the anticipated results, and the basis upon which such results are expected, an outline of implementation steps, a plan for staff usage, a budget, and a plan for results evaluation. <u>Proposed law</u> applies this same requirement to approved nonpublic elementary schools.

<u>Present law</u> (R.S. 17:222(A)) requires a child to be six years old on or before Sept. 30 of the calendar year in which the school year begins to enter first grade at any public school. <u>Proposed law</u> retains <u>present law</u>.

 $\frac{Present\ law}{(R.S.\ 17:222(C)(1)\ and\ (2))}\ provides\ for\ an\ exception\ to\ the\ first\ grade\ minimum\ age\ requirement\ through\ the\ 1995-1996\ school\ year.\ \underline{Proposed\ law}\ deletes\ \underline{present\ law}.$

Summary of Amendments Adopted by House

Committee Amendments Proposed by <u>House Committee on Education</u> to the <u>original</u> bill.

1. Deletes <u>proposed law</u> provision lowering the minimum age to enter public school pre-K <u>from</u> four <u>to</u> three.

- 2. Deletes <u>proposed law</u> provision requiring that a child be at least six to enter first grade at an approved nonpublic elementary school.
- 3. Provides that the minimum entrance age for nonpublic pre-K is three years old by Sept. 30 of the pre-K entrance year.
- 4. Adds requirement that the State Board of Elementary and Secondary Education, in consultation with the Nonpublic School Commission, adopt rules and regulations protecting the health and safety of three-year-olds attending nonpublic pre-K.
- 5. Adds provision requiring approved nonpublic schools to fulfill the same requirement as public schools relative to setting forth a statement of program details before implementing a pre-K program.
