5	Be it enacted by the Legislature of Louisiana:
6	Section 1. R.S. 51:2361(B)(2) and 2365(D) are hereby amended and reenacted and
7	R.S. 51:2361(B)(3) and (4) are hereby enacted to read as follows:
8	§2361. Rapid Response Fund

12	(2) Monies in the fund shall be available for appropriation to the Department
13	of Economic Development, hereinafter referred to as the "department". Such
14	appropriations shall be used by the secretary of the department for immediate
15	funding of all or a portion of economic development projects which may be
16	necessary in order to successfully secure the creation or retention of jobs by a
17	business entity under such circumstances as may be determined by the secretary and
18	the governor.
19	(3) The secretary shall report to the Joint Legislative Committee on the
20	Budget twice yearly, on the first day of October and the first day of April, with
21	respect to all actual expenditures of monies appropriated from the fund. The reports
22	shall be available electronically, and the secretary shall include in these reports any
23	other information which the committee may require with respect to use of monies

Such appropriations shall be used by the secretary of the department 15 for immediate funding of all or a portion of economic development mega-projects 16 which may be necessary in order to successfully secure the creation or retention of 17 jobs by a business entity under such circumstances as established by this Part. 18 (2) The secretary shall report to the Joint Legislative Committee on the 19 Budget twice yearly, on the first day of October and the first day of April, with 20 respect to all actual expenditures of monies appropriated from the fund. The reports 21 shall be available electronically, and the secretary shall include in these reports any 22 other information which the committee may require with respect to use of monies 23 appropriated from the fund, including but not limited to the following 24 information on each economic development project which receives funding: 25 (a) Performance targets.

(d) Overall payroll generated.
