FUNDS/FUNDING: Requires a portion of the monies in the Unclaimed Property Leverage Fund to be dedicated to the Louisiana Early Childhood Education Fund

2	To amend and reenact R.S. 17:407.30(B) and (D) and to enact R.S. 9:165(D) and R.S.	
3	17:407.30(H), relative to the Louisiana Early Childhood Education Fund; to provide	
4	for the uses of the fund; to provide for the deposit of the proceeds of the sale of	
5	unclaimed property into the fund; to require the State Board of Elementary and	
6	Secondary Education to submit a written report on the status and effectiveness of the	
7	fund; to provide for effectiveness; and to provide for related matters.	
8	Be it enacted by the Legislature of Louisiana:	
9	Section 1. R.S. 9:165(D) is hereby enacted to read as follows:	
10	§165. Deposit of funds

12	D. In Fiscal Years 2019-2020 through 2022-2023, of the monies remaining	
13	after deducting the amount needed to cover administrative costs and the deposits into	
14	the Unclaimed Property Leverage Fund as provided in Subsections B and C of this	
15	Section, the state treasurer shall deposit into the Louisiana Early Childhood	
16	Education Fund, ten million dollars per fiscal year of the funds received by the	
17	administrator under this Chapter.

11	D. The fund shall be administered by the State Board of Elementary and	
12	Secondary Education.	
13	(1) In the event that there are eligible parents or legal custodians of children	
14	on the Child Care Assistance Program waiting list maintained by the state	
15	Department of Education, the state board shall ensure that funds be used to support	
16	those parents or legal custodians in the order in which their applications have been	
17	approved.	
18	(2) Upon elimination of any Child Care Assistance Program waiting list	
19	maintained by the state Department of Education, Monies monies in the fund shall	
20	be awarded to local entities approved by the state board for the purpose of funding	
21	early childhood care and education slots through the Child Care Assistance Program	
22	in Type III early learning centers that have at least one classroom with children age	
23	fifteen months or younger if a local entity provides funds from nonstate sources. No	
24	such award shall be made unless the local entity's financial commitment to the	
25	project proposed for funding provides matching funds from nonstate sources at a rate	
26	of at least two to one.

1	H. By not later than October 1, 2024, the state board shall submit a written
2	report to the House Committee on Education and the Senate Committee on
3	Education on the status and effectiveness of the fund created by this Section.
4	Section 3. This Act shall become effective on July 1, 2018; if vetoed by the governor
5	and subsequently approved by the legislature, this Act shall become effective on July 1,
6	2018, or on the day following such approval by the legislature, whichever is later.

Abstract: Dedicates \$10 million per year from FY19 through FY22 from the proceeds of the sale of unclaimed property to be deposited into the La. Early Childhood Education Fund and allows the fund to be used to eliminate the waiting list for the Child Care Assistance Program.

<u>Present law</u> provides for the deposit of proceeds from the sale of abandoned property. Requires \$15 million to be deposited each year into the Unclaimed Property Leverage Fund for bonds and direct payments of highway construction on I-49. <u>Proposed law</u> additionally requires that \$10 million of the proceeds from abandoned property be deposited each year into the La. Early Childhood Education Fund. Otherwise retains <u>present law</u>.

<u>Proposed law</u> retains <u>present law</u> and provides that after satisfaction of the requirements of <u>present law</u> concerning the disposition of certain monies in the Unclaimed Property Leverage Fund, adds a deposit of \$10 million per year for FY19 through FY22 for deposit into the La. Early Childhood Education Fund.

<u>Proposed law</u> requires that the State Bd. of Elementary and Secondary Education ensure that funds be used to support parents on a waiting list for the Child Care Assistance Program prior to awarding monies to local entities. Further requires the state board to submit a written report, by Oct. 1, 2023, to the House and Senate education committees on the status and effectiveness of the fund.

Effective July 1, 2018.

- 1. Change the dedication from \$10 million each year in perpetuity to a four year dedication (FY19 through FY22) of \$10 million per year.
