APPROPRIATIONS/JUDGMENT: Appropriates funds for payment of judgment against DOTD in the matter of "Elaine Maxwell, et al v. State Farm Mutual Automobile Insurance Company, et al"

AN ACT

2 To appropriate funds out of the General Fund of the state of Louisiana for Fiscal Year 2011-3 2012 to be used to pay the consent judgment in the suit entitled "Elaine Maxwell, 4 individually and on behalf of her minor child, Felecia Woolens v. State Farm Mutual 5 Automobile Insurance Company, Mitsubishi Motors North America, Inc., Mitsubishi 6 Motors Corporation, XYZ Insurance Company, Louisiana Department of 7 Transportation and Development and ABC Insurance Company"; and to provide for 8 related matters. 9 Be it enacted by the Legislature of Louisiana: 10 Section 1. The sum of Four Hundred Thousand and No/100 (\$400,000.00) Dollars 11 is hereby appropriated out of the General Fund of the state of Louisiana for Fiscal Year 12 2011-2012 to be used to pay the consent judgment in the suit entitled "Elaine Maxwell, 13 individually and on behalf of her minor child, Felecia Woolens v. State Farm Mutual 14 Automobile Insurance Company, Mitsubishi Motors North America, Inc., Mitsubishi Motors 15 Corporation, XYZ Insurance Company, Louisiana Department of Transportation and Development and ABC Insurance Company", bearing Number 601-988 "K" on the docket 16 17 of the Twenty-Fourth Judicial District Court, parish of Jefferson, state of Louisiana. 18 Section 2. This Act shall become effective on July 1, 2011; if vetoed by the governor 19 and subsequently approved by the legislature, this Act shall become effective on July 1, 20 2011, or on the day following such approval by the legislature, whichever is later.
