CONTROLLED SUBSTANCES: Creates the crime of the unlawful production, manufacturing, distribution, or possession of prohibited plants and adds hallucinogenic substances to Schedule I

AN ACT

2	To enact R.S. 40:964(Schedule I)(C)(32), (33), (34), and (35) and 989.2, relative to
3	controlled dangerous substances; to create the crime of the unlawful production,
4	manufacturing, distribution, or possession of a material, compound, mixture, or
5	preparation which contains a prohibited plant; to provide for definitions; to provide
6	for criminal penalties; to provide for exceptions; to add certain hallucinogenic
7	substances to Schedule I; and to provide for related matters.
8	Be it enacted by the Legislature of Louisiana:
9	Section 1. R.S. 40:964(Schedule I)(C)(32), (33), (34), and (35) and 989.2 are hereby
10	enacted to read as follows:
11	§964. Composition of schedules
12	Schedules I, II, III, IV, and V shall, unless and until added to pursuant to R.S.
13	40:962, consist of the following drugs or other substances, by whatever official
14	name, common or usual name, chemical name, or brand name designated:

17	A.(1) It shall be unlawful for any person knowingly or intentionally to		
18	produce, manufacture, distribute, or possess with intent to produce, manufacture, or		
19	distribute a material, compound, mixture, or preparation which contains a prohibited		
20	plant and which meets any of the following criteria:		
21	(a) It is intended to be placed in the oral or nasal cavity.		
22	(b) It is prepared in such a manner as to be suitable for smoking in a pipe or		
23	cigarette, or other device.		
24	(c) It is to be burned and inhaled or exhaled in any manner or in any form.		
25	(2) Whoever violates the provisions of this Subsection shall be sentenced to		
26	a term of imprisonment with or without hard labor for not less than two years nor		
27	more than five years and may, in addition, be sentenced to pay a fine of not more		
28	than ten thousand dollars.		

B.(1) It shall be un	nlawful for any person knowingly or intentionally to
possess material, compound	d, mixture, or preparation which contains a prohibited
plant and which is intended	to be placed in the oral or nasal cavity, is prepared in
such a manner as to be suital	ble for smoking in a pipe or cigarette, or is to be burned
and inhaled or exhaled in an	y manner or in any form.
(2) Any person who	violates the provisions of this Subsection shall be fined
not more than five hundred	dollars, imprisoned for not more than six months, or
both.	
C. For the purposes	of this Section:
(1) "Distribute" me	ans to sell, barter, trade, furnish, supply, or otherwise
transfer in exchange for a	nything of value a material, compound, mixture, or
preparation which contains	a prohibited plant.
(2) "Homeopathic	drug" means any drug labeled as being homeopathic
which is listed in the Homeo	pathic Pharmacopeia of the United States, an addendum
to it, or its supplements. The	e potencies of homeopathic drugs are specified in terms
of dilution. Homeopathic d	rug products must contain diluents commonly used in
homeopathic pharmaceutics	. Drug products containing homeopathic ingredients in
combination with non-hom	eopathic active ingredients are not homeopathic drug
products.	
(3) "Manufacture	" means the production, preparation, propagation,
compounding, or processing	of a material, compound, mixture, or preparation which
contains a prohibited plant e	ither directly or indirectly by extraction from substances
of natural origin, or indep	pendently by means of chemical synthesis, or by a
combination of extraction an	d chemical synthesis. Manufacturer includes any person
who packages, repackages,	or labels any container holding a material, compound,
mixture, or preparation which	ch contains a prohibited plant.
(4) "Production" inc	cludes the manufacture, planting, cultivation, growing,
or harvesting of a prohibited	l plant.

1	(5) "Prohibited plant" means any combination of any of the parts, leaves,
2	stems, stalks, seeds, materials, compounds, salts, derivatives, mixtures, preparations,
3	or any resin extracted from any part of the following plants:
4	(a) Artemisia vulgaris (Mugwort).
5	(b) Canavalia rosea (Bay bean).
6	(c) Leonotis leonurus (Lion's tail).
7	(d) Leonotis nepetifolia (Lion's ear).
8	(e) Leonurus sibiricus (Honeyweed).
9	(f) Nelumbo nucifera (Sacred Lotus).
10	(g) Nymphaea caerulea (Blue Lotus, Egyptian Lotus).
11	(h) Pedicularis densiflora (Indian warrior).
12	(i) Scutellaria nana (Dwarf skullcap).
13	(j) Turnera diffusa (Damiana).
14	(k) Zornia latifolia
15	D. The provisions of this Section shall not apply to any dosage form which
16	is legally obtainable from a retail establishment without a prescription and is
17	recognized by the United States Food and Drug Administration as a homeopathic
18	<u>drug.</u>
19	E. The provisions of this Section shall not apply to the possession, planting,
20	cultivation, growing, or harvesting of a prohibited plant strictly for aesthetic,
21	landscaping, or decorative purposes.

LaFonta HB No. 551

Abstract: Creates the crime of unlawful production, manufacturing, distribution, or possession of a material, compound, mixture, or preparation which contains a prohibited plant and adds certain hallucinogenic substances to Schedule I.

<u>Present law</u> provides for classification of controlled dangerous substances in Schedules I through V.

<u>Proposed law</u> retains the provisions of <u>present law</u> and adds the following substances to Schedule I: $2-[(1R,3S)-3-hydroxycyclohexyl]-5-(2-methyloctan-2-yl)phenol {also known as CP 47,497 and its C6, C7, C8, and C9 homologues}; (6aR,10aR)-9-(hydroxymethyl)-6,6-dimethyl-3-(2-methyloctan-2-yl)-6a,7,10,10a-tetrahy drobenzo [c]chromen-1-ol {also known as HU-210}; Naphthalen-1-yl-(1-pentylindol-3-yl)methanone {also known as 1-Pentyl-3-(1-naphthoyl)indole or JWH-018}; and Naphthalen-1-yl-(1-butylindol-3-yl)methanone {also known as 1-Butyl-3-(1-naphthoyl)indole or JWH-073}.$

<u>Present law</u> provides criminal penalties for the unlawful production, manufacture, distribution, or dispensing of controlled dangerous substances.

<u>Proposed law</u> retains the provisions of <u>present law</u> and creates the crime of unlawful production, manufacturing, distribution, or possession of a material, compound, mixture, or preparation which contains a prohibited plant.

Proposed law defines "production", "manufacture", "distribute", and "prohibited plant".

<u>Proposed law</u> provides for the following criminal penalties for unlawful production, manufacturing, distribution, or possession with intent to manufacture, produce, or distribute a material, compound, mixture, or preparation which contains a prohibited plant: imprisonment with or without hard labor for not less than two years nor more than five years and a fine of not more than \$10,000.

<u>Proposed law</u> provides for the following criminal penalties for unlawful possession of a material, compound, mixture, or preparation which contains a prohibited plant: imprisonment for not more than six months, a fine of not more than \$500, or both.

<u>Proposed law</u> creates an exception for the possession, planting, cultivation, growing, or harvesting of a prohibited plant strictly for aesthetic, landscaping, or decorative purposes.

<u>Proposed law</u> creates an exception for any dosage form which is legally obtainable from a retail establishment without a prescription and is recognized by the FDA as a homeopathic drug. Defines "homeopathic drug".
